Found: The interview is screened on TV with some weight in the post-Superbowl period.

Description: Abridged Transcript follows.

JS: Think about it. If you can fly and throw trucks, how boring must it be to, to run around a field and throw a ball?

(laugh)

I: And what about Clay Rathen?

JS: Oh, I just knew you were going to put me on the spot about that one, huh.

(Laughter)

JS: Okay, okay, I know, this isn't funny, it's a serious thing. But we're talking about... you know what it is? This is a workplace safety issue. Now, I wasn't happy that the testing made Rathen

sit the superbowl out. That really unfortunate, especially since, apparently, he's not superpowered? I'm not sure about that, I'll have, I'll have to get some people to double check that for me, or talk to him myself.

JS: I like Clay! I've met him a few times, he's one of those guys who'll never back down. So I can understand him being so mad about what was going on. But there are some of these guys who don't even realise they've got these powers. And some of these powers are dangerous - really dangerous. I'm strapping on the pads, I'm doing it for safety. We wear helmets to protect ourselves, and we're doing it because, because this is our workplace!

JS: That field is my job. I go out, I'm working as hard as I can. And I need to be able to think about what I can do, and what I can't do, and how hard that's going to hit and the best path to the end for my guys. I don't want to have to worry about what'll happen if someone tackles... tackles, say, Positron, and cracks his suit. Or or-

I: That's a flawed example, though, isn't it?

JS: Yes, yes, but the thing is, the underlying idea is right. I don't want someone turning up at your workplace with a gun or a knife or drunk or high, right? We have the same thing. It's just because our work is so physically intense, we have to be even more careful with something that could misfire.

I: Interesting, interesting.

JS: Yeah. Clay did get an unfortunate hit here, and I'm really glad that he and the union were able to work something out that works out okay for him. I'm sure he'll be back next year.
