Questions for ATMCC RFP002:

1. **Question for ATMCC:** We cannot provide services to 6 of the 20 sites – Sundance, Hulett, Moorcroft, Kaycee, Lovell and Basin, please confirm that this will not disqualify our response. It will not disqualify your bid. The RFP envisions the group's needs now and into the future as contracts can be evergreen for HCF funding. Vendors may want to note the future timing of additional locations and services or, as written on page 4, "Offerors who are not able to provide both services may team up with other providers in order to submit a complete proposal."
2. Page 9, #1, C – **Question for ATMCC:** Please clarify that you don't require us to manage or provide LAN equipment but rather just the managed router that we may provide as part of our network circuit and CPE bundle. Members internal LAN equipment is not subsidizable by HCF and separate from this RFP (please see attached chart for the scope of charges).
3. Page 10, #2– **Question for ATMCC:** Please describe your requirements for the following bullet "Wireless connection to mobile clinics in rural and non-rural areas". Will you establish a VPN to a wireless mobile unit using cellular service? Our group is not requesting service (see site list) for a mobile unit in this RFP.
4. Page 11- #14. **Question for ATMCC:** Can you please describe this section more fully as to how it impacts our network design or your network requirements to be able to accomplish this need? "ATMCC member groups must also have **video wireless functionality** that includes 128 GB high write endurance solid state storage, 720p video recording with H.264 encoding, 3-10mm variable focal lens, and IR illumination up to 30mm. Access will control who can view live and historic footage, limit access to video exporting and grant viewing access to individual cameras and device tags" Our group is not requesting this service (see site list) in this RFP.
5. Page 12, #23 **Question for ATMCC:** Have all addresses already been provided for optional dark fiber connectivity within the same clinical organization? If not, what are the additional addresses that would benefit from "site A to site B" dark fiber or equivalent services within a particular clinical organization. The sites listed do use additional dark fiber or equivalent managed services to extend their bandwidth's function. Vendor pricing for these services should

6. be in their proposals as they are HCF subsidizable and included on the contracts submitted as part of the HCF application.
7. SLA Agreement –CTL cannot meet 100.00% SLA Understood best commercial efforts.
