## 2025 Jaialdi Vendors Food Concession & Vendor Space Frequently Asked Questions

### **How long will applications be open?**

Applications will be open from March 1, 2024 until May 31, 2024

### **What is the difference between a Food Concession Application and a Vendor Space Application?**

A Food Concession Application is for vendors who are selling ready to eat food. A Vendor Space Application is for those vendors who are selling merchandise/products.

### **Do I need to complete an application if I want to have a vendor space to provide information but will not be selling any products?**

Yes, you will need to complete a Vendor Space Application. These applications will be reviewed and categorized as informational booths. Priority will be given to those vendors who are selling products/merchandise.

### **If I submit my application past the deadline, will I still be considered?**

You will be placed on a wait list. After all applications are reviewed and if there is room, we will then review those vendors on the wait list.

### **When will I be notified of acceptance as an approved vendor for Jailadi 2025?**

Notifications will be sent to vendors beginning July 15, 2024 and complete by July 31, 2024.

### **Will I be notified if I am denied?**

Yes, you will be notified if you are denied.

### **Can I choose to be a food concession or vendor on the Basque Block rather than the Expo?**

No. Majority of the food concession and vendors will be considered at the Expo for the dates of August 2 - 3, 2024.

### **I am applying as a Food Concession Vendor, what hours will I be required to serve food? Can I adjust times based upon what I am selling?**

Vendors will not be able to adjust times.

Our anticipated hours of operation for vendors are:

Saturday: 10:00AM - 6:00PM

Sunday: 10:00AM - 5:00PM

These hours may be subject to change.

## **What is the booth fee for Vendor Space at the Expo?**

The booth fee includes the set up of: tables, chairs, power, and wifi

Small booth (10x10) \$100

Large booth (10x20) \$200

## **Are there any additional fees for Food Concessions?**

Outside food vendors will have a utility fee that includes power, water, and sewer. This utility fee is \$250 for the weekend.

## **What is the standard liability insurance required for a food vendor?**

The minimum amount of general liability insurance policy is defined below

- General Aggregate \$2,000,000
- Personal & Advertising Injury Liability \$1,000,000
- Per Occurrence \$1,000,000

## **What is the commission amount that I will owe?**

20% of all gross sales

## **As a Food Concession Vendor do I also pay a commission amount to Expo?**

No, you will pay a commission to Jaialdi and we will pay the commission to the Expo.

## **Will Jaialdi pay my sales tax to the Idaho State Tax Commission?**

No, each vendor will be required to submit their sales tax to the Idaho State Tax Commission. Click on the [Idaho State Tax Commission - Sales Tax](#) to take you to the website for more information.

## **If I am accepted to participate in Jaialdi 2025 can I decline if plans change?**

Yes, you can decline to participate once you have initially been approved to participate as a vendor. However, once you have signed your contract, you will be required to notify Jaialdi 60 days in advance of the event if you will not be participating.

**If I am accepted as a vendor, may I use the Jaialdi name and/or logo on my products and/or merchandise?**

No, the Jaialdi name and logo cannot be used in any way on your merchandise.
