

Lesher's Student Academic Honesty Policy

Lesher students are expected to be • inquirers • principled • thinkers. Academic honesty connects with the IB learner profile and Lesher's mission statement which links to students' developing competencies in self-management, research, thinking, and communication.

Students are flooded with shared information and shared opinions, making the concept of intellectual property difficult to understand. The key is to guide them in building an understanding of how and when to reference other people's work, giving **explicit** credit to the original source.

The goal of the academic honesty policy is to provide skills and knowledge for students to become lifelong learners acting with integrity in all aspects of life: school, work, and play.

Student's Responsibility	Teacher Responsibility	Parent/Guardian Responsibility
Make your work personal and write using your own "voice."	Communicate expectations you have for students by clearly referring to the academic honesty guidelines for each assignment.	Encourage your student to ask their teachers for advice if they are having difficulties with their work.
Acknowledge help and resources used by correct citations and referrals.	Encourage honesty and communicate the consequences of academic dishonesty. (See Academic Honesty Contract)	Establish a good level of communication with the school so that you understand the expectations students are held to. (See Academic Honesty Contract)
Allow yourself time to do the work properly.	Make the Approaches to Learning (ATL) skills an explicit focus for teaching and learning, particularly citing and referencing sources.	Support your child, but be sure he or she is the one responsible for the work done.
Submit work that is an authentic representation of YOUR skills and abilities.	Provide practice, scaffolds, and frameworks for citing and references formats.	
Familiarize yourself with what constitutes academic misconduct. (See Academic Honesty Contract)		

Academic misconduct includes:

1. Collusion: allowing another student to use your work and present it as their own.
2. Plagiarism: presenting another's work, ideas, or images as your own without an explicit, proper citation.
3. Cheating: copying from another student or using another source to complete a task.

Statement on Generative AI:

IB is a program that values innovation and curiosity, and encourages the exploration of new technologies. We also recognize the growing importance of generative AI tools such as ChatGPT; however, students need to be aware that the IB does not regard any work produced—even only in part—by such tools to be their own. Therefore, as with any quote or material from another source, it must be clear that any AI-generated text, image or graph included in a piece of work has been copied from such software. The inclusion of a reference at the end of the paper is not enough; the citation must be included at the point of use and linked to a full reference in the bibliography. If this is not done, the student would be misrepresenting content—as it was not originally written by them—which is a form of academic misconduct.

On writing assessments, the use of AI tools is **not** permitted. The IB allows students to use basic tools to support their spelling and grammar when this is not what is being assessed.

Academic Honesty Contract
