- There are five periods in the AM session and five in the PM session. Each period is 47 minutes long.
- Each class has an established contract, which includes direct instruction and independent work. If your teacher agrees, you may receive homework.
- Students demonstrate mastery of content through assessments, which includes 60 hours of actual work and testing per credit.

#### STUDENT EXPECTATIONS

#### I will:

Respect all people and follow all Palomar school rules and dress guidelines.

- Attend school regularly, arrive on time and remain on campus until the end of my school day.
- Leave campus when my school day is completed.
- Not trespass on any other school campus during school time.
- Always keep the peace with all students.
- Use my cell phone only during breaks and when my teachers permit.
- Always use appropriate language that doesn't offend anyone.
- Not gossip or instigate problems with others.
- Listen and comply with school authorities when asked.
- Always do my own work and not copy or plagiarize assignments.
- Protect all school personal and private property.
- Respect all students and adults on campus.
- Keep drug and alcohol free.

#### 13TH GRADERS EXPECTATIONS

- All 13<sup>th</sup> graders or 18+ year-old students will be placed on a contract.
- An attendance average of 90% is required.
- To remain at Palomar, you may not have any behavior issues or suspensions.
- We absolutely expect you to support yourself through excellent behavior, attendance, and attitude as you work your way towards graduation.

#### POLICIES, PROCEDURES, AND EXPECTATIONS

(in alphabetical order)

#### ACADEMIC HONESTY POLICY

The following are NOT acceptable behaviors and actions at Palomar High School and are in direct violation of the Academic Honesty Policy of any school, district, state and national tests.

- **Cheating:** Any intentional giving/discussing/using of external assistance relating to an examination, test or quiz, without the expressed permission of the teacher.
- **Fabrication:** Any intentional falsification or invention of date, citation or other authority in an academic exercise.
- **Forgery**: Any simulated signing of another person's name to any such writing whether or not it is also the forger's name; falsely making or altering a writing by which the legal rights or obligations of another person are apparently affected.
- Plagiarism: Any intentional use of another's ideas, words, or work as one's own.
   Plagiarism includes the misuse of published/copyrighted material whether written or visual, and/or the work of other students.
- Theft or alteration of materials: Any intentional or unauthorized taking, concealment or alteration of student, teacher, office or library materials.
- Pattern of test avoidance: A pattern of absences on test days or major report due
  dates for the apparent advantage of performing better on the make-up test or for
  gaining extra work/study time.
- Abusive conduct with computers, local area networks and Internet: Such conduct includes, but is not limited to, damage or theft of system hardware or software; altering of any system software or software configurations; placing unlawful information, computer viruses, or harmful programs on any computer; pirating (copying/stealing, copyrighted software).
- **Unauthorized electronic entry:** Any entry to a computer or computer systems without permission.
- Any access, downloading and/or printing of materials, which would be considered inappropriate, pornographic, unlawful, obscene or otherwise offensive or objectionable by any school community member.

All students will have due process in the handling of the above infractions. Penalties for infractions include but are not limited to: parent notification, lowering of academic and/or citizenship grade, Saturday School, and/or suspension.

#### ATTENDANCE POLICY

State law requires you to attend your assigned classes every day school is in session.

We expect you to be here 100 percent of the time. 90% attendance is the minimum acceptable at Palomar for all 13<sup>th</sup> graders and also to be eligible for any and all privileges such as: Grad Nite, field trips, schedule changes, extended day schedules, and special classes. If attendance falls below 80% students may be transferred back to their home school or to an alternative site.

Acceptable attendance requires that you accumulate no more than three (3) full-day excused absences during a 6-week grading period. If you have excessive absences, you will be referred to the Assistant Principal for a parent conference and risk being dropped from Palomar High School.

#### Verified Absence:

- Medical and dental appointments (student and/or their children)
- Illness
- Quarantine
- Bereavement
- Participation in religious services
- Court ordered appearance
- Naturalization ceremony
- Spending time with immediate family member who is an active military on leave from deployment in a combat zone

**Unexcused (Non-Truant) Absence and Truancy:** Any absence not defined as verified including a verified truancy must be made up at Saturday School or by attending 3 days of tutoring class. Falling below 90% in actual attendance will result in a loss of privileges.

#### ABSENCE PROCEDURES

Parents/guardians are required to call the attendance office at (619) 407-4802 to report an absence.

The Sweetwater Union High School District has two new attendance regulations:

- 1. It is the **parent's responsibility** to notify the school within 10 days to clear the pupil's absence. Absences not verified 10 days after the student returns to school will become
- 2. truant for the remainder of the school year unless the student attends Saturday School and/or tutoring to clear the absence.
- 3. The Sweetwater Union High School District has established that it is reasonable to be absent 1 day a month (equivalent to 5 days in a semester or 10 days in a school year). Students who have more than 5 days of unverified absences per semester or 10 excused absences during the year may be placed under an "Excessive Absence Contract."



If a parent/guardian does not call the attendance office, a Blue Slip or signed note upon the return to school must be turned in. After 48 hours the absence may remain unexcused. **Parents should check student attendance on a weekly basis.** 

#### TARDY PROCEDURES

Learning the responsibility of punctuality is important. Disruptions caused by tardiness distract teachers and students and affect the educational process.

**A.M.** Session students who are habitually tardy may be assigned to the P.M. session. Students who are habitually tardy will be referred to the Assistant Principal and a parent conference will be required.

<u>California Education Code Section 48260</u> provides more detail on compulsory school attendance. A student under 18 who is absent 3 or more times in a school year without an excuse is considered a habitual truant.

Palomar High School is a **closed campus**. Students may not leave campus **without an Off-Campus Permit**. Students who do so will be considered truant. Off-Campus Permits must be obtained prior to leaving school.

Students who are habitually truant and are referred to the district Student Attendance Review Board (SARB).

#### **CELL PHONE POLICY**

Students may bring and use electronic and mobile communication devices while on campus. Using such devices **must not** disrupt the educational program or school activities at any time. They **must not** be used for illegal or unethical activities, such as filming or recording others without their consent, or cheating on assignments/tests.

#### Permitted devices shall:

- Be turned off during class time and at any other time directed by a district employee.
- Not disrupt the educational program or school activity. If a disruption occurs, the employee can direct the student to turn off the device and/or confiscate it.

#### **Confiscated Devices Procedure:**

- A. **First time:** Students can pick up their device from the administration office after school.
- B. **Second time**: Parents must pick up student devices from the administration office after school.
- C. **Third time:** Parents can pick up student devices and a consequence will be assigned.
- D. A student who violates this policy may be prohibited from possessing a mobile communication device at school or school related events and/or may be subject to further discipline. (California Education Code 48901.5).

Photography, recording and/or videotaping of any person without his/her knowledge, permission or consent is illegal.

Palomar High School is not responsible for loss or theft of electronic devices brought to school and not responsible for investigating or reimbursing students for lost or stolen electronic devices.

#### **DRESS GUIDELINES**

#### Palomar High School Student Dress Guidelines

Palomar High School expects that all students will dress in a way that allows for active participation in class activities or school sponsored events. Student dress choices should respect the District's intent to sustain a community that is inclusive of a diverse range of identities. The primary responsibility for a student's attire resides with the student and their parent(s) or guardian(s). The school district is responsible for seeing that student attire does not interfere with the health or safety of any student, that student attire does not contribute to a hostile or intimidating atmosphere for any student, and that dress guideline enforcement does not reinforce or increase marginalization or oppression of any group based on race, sex, gender identity, gender expression, sexual orientation, ethnicity, religion, cultural observance, household income, or body type/size. Any restrictions to the way a student dresses must be necessary to support the overall educational goals of the school and must be explained with these dress guidelines.

- 1. Basic Principle: Certain body parts must be covered for all students at all times. Clothes must be worn in a way such that genitals, buttocks, breasts and nipples are fully covered with opaque fabric. However, cleavage does not have coverage requirements. All items listed in the "must wear" and "may wear" categories below must meet this basic principle.
- 2. Students Must Wear, while following the basic principle of Section 1 above:
  - a. A **shirt** (with fabric in the front, back and on the sides under the arms). **AND**
  - Pants/jeans or equivalent (for example a skirt, sweatpants, leggings, a dress or shorts). AND
  - c. Shoes.
- 3. Students May Wear, as long as these items do not violate Section 1 above:
  - a. Hats hats must allow the face to be visible to staff, and not interfere with the line of sight of any student or staff.
  - b. Religious headwear
  - c. Hoodie sweatshirts (wearing the hood overhead is allowed, but the face and ears must be visible to school staff).
  - d. Fitted pants, including opaque leggings, yoga pants and "skinny jeans"

- e. Pajamas (as long as this is done in a way that does not violate Section 1 above)
- f. Ripped jeans, as long as underwear and buttocks are not exposed
- g. Tank tops, including spaghetti straps, halter tops
- h. Athletic attire
- i. Visible waistbands on undergarments or visible straps on undergarments worn under other clothing (as long as this is done in a way that does not violate Section 1 above).

#### 4. Students Cannot Wear:

- a. Violent language or images
- b. Images or language depicting/suggesting drugs, alcohol, vaping or paraphernalia (or any illegal item or activity).
- c. Bullet proof vest, body armor, tactical gear, or facsimile.
- d. Images or language depicting/suggesting hate speech, profanity, and/or pornography.
- e. Images or language that creates a hostile or intimidating environment based on any protected class or consistently marginalized groups.
- f. Any clothing that reveals visible undergarments (visible waistbands and visible straps are allowed).
- g. Swimsuits
- h. Accessories that could be considered dangerous or could be used as a weapon.
- i. Any item that obscures the face or ears (except as a religious observance or as Personal Protective Equipment (PPE)).

#### 5. Dress Guidelines Enforcement

To ensure effective and equitable enforcement of these dress guidelines school staff shall enforce the dress guidelines consistently using the requirements below. School administration and staff shall not have discretion to vary the requirements in ways that lead to discriminatory enforcement.

- a. Students will only be removed from spaces, hallways, or classrooms as a result of a dress guideline violation <u>as outlined in Section 1 and 4 above</u>. Students in violation of Section 1 and 4 will be provided these options:
  - Students will be asked to put on their own alternative clothing, if already available at school, to be dressed more to code for the reminder of the day.
  - ii. Students will be provided school loaners, which will be returned at the end of the school day.

- iii. Students will experience the logical consequences of their clothing choices. For example, inappropriate footwear may lead to losing the day's hour in PE.
- iv. If necessary, students' parents may be called during the school day to bring alternative clothing for the student to wear for the remainder of the day.
- b. No student should be affected by dress guideline enforcement because of racial identity, sex assigned at birth, gender identity or expression, sexual orientation, ethnicity, cultural or religious identity, household income, body size/type or body maturity.
- c. School staff shall not enforce the school's dress guidelines more strictly against transgender and gender nonconforming students than other students.
- d. Students should not be shamed or required to display their body in front of others (students, parents, or staff) in school. "Shaming" includes, but not limited to:
  - i. Kneeling or bending over to check attire fit;
  - ii. Measuring straps or skirt length;
  - iii. Asking students to account for their attire in the classroom or in hallways in front of others;
  - iv. Calling out student in spaces, in hallways, or in classrooms about perceived dress guideline violations in from of others; in particular, directing students to correct sagged pants that do not expose the entire undergarment, or confronting students about visible bra straps, since visible waistband and straps on undergarments are permitted; and
  - v. Accusing students of "distracting" other students with their clothing.

These dress guidelines shall apply to regular school days and summer school days, as well as any school-related events and activities, such as graduation ceremonies and Grad Nite, with the exception of events that require assignment-specific attire, i.e. professional, public speaking, and job readiness field trips.

#### FIELD TRIPS

- All Palomar rules apply on field trips.
- You are an ambassador for your school.
- Good attendance is expected.
- It is expected that you are earning credits.

 The expectation is that you behave always in an appropriate manner both at school and away from school.

#### HALL PASSES

Hall passes will be given by your teacher only. There <u>are no passes during the first 10 minutes and the last 10 minutes of class.</u> If you are having an emergency, your teacher can issue you a pass to the nurse, where you will be required to sign in to verify your emergency. Use restrooms during *appropriate* breaks.

#### LUNCH

**LUNCH APPLICATIONS**: All students will receive free lunch during the 2023-24 school year due to the USDA extending this opportunity to students. A lunch application does not need to be completed at this time, you will receive more information later in the year regarding a form taking place of the lunch application all families will complete to secure funding for our school.

**BRINGING LUNCH:** Students can bring lunch from home but are **not allowed** to have food delivered to school. Food deliveries to the school will be denied. For the safety of our students and staff, Palomar High School is a <u>closed</u> campus. Students cannot leave campus to get and/or purchase food for lunch and then return.

#### **NURSE'S OFFICE**



**HEALTH OFFICE PASS**: All students must have a goldenrod hall pass in their possession to be seen in the health office during class time. A pass to the nurse is not needed during break or lunch.

**EYE EXAM:** Students who have difficulty with their vision can be evaluated and a referral made by the nurse, if needed.

**ILLNESS:** Due to COVID, you should <u>not</u> come to school if you feel ill. If you become or feel ill while at school, you must see the nurse to be evaluated. The nurse will call your parent/guardian. Do not call your parent/guardian to pick you up prior to seeing the nurse or your absence will be unexcused.

**INJURY**: If an injury occurs at school, report it to any staff member immediately and go to the health office for an evaluation.

**PHYSICAL EDUCATION (P.E.) EXCUSES:** These are obtained from the nurse <u>prior</u> to the start of your PE class and are not to be obtained during any class period. Bring a note from your parent/guardian, or a formal medical excuse before school or during break.

**MEDICATION**: Medication is not allowed on campus unless prescribed by a doctor from the United States (instructions or prescriptions from doctor's outside of the United States are not acceptable).

Medication that is needed must have the Physician's Recommendation for Medication form signed by the doctor who prescribed it. You may obtain this necessary form from the nurse.

When medication is brought to school, it must be kept locked in the health office. Keeping any medication, including any over-the-counter products (drugs) in the student's possession while at school is grounds for disciplinary actions, unless otherwise indicated by a physician.

**IMMUNIZATIONS (VACCINATIONS)** are required by California State Law. All students must show proof of adequate vaccinations in order to be and remain enrolled in school. This includes the T-dap (whooping cough) vaccine.

**COVID PRECAUTION REMINDERS:** Wash your hands or use hand sanitizer frequently throughout the day, but especially after visiting the restroom and before you eat. Finally, <u>if you</u> feel sick, stay home and notify the school.

**OVERALL GOOD HEALTH:** Eat breakfast prior to starting your school day. Eating healthy foods provides fuel to your body, allowing you to concentrate and focus on your studies so you can do well!

#### **ORIENTATION CLASS**

The two-week Orientation Class is a chance for you to get to know how Palomar works and how you earn credits. If you have questions, ask your counselor or your Orientation Class teachers. They are here to help. When you succeed, they succeed!

#### After completing Orientation Class, you should know:

- How many credits you need to graduate.
- Your counselor and how they can help you succeed.
- The consequences of missing school.
- That you can be successful at Palomar and beyond.

#### PARENT INVOLVEMENT POLICY

As parents and/or caregivers are partners in the education of their high school students, it shall be the policy at Palomar High School to:

 Invite all parents to attend an annual meeting at which the School Plan for Student Achievement (SPSA) including the Title I, SCE and LEP components and their requirements are discussed.

- Allow contribution of suggestions and revisions of programs by parents and to respond to parents contributions through the allocation of time at all meetings involving parents.
- Provide time for the School Site Council (SSC) and parent committees to review, modify, and approve the School Plan and all categorical budgets

#### Provide parents with timely information about:

- Student progress, attendance and behavior
- School test results
- Types of assessments
- School curriculum
- Intervention programs
- Student graduation requirements

#### PROHIBITED ITEMS

<u>California Education Code 48900</u> and <u>SUHSD Board Policies</u> prohibits the following items on campus:

- Explosives of any kind, including stink bombs, fireworks, and shells
- Alcohol, energy drinks, controlled drugs, tobacco products and drug paraphernalia including but not limited to, rolling papers, lighters, eyedrops, vaping products, and/or devices.
- Dangerous objects, and/or weapons firearms, knives, pepper spray, stun guns, etc.
- Obscene, pornographic or misogynistic materials
- Graffiti-marking pens, spray paint, and drill bits
- Laser beam pointers

#### SAFE AND SECURE CAMPUS

**Palomar High School** always supports a safe and secure campus. School rules are consistently enforced. You are expected to know the school rules and to be respectful to all. *Report any concerns to the Assistant Principal*. Nondiscrimination Policy 0410 and 5145.3

Breaks and lunchtime are an opportunity for you to treat each other with respect and dignity.

- Be respectful
- Clean up after yourself, keep the campus clean
- Return to class **IMMEDIATELY** when the bell rings

**Harassment** hurts everyone involved including the harasser. **EVERYONE** has the right to feel and be safe at school. Palomar High School and the Sweetwater Union High School District **will not** tolerate any harassment of students.

**Harassment can be VERBAL or PHYSICAL**. This is behavior that makes someone else feel uncomfortable or unsafe, whether or not it is unintentional.

Actions or behaviors that might constitute HARASSMENT include but are not limited to:

- **SEXUAL** touching others and/or yourself on intimate parts of the body, including kissing, pats on the behind, fondling, etc.
- **PHYSICAL** invading personal space or obstructing one's movement.
- VERBAL whistling, cat calls, descriptions and/or comments about body parts, unwelcome jokes, suggestive tone of voice, propositions, name calling, racial slurs, smacking lips, inappropriate comments.
- VISUAL offensive pictures or drawings, put downs, negative comments towards a
  person's sexual orientation, hand gestures to suggest harm, tongue movements, lewd
  wings, ogling, gestures that simulate sexual behavior etc.

#### REUNIFICATION LETTER

The Reunification Letter on the following page is updated and sent home at the start of each school year. It contains important information about what to expect in the event of a major emergency where all students need to be picked up at the same time. As always, student safety is our paramount concern and in such an event, patience and cooperation will be needed.

#### Dear Parents/Guardians:

In case of a school emergency or a natural disaster, such as an earthquake, you need to be aware of our school's plan for releasing your child. First and foremost, remain calm. Remember, it is our primary concern that students remain safe at all times, and that there is an orderly dismissal and release of our students. We will issue notification for student release via School Messenger phone calls. If all parents/guardians arrive at our school at approximately the same time to pick up students, everyone's understanding, cooperation and patience will be essential to our plan.

Walking to school to pick up your child would be best. Parking will be very limited. If you must drive, be prepared to park at least three blocks from the school. Do not plan to park in school parking areas as it may interfere with getting emergency fire, medical and/or police vehicles into school. Proceed immediately to our Student Request Area at the entrance of the parking lot.

For the safety of every child, we must document to whom each child is released. When you arrive at school, proceed to the Student Request Area, and plan to do the following:

- 1. Sign Emergency Information Card
- 2. Sign Student Release Log
- 3. Be prepared to present a picture identification card upon request.
- 4. A runner will go to the Assembly Area, get your child, and bring him/her to the Release area.
- 5. After completing the paperwork, wait for your child to arrive and leave immediately.
- 6. In the event students are not picked up, staff will keep students housed in a designated area.

It will take some time for the orderly dismissal of all our students, so please be patient and be prepared to wait. The less confusion, the quicker students will be reunited with parents/guardians.

REMINDER: Your child will be released only to those listed on the Emergency Card. It is therefore imperative that you keep information on your child's Emergency Card up to date. Know also that for any reason your child is not picked up, he/she will be placed in an alternate place of safety.

These procedures should be shared with everyone you list on the Emergency Card so they are familiar with our plan and these concerns.

Por la misma seguridad de sus hijos debemos llevar un registro de cada estudiante que le es entregado a sus padres o tutor. Cuando usted llegue a la escuela, diríjase al área designada para Solicitar a los Estudiantes, y prepárese para proceder de la siguiente manera:

- 1. Firme el documento que contiene la información de emergencia.
- 2. Firme la bitácora de Entrega del Estudiante
- 3. Esté preparado para mostrar una identificación con fotografía en el momento que se lo pidan.
- 4. Una persona irá al área donde se llevan a cabo las asambleas para traer a su hijo (a) al área de entrega.
- 5. Después de terminar el papeleo, espere la llegada de su hijo para después proceder a abandonar el plantel inmediatamente.

Entregar a todos los estudiantes tomará algo de tiempo, por eso les pedimos que sean pacientes y que estén preparados para esperar. Mientras menor sea el grado de confusión, más pronto podremos reunir a los estudiantes con sus padres o tutor.

RECORDATORIO: Únicamente podemos entregar a los estudiantes a la persona (s) que aparece en el documento de emergencias del estudiante, por esta razón es muy importante que esta información se mantenga actualizada. Si por la razón que fuere a su hijo no se le recoge, se le va a llevar a un lugar alternativo de seguridad.

Estos procedimientos deben compartirse con todas las personas que aparecen en la lista del documento de emergencias del estudiante para que estén familiarizados con nuestro plan y con los factores que deben tomarse en cuenta.

## **Reporting Sexual Harassment**

# What is sexual harassment?

Prohibited types of conduct which may constitute sexual harassment include, but are not limited to:

- Unwelcome sexual flirtations or propositions.
- Sexual slurs, leering, epithets, threats, verbal abuse, derogatory comments, or sexually degrading descriptions.
- Graphic verbal comments about an individual's body, or overly personal conversation.
- Sexual jokes, notes, stories, drawings, pictures, or gestures.
- Spreading sexual rumors.
- Teasing or sexual remarks about students enrolled in a predominantly single gender class.
- Touching an individual's body or clothes in a sexual way.
- Purposefully cornering or blocking normal movements.
- Limiting a student's access to educational programs or resources. •

Displaying sexually suggestive objects, drawings or photographs. • Profanity, inappropriate offensive & profane language (without intent to harm).

- Sexual assault, sexual battery, or sexual coercion.
- Electronic communications containing comments, words, or images described above.

# How do I report an incident?

Report the incident to a teacher, counselor, assistant principal, principal, or other school staff member.

The District has a responsibility to promptly investigate complaints in accordance with the law and District Administrative Regulations (AR) 5145.7 and 5145.71. Within one school day of receiving such a report, the school employee shall forward the report to the principal or the district's compliance officer. The student who is complaining shall have an opportunity to describe the incident, present witnesses and other evidence of the harassment, and put the complaint in writing. The principal or designee will tell the student who complained that he/she has the right to file a formal complaint at any time in accordance with the District's uniform complaint procedures (UCP) in AR 1312.3 or with local law enforcement. Both the student who is complaining and the individual against whom the complaint is made will have the right to appeal the District's decision. The District prohibits discrimination, intimidation, harassment (including sexual harassment) or bullying based on a person's actual or perceived age, ancestry, color, disability, gender, gender identity, gender expression, immigration status, nationality, race or ethnicity, religion, sex, sexual orientation, or association with a person or a group with one or more of these actual or perceived characteristics. # ¿Qué es el acoso sexual?

Los tipos de conducta prohibida que pueden constituir acoso sexual incluyen, sin limitarse a:

- Coqueteos o proposiciones sexuales no deseadas.
- Calumnias de tipo sexual, miradas lascivas, epítetos, amenazas, abuso verbal, comentarios despectivos, o descripciones sexualmente degradantes.
- Comentarios verbales gráficos sobre el cuerpo de una persona o conversaciones demasiado personales.
- Chistes, notas, historias, dibujos, imágenes, o gestos sexuales.
- Difundir rumores de tipo sexual.
- Burlas o comentarios sexuales sobre alumnos matriculados en un grupo predominantemente de un solo género.
- Tocar el cuerpo o la ropa de una persona de manera sexual.
- Acorralar o bloquear deliberadamente los movimientos normales.
- Limitar el acceso del alumno a programas o recursos educativos.
- Mostrar objetos, dibujos, o fotografías de índole sexual que sean sugestivos.
   Blasfemias, lenguaje inapropiado ofensivo y profano (sin intención de dañar).
   Agresión sexual, agresión física de tipo sexual o coerción sexual.
- •Comunicaciones electrónicas que contengan comentarios, palabras, o imágenes descritas en los puntos anteriores.

Tanto el alumno que presenta la queja como la persona contra quien se presenta la queja tendrán derecho a apelar la decisión del Distrito.
