#### **Matters arising**

#### **Spring concert and start time**

Rehearsals are underway for the Spring concert and are going well. Ed is very pleased with the progress so far.

The start time has been bought forward to 7.00pm. The website still has the later time of 7.30pm and this needs amending. More effort needs to be put into making sure all information about future concerts is correct in all formats.

There was a discussion as to whether the staging was necessary with a smaller choir and it was decided to do without it this time as we are trying to restrict spending in consideration of the reduced state of the choir's finances.

We are still without anyone to take responsibility for running a bar and in the present climate it was decided to limit the interval as in the Christmas concert to 10 minutes. There will hopefully be a raffle, which is a good fundraiser.

#### Future concerts and July set up change.

- ED is planning that the Summer concert in July should be based around American music. He is suggesting three medleys based around 'Showboat', 'West side story' and Sondheim musicals. It was suggested that we might do a medley based around Rodgers and Hammerstein as well. He was asked to finalise his ideas and let Keith and Sylvia know as soon as possible so that some advance planning can go on as far as budgeting etc and ordering of music.
- It was suggested that we do the Faure requiem in November and include parts of the Messiah in the Christmas concert
- The event at Frimhurst on 25<sup>th</sup> June is to go ahead and we are well into learning the piece 'Dig Deep'

## Treasurer's report.

Keith had produced a budget for 21/22 which was used as a basis for further discussion

Money is becoming a problem with much fewer members and less income from concerts. We have also lost the Siemens' contract as they are moving out of the Frimley premises soon. There was a discussion of how to minimise our outgoings and it was suggested that we go back to only producing 3 concerts a year instead of 4 and there was a suggestion that instead of a concert in November we join with a local church and produce an event as we have done before at Remembrance. It was decided to cancel our booking for a concert at High Cross in November and investigate the possibility of a joint effort with St Peter's church. Other suggestions

were: - more open evenings to encourage new members, raising the fees substantially in September, perhaps to £150/ year, limiting using of staging at concerts, cutting down on expenditure wherever possible. Our outreach work was also discussed as this often has outgoing costs that have not been recovered. We shall have to charge for this work in future. The event at Frimhurst is being paid for by the organisers who are attracting funding for the event.
