This Make-up Artist Contract (the "Agreement"), executed on _____, is entered into by and between: Niamh Anderson (hereinafter known as "Artist"); and _____

WHEREAS, Client desires to hire Artist for performing make-up services for client; WHEREAS, Artist accepts to engage to perform make-up services (the "Service") to Client for the amount of _____;

NOW, WHEREFORE, FOR and in consideration of the foregoing premises, the Parties hereby agree as follows: Time and Place The Service shall be conducted beginning _____ and shall end at _____ (the "Event") at the following address _____

Terms of Payment:

Client shall pay _____ of the total contract amount and shall pay the remaining balance after completion of the Service.

Cancellation:

In case Client cancels this Agreement 1 week prior to the scheduled event, all deposits made by Client to Artist shall be non-refundable. In case Client cancels this Agreement with more than 1 week from the scheduled event, a cancellation fee of _____ pounds shall be collected by Artist.

Consultation:

A trial makeup ("Consultation") may be availed of by Client at the latter's option. Consultation fee shall be separate and not included in the contract amount. This is a separate fee for the amount of _____ per person. Consultation may be availed of anytime, but not later than 3 days prior to the day of Event.

Image Use:

Client allows that images captured by Artist and/or the latter's representative of Client may be used by the latter for use on websites, brochures, or for any purpose of advertising the works of said Artist.

Client does not allow that images captured by Artist and/or the latter's representative of Client may be used by the latter for use on websites, brochures, or for any purpose of advertising the works of said Artist

Confidentiality:

The terms and conditions contained in this Agreement constitutes confidential information. The Parties agree to keep confidential such information against any third-party unless written consent has been given by the other. In any event that a Party is legally compelled to disclose the confidential information of the other, such Party shall promptly notify the other in order for the latter to be able to afford protection or waive compliance with the provisions hereof. This provision shall survive the termination of this Contract for whatever reason.

Client Responsibilities:

Provide an accurate and detailed brief regarding the requirements of the Artist, including desired effects, makeup and hair.

Ensure there is appropriate facilities available including seating arrangements, special equipment needed (This will be discussed beforehand)

Communicate any alterations within good time regarding the Makeup Artist

Artists Responsibilities:

Provide professional Makeup and Hair service following industry standards.

Use appropriate sanitised makeup and Hair tools and products to ensure safety of client

Maintain an organised workspace throughout the given time, disposing of tools responsibly.

Leaving the workspace how it was upon arrival.

Liability:

The Makeup Artist shall not be held responsible for any allergic reactions from makeup equipment and products used on the day or any trial runs. Clients must inform Makeup Artist of known allergies or sensitivities before service.

Governing Law:

This agreement shall be governed by and constructed under the laws of Jurisdiction.

Both parties acknowledge that they have read and understood the terms of this agreement and agree to be bound by them.
