## BUDGET CONVERSATION

• Action/Discussion: A question is before us on what we should do with the remainder from the Search Team Funds--an amount of \$4,000. The Treasurer is recommending we use the \$4,000 for repairs and spruce-up the new Lead Minister/Head of Staff office. The bathroom flooring in there needs to be replaced, and it would be nice to paint before she arrives. Also, there is a need for different seating and furniture as it's pretty dated and uncomfortable. It is easiest and most efficient to get these items completed before the new Lead Minister arrives. The Executive Committee members have expressed support and interest in this plan.

**MOTION:** I move the church use the excess \$4000 from the settled search process to be repurposed and used to repair and refresh the Lead Minister's office and office furniture.

- Aime the Settled Search team was left with about \$4,000 from their \$10,000 budget; no time to

  process.

  - o do some freshening up of the Lead Minister's Office
    - it needs new paint, flooring, seating, desk make it as welcoming as possible for Beth (with her input).
- Hunt has optimism that we can raise funds for sabbatical later, let's jump at this opportunity

  - how do we look at Strategic Plan given these comments? You have given us a guide to the future, thank you for being honest with us
- KB you need people of other social, racial strata the church cannot grow without deep relationship with other
- Densmore highlighted perfectionism section, how egos get in the way of spiritual growth
- Hunt sparks thinking about why can't we get more people involved in leadership positions is perfectionism setting up roadblocks?
