FREQUENTLY ASKED QUESTIONS (FAQs)

- What is the aim of Potion Owl? To make healthcare services easily accessible irrespective of time and location.
- Is Potion Owl an EHR? No, Potion Owl is **not** an EHR platform. We state this in our <u>whitepaper</u> on page 3 under section 1.2. Rather EHR is a part of our ecosystem and is utilized by healthcare providers.
- 3. What will PTN tokens be used for? PTN tokens will be used throughout the ecosystem to power smart contracts with incentivization built in. Additionally, a holder of 50,000 PTNs will have the opportunity to operate a med rep account which provides incentivization in the form of passive earnings through transaction fees (10-25%) see here for more details.
- 4. When will Med Rep accounts be first made available? During the presale. At the close of presale you will have the opportunity to opt-in or waiver your med rep account(s).
- 5. Is there a limit to the number of med rep accounts that I can own? No, there is not. You can run as many med rep accounts as you would like given that you have the required amount of PTNs. For eg: If you have 100,000 PTNs during the presale that you will automatically be allocated **two (2)** med rep accounts at the close of presale. (You may opt-in or waiver these accounts)
- 6. Where can I purchase PTN tokens? You can purchase these tokens directly from Potion Owl's website at: https://www.potionowl.com (Please use the sign-up in the footer as the header is for healthcare providers who are already utilizing the system. Note that we have been in operations since 2015 as a centralized entity).
- 7. Why would hospitals that have invested millions of US\$ in EHR discard of their systems to implement blockchain? Following on from question 3. An EHR platform is doctor facing and implemented in hospitals that can *afford* to do so. Personally, we think this is one of major reasons for the slow adoption of an healthcare platform with huge popularity globally. We are aiming to fill that space. Potion Owl will be for healthcare providers who operate private practices, health clinics, medical centres, labs, pharmacies etc. North America and Europe are just a fraction of the globe. The Caribbean, Central America and South America along

with majority of the world do not have the luxury to spend millions of dollars on medical systems per location not to mention the laws are significantly more relaxed or non-existent. Potion Owl will be implemented by taking the path of least resistance in order to gain critical mass quickly. Question 4 is a sequel to this answer.

- 8. Why the Caribbean as a starting point? It's an untapped market and approximately 30 million tourists travel here each year; which is higher than the global average (26+ million by cruise ships) to explore the countries and mingle with the 42 million plus natives. Healthcare Services are isolated between developed and developing countries and we want to bridge this gap. For eg: If a visitor became ill in Jamaica they should have the ability to visit a doctor there and should symptoms persist, they should be able to relay that information with another doctor in another country. By connecting all islands we are providing tourists with ease of access, medical attention and reassurance that they'll be covered by their insurance policy holders should the need arise. The Caribbean is the first stop over a 6 month period with Central and South America dates to be announced after the token sale.
- 9. When will tokens be distributed to wallets? All tokens will be distributed two (2) weeks after the crowdsale.
- 10. How will I be able purchase PTN Tokens during the Presale? You will be able to purchase PTN Tokens using Nebl, Ether, Bitcoin, Bitcoin Cash, Doge, Litecoin, Nano and FIAT(conditions apply)
- 11. What is the cost of a PTN token? During special Neblio presale US\$0.043, presale 0.07 and during crowdsale US\$0.10.
- 12. What is the minimum purchase necessary to acquire PTNs? 3.67 Nebl (pegged at US\$15 per Nebl)
- 13. What are the Exchanges that Potion Owl intends to list on? Originally we had a list of exchanges here but have been advised to not openly discuss.
- 14. Are there any paid marketing plans in place? Yes, this will be initiated during the main sale.

- 15. Are there any plans for partnerships? We are in discussions regarding this at the moment. We have agreed in principle with four (4) companies; three (3) of which are multi-billion dollar companies with Caribbean and Central American wide reach. Announcement will be made after the token sale.
- 16. What is the total supply of PTNs? 50 million Potion Owl Tokens (PTN)
- 17. Is there a bounty? Yes, there is a Bounty Campaign. To sign up, click here.
- 18. Is there a bonus during presale? Technically there is a bonus in the form of pricing Nebl higher than its cmc rate which at the time was \$10.00. We are accepting at the rate of \$15.00
