Committee Updates

The ponds will open for trout fishing to all Members on Wednesday April 22nd with the normal daily trout limit of 5 fish.

Range Committee – The **New Pistol Range will remain closed until all alterations are complete.** The embankment will be raised in the Near future. Everyone will be notified via email when this work is completed. New changes to the Range Rules were adopted as follows.

1. Only pistols of 45 caliber or less may be used

2. Only pistol ammunition may be used.
3. Only paper targets are to be used.
4. A frame for shotgun patterning will be located at the pistol range.
5. No hunting will be permitted behind both the pistol and rifle ranges
6. A copy of the Range Rules will be emailed to all members.

Grounds – We will spray to kill all the cold weather grasses prior to seeding warm season grasses as required by our annual CREP Report. Spraying will begin in April and may require a separate spraying if necessary. Planting and seeding is expected in June. Sarah Harnish will order the seed and spray for the project. We will also discuss our CREP Plans with our farm partner, Eugene Hoover to get his input. He is a vital part of our CREP Program and other programs which we conduct at the Club. Members Dick Deibert, Joe Szewczak, and Jarrod Specht will speak with Mr. Hoover.
