




Draculaura is known for her unique and expressive style, which has been unfairly appropriated by Grant. This image, like others he has taken, represents hours of dedicated effort and creativity, and its misappropriation not only violates intellectual property rights but also undermines the integrity and hard work of the original artist.


The character is Suzu the bear, belonging to CandyKuma.



















This situation further escalates as it has been discovered that various screenshots were stolen by Grant including those belonging to CandyKuma and other sonic artists on the Bluesky platform. These artworks were then gathered on Discord by Grant, demonstrating a clear pattern of stealing characters without the artists' permissions.



Additionally, it has come to light that Grant created three alternate accounts on Discord to harass or insult himself on the platform. This self-sabotaging behavior further highlights the extent of his disruptive actions and raises serious concerns about his motivations and mental state. He literally goes in and trolls himself until the accounts got banned.


The admin told me back then, that the alt accounts were all connected to the same IP address, which is why he could tell they were Grants alts



Here is further evidence showcasing that he uses these alt accounts on discord to interact with himself.









Moreover, Grant has been seen actively encouraging others to harass a fellow Sonic fan named A0zora. He has been telling people to block and report her account with false accusations, escalating his harmful behavior.



Grant's actions have taken another disturbing turn involving hate art. This involves CandyKuma's character, Suzu the bear. Grant claims that the drawing was edited by someone who hates him, trying to distance himself from the misconduct. However, the truth is more insidious as the image was actually the profile picture of his a0zora alt account, where he openly stated that he made it. This contradiction reveals Grant's attempts to manipulate the narrative and evade responsibility for creating and sharing harmful content. It is imperative that the community addresses these actions to protect the rights and well-being of all artists involved.







Most of what he said was just "where do you know this from" and Mr. Deflecting and making things up. His responses only served to further illustrate his unwillingness to take responsibility for his actions, and his attempts to obscure the truth with fabrications were evident.


In one instance, when confronted about his knowledge of CandyKuma, Grant claimed that he knew her from a roleplay. However, if what she said is true, then Grant appears to be delusional, further complicating the issue.


When CandyKuma confronted the art thief, he began to argue with her, refusing to remove her character from his profile picture, claiming it as punishment for something she had no involvement in. Grant's defiance and unjust accusations further fueled the conflict, leading to a heated exchange where CandyKuma demanded the immediate removal of her artwork. But instead of acknowledging his wrongdoing, Grant doubled down on his actions, perpetuating the theft and harassment.



Grant even threatened to keep CandyKuma's artwork if she and other artists would continue spreading awareness about his unacceptable behavior. Despite the threats, the art community united, amplifying the message to protect their work and stand up against plagiarism and harassment.



Grant then continued his rampage, vehemently denying any wrongdoing and telling CandyKuma to stop making comments about him. He insisted that she deserved to be punished for calling him out on his inappropriate behavior. Once again threatening to keep her characters without her permission. His attempts to silence her included creating more fake accounts to spam her with harassing messages, further isolating and intimidating her.



Grant even took it a step further and started encouraging everyone to wrongfully block and report him and lying about any wrongdoing he committed, including stealing CandyKuma's characters. His attempts to paint himself as the victim in this situation were transparent and deceitful, further illustrating the extent of his manipulative tendencies and the lengths he would go to distort the truth.

The art community, however, stood resilient, rallying around CandyKuma and denouncing Grant's actions, ensuring that his misconduct did not go unnoticed.

After getting banned the first time on Bluesky, Grant made a second account, and the harassment escalated further with him threatening people he came in contact with. This second wave of misconduct not only included theft of artwork but also aggressive and intimidating messages directed at artists and community members. Grant's increasingly volatile behavior created a hostile environment, significantly impacting the mental health and productivity of those targeted.

Grant issued a false apology to CandyKuma, claiming he would stop his harassment. However, despite being banned on Bluesky, he blamed a0zora for his suspension and continued his toxic behavior.



To make matters worse, Grant's deceptive behavior included a false apology to the community. He assured everyone that he would cease his harassment, but in reality, he continued targeting CandyKuma relentlessly. His alarming actions culminated in an outrageous threat to call the police for a trivial and unfounded reason, demonstrating his willingness to escalate the situation to extreme measures. This manipulation and abuse of authority further amplified the distress and insecurity among the creative community.




As if that wasn't bad enough, Grant even went as far as to become obsessive with CandyKuma to the point that he began to stalk her. His behavior included incessantly monitoring her social media activities and attempting to infiltrate her personal life.

His obsession with CandyKuma even went as far as to exposing her real-life situation, including her grandmother being in hospice, which was never mentioned throughout their interactions. This invasion of privacy greatly exacerbated the distress experienced by CandyKuma. In addition, he continued to falsely apologize and deny any wrongdoing during his previous run on his first suspended account.

He even went a step further and threatened to join her server in an attempt to harass her and her followers whom she supported, her server has been locked down since then to ensure her safety and the safety of others.



Screenshots show that Grant added CandyKuma's character's name without her permission or consent. In addition, he explains that he deliberately stole her character and used her character to roleplay with himself without permission or consent, making CandyKuma uncomfortable. This blatant disregard for personal boundaries and intellectual property highlights the severity of Grant's behavior and the lengths to which he is willing to go to cause distress to others.



As if that wasn't bad enough, he then began to stalk her closest friends, including a fellow artist named Lily who was friends with CandyKuma and one of her supportive fans.



He falsely assured the community that he would no longer use her character in profile pictures, despite having already taken her artwork numerous times without permission.




Grant's account got banned a second time after numerous blocks and reports were submitted to the Bluesky moderation team. Undeterred, Grant decided to go for round three. He once again resorted to his usual threats of calling the police and falsely blaming a0zora for his ban. His relentless pursuit and hostile actions continued to sow fear and anxiety among the community members, underscoring the urgent need for effective measures to curb such toxic behavior in online spaces.



He then continued ranting and ordering everyone to stop banning him, while persistently blaming a0zora for his repeated suspensions. Grant's actions escalated as he went a step further by stealing a0zora's character named Journey. This additional act of theft demonstrated his ongoing disregard for others' creations and boundaries, further intensifying the turmoil within the art community.

In a brazen attempt to regain control, Grant then went on to threaten a0zora on discord, demanding that they stop encouraging others to block and report his account. Despite his intimidation tactics, other artists continued to block and report his account, highlighting the community's unwavering stance against such toxic behavior.




Despite his assertion that he does not wish to upset anyone, Grant's actions speak louder than his words. His admission to posting characters and artwork that do not belong to him is a testament to his blatant disregard for respect and ownership within the community.






Despite all the turmoil caused, Grant's behavior did not cease. He went on to insult one of CandyKuma's supporters and calling her a brat while once again falsely promising once again that he wouldn't steal her characters anymore. Such deceitful assurances were quickly overshadowed by his demand for CandyKuma to stop spreading awareness about his inappropriate behavior. This further added to the community's frustration and underscored Grant's unwillingness to accept responsibility for his actions.



Grant is then seen finding out that CandyKuma likes Cream the Rabbit, a character from the Sonic the Hedgehog series, and disturbingly declares his own fondness for the same character. This revelation not only further highlights his obsessive behavior but also his invasive approach to CandyKuma's personal interests, making her feel even more unsettled and threatened by his relentless intrusions into her online and personal life.

In a misguided attempt to mend the situation, Grant reached out to a0zora, claiming that he wanted to resolve their differences. However, his true intentions quickly surfaced when he revealed that he was blocked and exposed by CandyKuma. His attempt at reconciliation was nothing more than a facade, as he soon admitted that CandyKuma had also blocked him.

When CandyKuma and one of her supporters brought Grant into a group chat, Grant raged out and left the chat

He hurled derogatory remarks and personal attacks at anyone who dared to question his actions, further alienating himself from the community. This escalation of hostility only served to deepen the rift between Grant and the rest of the art community, who were united in their condemnation of his actions. The toxic atmosphere he created left many feeling unsafe and anxious, highlighting the pressing need for stronger community guidelines and enforcement to protect members from such harmful behavior.

His behavior became even more erratic as he began to write in capital letters, signaling his heightened aggression and inability to engage in constructive dialogue. This tactic of overwhelming others with his loud, insistent proclamations was a clear indication of his unwillingness to acknowledge his wrongdoings or engage in meaningful conversations about his actions.







A couple of days later, he decided to make another alt account on discord, using CandyKuma's character as his profile pic, once again showing that he's stalking her.





On the 21st of March 2025, Grant was caught picking a fight with members of another discord server who had nothing to do with him, to which he was called out by admins and moderators for his actions.










He once again accused CandyKuma for a crime that she never committed, denying that he was involved with any wrongdoing.


He then threatened that he was gonna steal CandyKuma's character and not give it back to her.










On the 28 of March, 2025, he was caught trying to post hate art of another sonic OC while impersonating someone else. He was recently seen in the Sonic Revolution discord server.






After his comment was removed, he used his main account to try to cover up his wrongdoing.







CandyKuma was then thrown into a group chat where the confrontation between her and Grant escalated.

In addition, he continues to deny allegations regarding his inappropriate behaviour, claiming that a "family member" was behind the stalking and harassing.




He was also caught using a slur in the group chat.





He even tried making another alt account on discord in an attempt to rejoin the Sonic Revolution server, but he was banned immediately.

## User Statement:

"After a warning message from a separate server, the Grant guy indirectly joined my Discord server using "grantloves202020" username on March 13th, 2025. I quarantined the user from my server without directly banning them. Then, Grant left and rejoined my server 2 times to evade the quarantine role before leaving. I temporarily paused invites to my Discord server for 2 hours due to security issues.

However, on March 31st, 2025, the same guy using "grantlovespiper2025" alt account joined my Discord server again for the fourth time. I quarantined his alt account once again. However, he sent me a DM from the first screenshot saying that I was banning him from the server mentioned by a member of a different server. I never responded to his DMs in fear of retaliation. Because of those issues, I decided to enable DoubleCounter with strict settings requiring him to verify the server and disallow VPNs and alt accounts. After verifying, I limited the user from viewing any channels due to security issues, as he was looking into different channels.



Later, the "shinodawolf1244" joined my friend's Discord server and sent a false report in the general chat before leaving the server and using his other alts. I currently do not have the last known screenshot of the image he sent, but this was the message before I banned the user for making a false report. However, because the alt account left the server, I couldn't IP ban the user from the server.

He joined using the "grantlovespiper2025" account under verification requirements. After 5 minutes, the user was kicked from the server for failing to verify themselves. He joined again while under verification and accused some mods of "personally" kicking him from the server when the DoubleCounter bot actually kicked them. During verification, DoubleCounter detected a VPN intrusion, preventing him from completing his verification before he turned off the VPN and completing verification.





However, many mods warned me about the user, so I instructed my staff to ban Grant from me and my friend's server. Grant later joined using an alt account, "grantlovespiper2025" and found we were banning him from our servers. He sent more DMs, provided more false evidence (considering his track record), and plans to evade suspension from our servers using multiple alt accounts and VPN.



After DoubleCounter kicked his alt account for failed verification, he used another alt account while using a VPN to evade suspension. He sent even more vague and false DMs with the user ID shown on the screen. However, the user ID did not exist when I used ID lookup. Once again, I never responded to any messages.




DoubleCounter once again kicked his alt account for verification failure, and he was never seen again on our servers. Our staff decided to ban all alt accounts from our servers using Carl-bot's /massban command with all user IDs listed in your document.

I have more screenshots to document. This time after my announcement from a different art thief, same grant guy sent me this message, which I was able to screenshot the user.
