Journal Entry of Kian Durant on day - [REDACTED]

The Durant family was a South African Military family. So it was tradition for someone like me to be in the military at some point in my life and I joined at age 19. I worked my way up through the ranks and proved I was able to join the Special Forces, Recces. We specialised in counter-insurgency, long range reconnaissance, hostage rescue, direct action operations and unconventional warfare.

Well that's all everyone knew about. Operation **Branded Steel**, our task was to infiltrate and grab documents from a facility in the Sinai Peninsula. The facility was heavily guarded like it was protecting a small country. It's where I got hit by shrapnel once our helo got shot down. I woke up in a hospital with multiple military men in and outside my room and a man in a black trenchcoat asked me if I'd like to know the truth of the world. I was a superstitious person so I said go ahead.
