Abstracts are written in English in unstructured form, with a concise and clear manner, thus allowing the reader to understand important aspects without having to read the entire script. The abstract contains no more than 250 words, covers the background, objectives, methods, results, and conclusions. There is no suggestion in abstract, use Times New Roman 10pt.

Keywords: consists of 3-5 words that can help the preparation of the index, separated by semicolon (;), Times New Roman 10pt

INTRODUCTION

Introduction includes background, a little literature review, research problem formulation and research objectives. Introduction contains justification of the importance of the study conducted. Novelty generated from this study compared the results of previous studies or existing knowledge needs to be clearly displayed. Complete it with main reference used.

MATERIAL AND METHODE

Material and method contains the design, the size, criteria and method of sampling, instruments used. procedures collecting, processing, and analysis of the data. When using a questionnaire as instrument, explain the contents briefly and to measure which variables. Validity and reliability of instruments should also be explained. In the experimental or intervention studies need to be explained interventional procedure or treatment is given. In this section it should explain 2 research ethics approval was obtained and the protection of the rights of the respondents imposed. Analysis of data using computer programs needs not be written details of the software if not original.

Place/location of the study is only mentioned when it comes to study.

For the qualitative study, in this section needs to explain how the study maintain the validity (trustworthiness) data obtained. The methods section written brief in two to three paragraphs.

RESULT

The findings are sorted by the objectives of the study or the research hypothesis. The results do not display the same data in two forms namely tables/images /graphics and narration. No citations in the results section. The average value (mean) must be accompanied by a

standard deviation. Writing images and tables using the following conditions.

Images are placed symmetrically in columns within a single space of a paragraph. The image is placed in the position of the top or bottom of each page and do not flanked by sentence. If the size of the image passes through the column width then the image can be placed with a single column format. Images are placed immediately after its description in the manuscripts. Pictures are numbered and sorted by Arabic numerals. Captions placed below the image and within one single space of the image. Captions are written by using 10pt font size, bold, capital letters at the beginning of the word, and placed as in the example.

Images which have been published by other authors should obtain written permission from the author and publisher. Include a printed image with good quality in a full page or scanned with a good resolution in the format {file name}.jpeg or {file name}. tiff. When the images are in the photograph format, include the original photographs. The font used in the picture or graphic should be commonly owned by each word processor and the operating system such as Symbol, Times New Roman with size not less than 10 pt. Image files which are from applications such as Corel Draw, Adobe Illustrator and Aldus Freehand can give better results and can be reduced without changing the resolution.

Here (Fig. 1) is an example of an image included in the manuscript.

Table should not use a column line. Table is written with Times New Roman size 10 pt and placed within a single space below the title table. Numbering tables are using Arabic numerals. The distance between table and the paragraph is a single space. The table is put immediately after its appointment in the manuscript. The table framework is using lines size 1 pt. If

the table has many columns, it can use one column format at half or full page. If the title in each table column is long and complex, the columns are numbered and its description given at the bottom of the table. The table is placed in the highest or the very bottom of each page and do not flanked by sentence. Avoid interrupted the table by page.

For the qualitative study, the findings commonly are written in the form of participants quotes. Table format is rarely used except to describe the

characteristics of the participants, or recapitulation of the themes or categories. If the quote is not more than 40 words, then use quotation marks (") at the beginning and at the end of a sentence and include participants/ informants which give statements without the need to create separate paragraphs. Ellipsis (...) is only used to change a word that is not shown, instead of a stop sign/pause. See the following example.

It is need to discuss the reason of the findings. The implications of the results are written to clarify the impact of the results the advancement of science are studied. The discussion ended with the various limitations of the study

The author-year notation system is required and completed. All references mentoned should be written down in reference using Vancouver style and arranged from A to Z. Articles have minimal 10 recent references (last 10 year for book or last 5 year for article, journal or others references) and 80% is journal. The number of references is at least 20 references. References from journal publication should be provided by DOI. All cited references must be mention in in-text citation. It's very recommended to use Mendeley or Zotero.
