Application, Registration and Payment Policies 2025-2026

SAC Lottery Information

To be considered for a SAC slot, each student (new to SAC and existing SAC students) must be entered into our lottery system. The on time lottery sign-up window will be open from April 7, 2025 at midnight and closes on April 25, 2025 at 2 pm for incoming kindergarteners through 8th-grade students.

Tiered Selection Process

At the end of the Lottery window, available spots are filled using the following tiered system. At any given location, the higher tier will be filled before applicants are accepted from the next tier. Within each tier, full-time schedules and children of BVSD benefits-eligible employees will receive priority. **No child is guaranteed a spot, including full-time returning applications.** Once all applications in Tier 1 are fulfilled, the next tier will open, and this process will continue for each subsequent tier.

Our tiers consist of the following:

1. Returning applications: Students enrolled in School Age Care at the opening of the 2025 Lottery at the same school, or 2023-24 SAC students that applied in the 2024-25 Lottery but did not receive a spot.
2. Siblings of Returning Applications: New sibling applications of returning applications.
3. New Applications: Not enrolled in SAC at the time of the Lottery, or moving to a different school.
4. Late Applications: Applications submitted after 2:00pm on Friday, April 25.

How to sign up the SAC Lottery

School Age Care: The online lottery application for the fall will be open on April 7, 2025, (12am) and will close on April 25, 2025 at 2 pm . All applications received after the closing date (April 25, 2025 at 2 pm) will be considered a LATE SAC lottery application and will be time stamped and be placed at the bottom of the waitlist.

Fixed Enrollment Period

To ensure efficient planning and staffing, schedule choices for the School Age Care (SAC) program are fixed through December 31, 2025 . We are unable to accommodate schedule changes prior to that date. The only change allowed before December 31, 2025 , will be disenrollment from the SAC program.

Cancellation Request

If you need to cancel your child's SAC schedule, we require a **two-week notice via email** to bvsd.childcare@bvsd.org. Please include your student(s) name, the SAC site location, the schedule you wish to cancel. The effective date of the schedule change will be two weeks from the time the request was received, or later if indicated. Refunds are processed only for the period beyond the two-week notice date and are subject to the terms and conditions of the two-week cancellation policy. Parents are responsible for any unpaid fees at the time of withdrawal. If you

cancel your student(s) SAC enrollment and later require SAC services, you will need to apply for the late lottery. *Please note: late lottery applicants are placed at the bottom of the waitlist.* Please note that if you plan on entering the SAC lottery for the 26-27 school year, in order for your student(s) to receive the Returning Family preference, your student(s) must be actively enrolled in SAC at the time of the 26-27 lottery. Disenrolling your student(s) **before** the lottery opens will make them **ineligible** for this preference.

Schedule Choice Fixed Through The End of December

Any registered SAC schedule (full or part-time) will remain fixed. Schedule change requests can be submitted starting December 1, 2025 at 8:00 am via a link on our website and ends on December 10, 2025 at 3:00 pm. If the schedule change is approved, it will be for a January 1, 2026 start date. A **\$25 schedule change fee** is associated with this request.

When considering a schedule change request, you may request to move from full-time to part-time or vice-a-versa.

*The only schedule change request permitted BEFORE the schedule change window will be complete disenrollment from the SAC program. **No schedule changes will be granted after the schedule change window closes on December 10, 2025.** After that, the only permitted change will be complete disenrollment from the program.* If you wish to adjust your schedule after the deadline, you may re-enter the lottery with your specific schedule request and will be placed at the bottom of the waitlist, if applicable.

- Schedule change requests must be submitted using the designated form on our website.
- Schedule change requests will be time stamped upon receipt.
- For staffing and state licensing purposes, we do not offer custom scheduling or rotating scheduling pricing. Exchanging days is not allowed. Permanent additions or changes would require a schedule change fee and written notification to the registrar.

Adventure Camp Registrations

Online registration will open for all school-year Adventure Camps shortly after the beginning of each school year. Space may be limited due to excursion type or transportation required.

How to Register

Current School Age Care (SAC) Families will register through their Parent Portal by clicking on the "registration" tile from their home page. Families will be charged at the time of the request for all dates selected.

New Families without a SAC account will first register through the BVSD SAC website. Once registration information is approved, you will be able to register for Adventure Camps through your new Parent Portal account (Information will be provided in your confirmation letter).

- Children must be actively enrolled in a BVSD Kindergarten – 8th grade school to be eligible for Adventure Camps.
- There is a one-time registration fee of \$75 to set up a childcare account for the first sibling. For additional siblings, the one-time \$10 non-refundable registration fee will be included in their registration cost.

Schedule Changes and Attendance or Absences

Registration closes on the posted cut-off date for planning and staffing purposes. Any cancellation request before the cutoff deadline will be assessed a \$25 cancellation fee. Any site and or schedule changes for camps you have registered for will be assessed a change fee of \$25.00.

If you reserve a space and your child does not attend for any reason, the camp fee is non-refundable. This policy is in place because the cost for staff and programming remains the same when children are absent

Monthly Tuition Payments

How Billing is Calculated

Tuition payments are based on the number of attendance days in the school year, divided by the number of months the program runs during the school year (August - May).

Payment Options and Deadlines

Monthly payments are due in the BVSD Childcare office by the 20th of the prior month (ex: September tuition is due on August 20th) and are payable with a credit/debit card, checking or savings account.

- Parents may set up auto payment through their SCW parent portal. Auto payments run on or near the 20th of every month.
- A \$25 charge will be assessed for ACH/NSF that are returned. After two consecutive returned checks or credit card denials, a cash or money order will be required.
- Contact your employer or human resources department for information on using a flexible spending account for childcare.

Delinquent Accounts & Late Payment Fees

- Accounts that are unpaid may result in termination from the program and will be charged a late fee of \$25 for each month the bill is unpaid.
- Payment must be received in full prior to returning to the program.

- Failure to respond to your delinquent balance, can result in removal from the program before the next billing cycle. If we have not received payment or communication your seat becomes available for another student upon review of the enrollment and management team.
- Families with accounts that are not in good standing may not be allowed to enroll their child(ren) in current or future programs until the account balance has been paid.

Refund Policy

Regular tuition and fees will be charged for all absences. This policy is in place because the cost for staff and programming remains the same when children are absent. No refunds or credits will be given for school closings, days off, sick days, weather related closures (example, snow days), COVID or other health quarantines, or family vacation days.

Child Care Fees & Discounts

Discounts do not 'stack'; you may have a sibling discount applied or the BVSD employee discount applied, but not both.

Registration Fees

- A non-refundable registration fee and the first month's tuition are due at registration. The registration will not be confirmed until paid in full or the CCAP authorization information has been provided to the BVSD Childcare office.
- There is a non-refundable annual registration fee of \$75. Additionally, a one-time, non-refundable \$10 registration fee applies per sibling each year.
- If you have withdrawn or have been terminated during the school year and decide to re-enroll your child, you will be charged another registration fee.

Late Pick up & Nonattendance Notification Fees

- A late fee of \$1.00 per minute will be charged for every minute the child is in attendance past the closing time of the program.
- All absences must be reported to your childcare program prior to the absence.
 - Failure to notify staff of an absence will result in a \$10 non-notification fee. If we are unable to reach you within 30 minutes, it is our practice to make a non-emergency report to the local police department to inquire about your child's whereabouts.
 - **After two late pick-ups, you will be contacted by a SAC Coordinator and upon the third occurrence your child care services are no longer guaranteed.**

Discounts Available

- Sibling discounts: A monthly tuition discount of 15% is given for each additional child after the 1st full paying tuition child in any of our BVSD child care programs (School Age Care).
- Employee discounts: There is a monthly discount of 15% for each child enrolled for a current district benefit-eligible employee.
