

Attorney General Removal

Reasons

The original job of the Attorney general in Mk 2 was to protect the President from lawsuits. The job of the AG in Mk 3 was to hold the executive accountable. The execution of that is horrendous. Having the AG answer to the President makes it impossible for this to happen, on top of that, having the AG exist at all takes the burden away from the community to hold their government accountable, and puts it on the shoulders of one person. Removing this will be the most controversial of recent amendments, but for the good of the government accountability, it should be done.

Text

This Amendment hereby changes the following...

Article 2 Section 1 Subsection 2

“The Presidential Chamber shall consist of one President, one Vice-President, and one Attorney General.”

Shall read

“The Presidential Chamber shall consist of one President, **and** one Vice-President, ~~and one Attorney General.~~”

Article 2 Section 2 Subsection 10 shall be stricken from the Constitution

“10. The Attorney General should be well-versed in the law and Democratic Constitution, and must impartially advise members of the Executive branch in legal matters. Additionally, the Attorney General shall represent the President in legal battles.

- a. In the event the Attorney General relinquishes their title for any reason, the President must choose a willing replacement within reasonable time of the position's vacancy.
- b. The Attorney General may create inferior attorney positions, and may appoint inferior assistants to help with their various duties.
- c. The Attorney General and, if so assigned, their official designated inferior attorneys are responsible for acting as plaintiff on behalf of the government in any Criminal Investigation cases.
 - i. The President retains the right to require the Attorney General to recuse their office from serving on a case, thereby allowing any citizen to take on the responsibility of plaintiff.”

Article 2 Section 6 Subsection 2

“2. Should the Attorney General, Governor, or Councilor feel they will be unable to attend a scheduled game session, they may appoint an Executive proxy to assume their role for the remainder of the specified game session. They must inform the President or Vice-President of the identity of their proxy prior to the specified session.

- a. Executive proxies must be registered voters, and may not be currently members of the Legislative or Judicial branches.
- b. Executive proxies are bound by the same laws and regulations as their assumed role while acting in place of said member of the Executive branch.
- c. If the Attorney General, Governor, or Councilor appoints an Executive proxy for a game session, they will not be considered absent for said session.”

Shall read

“2. Should ~~the Attorney General,~~ a Governor, or Councilor feel they will be unable to attend a scheduled game session, they may appoint an Executive proxy to assume their role for the remainder of the specified game session. They must inform the President or Vice-President of the identity of their proxy prior to the specified session.

- a. Executive proxies must be registered voters, and may not be currently members of the Legislative or Judicial branches.

Article 6 Section 5
