


Harvey Milk LGBTQ Democratic Club April 2025 Oakland Mayoral Endorsement Questionnaire (February)

I recognize that some aspects of the platform are tailored specifically to San Francisco's unique context. While my campaign focuses on addressing the distinct needs of Oakland, I am committed to upholding the shared values of equality and inclusivity that resonate across both cities.

Also, I appreciate the Club's dedication to mental health support. While I advocate for integrating mental health professionals into emergency responses, I believe collaboration with law enforcement is essential to ensure public safety.

1. The residents of Oakland are seeking a strong leader as the City faces a budgetary

crisis. What are your qualifications to be the Mayor of Oakland?

I grew up in Oakland in a bilingual-bicultural English-Spanish household and have lived here for much of adult life. I am an Olympian and a graduate of UC Berkeley and Harvard. I was also a technical and non-technical recruiter for 7+ years for some of the top tech and non-tech companies, so I am able to build great teams and will also create the best team of people to help guide Oakland during this time. I'm also a stand-up comedian and producer, so I can occasionally bring moments of lightheartedness, which is helpful in creating unity across different viewpoints.

I interned during Gavin Newsom's San Francisco Mayoral Campaign and then in his Mayor's Office of Neighborhood Services (MONS). During these times, I helped with Spanish-speaking voter outreach, and homeless outreach. I also assisted with the fist same-sex marriages in the city.

2. Why is the endorsement of the Harvey Milk LGBTQ+ Democratic Club meaningful to you?

The endorsement of the Harvey Milk LGBTQ+ Democratic Club is deeply meaningful to me because of my lifelong commitment to inclusivity, leadership, and advocacy. As a two-time recipient of the Mark Bingham 9/11 Leadership Scholarship, I carry forward the legacy of a courageous leader who championed LGBTQ+ rights and inclusivity. Working on Gavin Newsom's mayoral campaign, I contributed to Spanish-speaking voter outreach and was also on the team that initiated San Francisco's first same-sex marriages—an experience that reinforced my dedication to equality. Watching the film *MILK* was moving, and meeting its screenwriter, Dustin Lance Black, in 2009 and 2019 further deepened my appreciation for the ongoing fight for LGBTQ+ rights. As a stand-up comedian and producer, I also understand the power of storytelling and unity. I would be honored to have the club's support in building a more inclusive and stronger Oakland.

3. Given the Trump Administration, what specific policies will you champion to ensure that Oakland remains a safe and affirming city for LGBTQ+ individuals, particularly transgender and gender-nonconforming people?

The state of California is already strong with LGBTQ+ rights, especially compared to the rest of the country. I would work to help Oakland ally with Governor Newsom and with the state on California on these policies.

Also, I value that the Harvey Milk LGBTQ+ Democratic Club has long been a champion for equality, justice, and progressive change, all of which I deeply respect. Your club's advocacy for housing as a human right, economic justice, and more aligns with my commitment to making Oakland a more inclusive and equitable city. I appreciate the Club's dedication to uplifting marginalized communities, and I look forward to working toward shared goals that

benefit all Oakland residents.

4. Data shows that a significant portion of homeless youth identify as LGBTQ+. What is your plan to address this type of homelessness and to significantly decrease homelessness overall (short- and long-term)?

I see that LGBTQ+ youth face unique challenges that contribute to homelessness, including sometimes family or workplace lack of support. I will work to expand access to emergency housing, strengthen partnerships with LGBTQ+-affirming shelters, and increase funding for mental health and job training programs.

In the long term, my focus is on building more affordable housing, preventing evictions, and investing in supportive services that address the root causes of homelessness for all Oakland residents.

5. How will you work to address health disparities within Oakland's LGBTQ+ communities, including access to mental health services, HIV/AIDS prevention information and medicine, and gender-affirming healthcare?

I would like to help Oakland strive towards an Olympic standard of healthcare. For example, at my 2018 Olympics, any participant could access healthcare, dental care, and sexual health resources. A total of 50,000 condoms were offered to a total of 2,800 athletes over the month. Similarly, Oakland should always have a supply of sexual health products to offer to all residents.

Funding places like the Oakland LGBTQ Community Center would also help support the LGBTQ+ population.

6. Describe your work addressing the climate crisis, and what specific steps you think Oakland will need to take to confront climate change and environmental injustice.

I believe Oakland should offer incentives to all residents to use public transportation or bike to work. Contra Costa County and the state of California are offering similar incentives.

I also believe in protecting Oakland's parks, wild animals that live in Oakland, and supporting Oakland Animal Services.

7. How have you addressed racial injustice and police brutality? What actions will you take to implement meaningful police reform in Oakland, reduce police violence, and promote alternative community safety models?

I believe that the Oakland police needs more diversity in its police force and needs to communicate with and understand its residents more. Community policing or community safety officers would also work as a complement to the existing police officers. I would also work to better understand what the police unions want, so a compromise can be reached on how they can better connect with the community.

I applied twice to be an officer and wanted to offer my perspective and help with reform. I was ranked as the #1 candidate two years in a row, but was ultimately not offered a position. I will also work to eliminate roadblocks to avoid bureaucratic obstacles so that more diversity can be achieved in the Oakland police force, to better reflect its residents.

8. How will you work to reduce incarceration rates and promote restorative justice practices, particularly for LGBTQ+ individuals and communities of color?

I plan to expand diversion programs, invest in community-based alternatives to policing, and advocate for restorative justice to reduce incarceration. For LGBTQ+ individuals and communities of color, I'll push for equitable policies, end discriminatory policing, and prioritize rehabilitation over punishment.

Either continuing Jestin Johnson or someone similar to him would be ideal; someone with an extensive background and passion in municipal government.

11. How will you ensure transparency and accountability in your administration while amplifying the voices of Oakland's marginalized communities? How will you work to ensure Limited English Proficient (LEP) community members have access to government services?

My mother is a Spanish-English interpreter, translator and voiceover talent in Oakland. I am constantly aware that Oaklanders may have a preference in a language other than English. I would work to ensure access to government services in multiple languages for all Oaklanders.

I understand that members of the community can already speak at many city meetings at City Hall. It would be helpful though to bring more city meetings to more locations around Oakland, or at least livestream them in community centers so more Oaklanders can have access to watching and participating in these meetings.

12. Given the weak mayoral system in Oakland, how will you leverage your charter-granted power to make any of the changes you discussed above?

By understanding the needs of the City Council members and their constituents, and other members of Oakland's government, we can all become more aligned and understand the needs of Oakland's residents.
