### **Personal information we collect**

- *Information that you provide voluntarily*

- *Information that we collect automatically*

The App may collect certain information automatically from your device when you use it, such as information about the device or browser that you are accessing the App from or diagnostic data. In some countries, including countries in the European Economic Area (“EEA”), this information may be considered personal information under applicable data protection laws. The App may also collect information about how your device has interacted with the App, including the pages accessed and links clicked. ### **How we use your personal information**

We use and process or share your personal information collected through the App for the following purposes:

- **To Provide and Operate Church Services**  
To enable participation in worship services, events, volunteer opportunities, small groups, and other church-related activities.
- **To Communicate With You**  
To send service announcements, commission updates, event notifications, prayer communications, and other information related to church activities via email, text messages, push notifications, or in-app messaging.
- **To Process Donations and Financial Contributions**  
To process tithes, offerings, and other donations securely, issue contribution statements, and maintain financial records as required by law. Payment information is handled by trusted third-party payment processors.
- **To Manage User Accounts and Preferences**  
To create, maintain, and manage user accounts, authenticate access, personalize content, and save user preferences within the app.
- **To Improve App Performance and User Experience**  
To analyze usage trends, monitor performance, fix errors, and enhance app functionality and content, including through aggregated and de-identified data.
- **To Ensure Security and Prevent Fraud**  
To protect the app, users, and church systems from unauthorized access, security threats, misuse, or fraudulent activity.
- **To Comply With Legal and Regulatory Obligations**  
To comply with applicable federal, state, and local laws, including accounting, tax, and record-keeping requirements.
- **For Internal Administrative Purposes**  
For internal operations such as audits, reporting, and ministry planning.
- **With Your Consent**  
To use personal information for any additional purpose disclosed to you at the time of collection or with your explicit consent.

### **Data security**
