

## Privacy Policy

### 1.Your data protection rights

- 4)Object to processing: you have the right to object to the ways in which we are using your personal data.

### 2.What types of personal data do we collect

We collect, store, and use the following categories of personal data:

- 1)device identifiers (such as IDFA, IDFV for Android, GAID for IOS).
- 2)email address.
- 3)the type and operator of network (such as Mac address).
- 4)the type, version, brand, language and operating system of device.
- 5)behavioral usage of the App.

### 3.Purposes for collecting personal data

Such purposes may include the following:

- 1)To provide Services to users.
- 2)To detect and prevent fraud.
- 3)To promote, improve, and further the provision of the App and/or Services.
- 4)To comply with, whether compulsory or voluntary, any present or future law, rules, regulations, judgment, court order, request, or commitment or arrangement binding on or applicable to us.

### 4.With whom do we share your personal data

We outsource a number of services to contracted service suppliers from time to time. Typically we share your personal data with the following:

- 1)Third party service suppliers, such as I.T. contractors and database designers and Internet service suppliers, legal and other professional advisors.
- 2)Our subsidiary and affiliates.
- 3)Entities involved in dispute resolution.
- 4)Governmental entities.

These uses and disclosures are also subject to our contractual obligations.

#### 5.How long do we collect personal data

We will retain personal data as long as necessary to fulfill the purposes outlined in this Policy unless the law requires us to keep it for a longer period of time. We will cease to retain your personal data, or remove the means by which the data can be associated with you, as soon as it is reasonable to assume that such retention no longer serves the purpose for which the personal data was collected, and is no longer necessary for legal or business purposes.

#### 6.What about data security

To help protect personal data from being accidentally lost, used, altered, destructed, disclosed or accessed in an unauthorized way, we have put in place physical, technical, and administrative safeguards. We limit access to your personal data to those who have a genuine business need to know it.

#### 7.What about children's data

We do not knowingly collect personal information from children under the age of 13 years old. The App is not intended for or directed to children. If you believe we may have collected personal data from a child, please contact us to delete it from our system.

#### 8.External sites

The App may contain links to or from other websites. External sites that are linked to or from the App are not under our control and you are advised to review their privacy policy and terms of use.
