The contents of the introduction that you include in detail include the background of the problem which is supported by factual evidence so that you can include in detail the results of the initial observations that you have made as part of your research process.

The explanation of the background can be strengthened by reviewing literature or related research results that are cited directly according to topics that are relevant to the research you will conduct. In each paragraph you can include any citations to support primary information that refers to each related research.

METHOD (12 pt Cambria font)

Written using Cambria font 11 pt, 1.0 spacing. The research method you use must be explained in detail and coherently starting from the type of research, sample selection method, data collection techniques and the data processing process that you carried out quantitatively and qualitatively and can include the results of data triangulation if this was done in your research process. In this method, avoid using general concepts and focus more on the research design you choose and can refer to results or opinions from experts according to the specific research method you are conducting.

RESULTS AND DISCUSSION (12 pt Cambria font)

Written using 11 pt Cambria font, 1.0 spacing. It is the result of presenting research results that have been obtained which are published or discussed in the form of comparative analysis results or descriptive studies and so on according to the research you conducted. The results are presented logically and contain relevance that is integral to the context of the literature as study material that is carried out in real terms to support each research result that you have obtained.

If Using Tables

Contains in detail each spec and component measured using clear instruments in the research process. Each table is numbered according to the sequence (Table 1, etc.), with a center justified position.

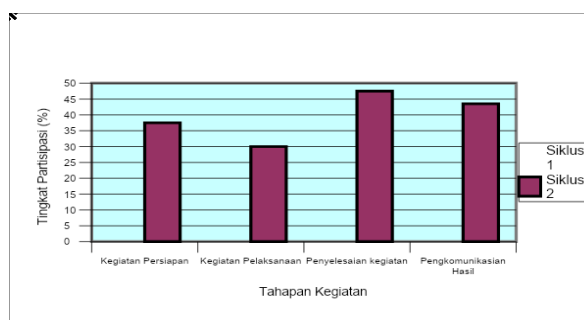

Conclusions are prepared in paragraph form (**not in numbering form**), which are arranged logically and explain the correlation of each research result obtained and its main implications in the field of education or the general public.

BIBLIOGRAPHY (12 pt Cambria font)

It is recommended to use **APA style** by using the Mendeley or Zotero reference manager application consistently so that each literature review result can be clearly included in the bibliography used to support each study of research results that are considered relevant or appropriate. By using Mendeley, each bibliography will be automatically sorted. The minimum number of citations entered is 10 relevant citations aligned right and left in **Cambria 10 Pt Font**.
