Terms of Service (TOS) Dramokin Art

Please read these terms carefully before commissioning me. By commissioning me, you agree to these terms.

1. General Guidelines

- I reserve the right to reject any commission request that makes me uncomfortable or goes against my values.
- My artwork is strictly **prohibited** from being used for AI, crypto projects, or NFTs.
- If you are found using any of my artwork—including character designs, commissioned illustrations, or any other pieces—for AI training, generation, or modification, you will be permanently **blacklisted**. This means you will **lose all rights** to the commissioned piece, and you will no longer be allowed to commission or collaborate with me on any future projects.
- My artwork cannot be used for commercial purposes (e.g., selling merchandise) unless explicitly discussed and agreed upon beforehand. Personal use only unless otherwise stated.
- You are free to check on the status of your commission at any time.

2. Payment

- Payment is **upfront**, and I will not begin the commission until payment is received in full.
- Payments are accepted exclusively through **PayPal** or **Ko-Fi**.
- If I do not receive payment within **24 hours** of sending the invoice, your order will be canceled, and you will not be added to the commission queue unless discussed otherwise.

3. Revisions

- Revisions are **only allowed during the sketch phase**. Once you approve the sketch, no further alterations will be made, except for minor details like patterns on clothes, hair adjustments, or fur details.

4. Adoptable and Custom Designs

- Once purchased, you may use and modify my adoptable designs as you wish. However, **proper credit** for the original design must always be given to me.

5. Communication

- Please be respectful and patient; I will do my best to respond promptly and keep you updated on your commission status.

6. Blacklist Awareness

- Clients are advised to be aware of my blacklist. I will not work with individuals on this list under any circumstances.
- If you are found to be **evading the blacklist**—whether through second, third, or any other parties—**all users involved will be added to the blacklist.**
- I reserve the right to refuse future service and rescind any personal-use licenses for the artwork files provided.
- If the blacklisted individual continues to use the design after rights have been revoked, I will proceed to file a **DMCA takedown.**

Evading the blacklist is taken seriously and will result in permanent removal from any future transactions or collaborations.

7. Refund Policy

- If, for any reason, I cannot complete your commission, I will issue a full refund.
- If, for any reason, the client wants a refund after the sketch was complete. I will issue a 50% refund.
- Refunds are **not available** once the final product has been delivered.

8. Usage Rights

- As the artist, I retain all rights to the artwork I create. This includes the right to use the commissioned piece for promotional purposes, portfolio examples, or social media posts unless otherwise agreed upon.
- If you do not wish for your commission to be shared publicly, please inform me when placing your order.

9. Copyright and Credit

- Do not claim my artwork as your own. Proper credit must be given if the artwork is shared or used online.
- If you wish to use the artwork for commercial purposes, additional fees and agreements will apply.

10. Client Rights

- **Ownership of Character:** The client retains all rights to the characters depicted (unless it is an adoptable/custom design being purchased).

- **Personal Use License:** The client is granted a non-exclusive license to use the final artwork for personal purposes. This includes uploading to social media (with credit), using as an avatar, and printing for personal, non-commercial display.
- **File Standards:** The client has the right to receive a high-resolution, unwatermarked digital file upon completion of the commission.
- **Communication:** The client has the right to be notified of any delays that extend beyond the estimated turnaround time.
