Thompson, Cheryl W.; Chinoy, Ira; Vobejda, Barbara; "Fatal Flaws: The District's Homicide Crisis." The Washington Post, Dec. 3-6, 2000. NOTE: This four-day series exposed the Washington, D.C., police department's declining ability to solve homicides. The stories also revealed some of the violent effects of this problem, including a significant number of repeat killers and a pattern of "street justice" – cases closed by revenge on the streets instead of justice in the courts. This project, which prompted calls for reform, hearings, and changes in police practices, won a first-place award for enterprise reporting from the National Association of Black Journalists and a first-place award from a regional press association.

Leen, Jeff; Craven, Jo; Jackson, David; Horwitz, Sari. "Deadly Force: An Investigation of D.C. Police Shootings." The Washington Post, Nov. 15-19, 1998. ROLE: director of computer-assisted reporting. NOTE: This five-day series revealed a higher per-capita rate of fatal shootings by police in Washington, D.C., than in any other large American city. Stories explored the problem's causes and consequences. Other members of the team included four reporters, two editors and two researchers. The series led to reforms in police training and prompted the police chief to seek federal help in investigating D.C. police shootings. This project won a Pulitzer Prize for Public Service and the Selden Ring Award for investigative reporting.

In *The Best of Times: America in the Clinton Years*, Professor Haynes Johnson of the University of Maryland described this reporting project as "the definitive analysis of Scaife's largesse as leading patron of conservative causes."

This series, which has been cited in subsequent studies, won a first-place award for state government coverage from the Maryland-Delaware-D.C. Press Association. *The Washington Monthly* described it as "a

shocking look at how involved government has gotten in the business of persuading its citizens – especially the poorest – to gamble."

The reporting led to the resignation of – and criminal charges against – the chief justice of the state Supreme Court. Contributions to the investigation included coauthoring stories on a slush fund used by the chief justice and the top court administrator (Barry, Dan; Chinoy, Ira; "The days of booze and baskets: A closer look at how Chief Justice Fay and administrator Smith spend funds from the secret account," The Providence Journal, Providence, RI, Sept. 24, 1993) and on patronage in court-awarded legal work (Barry, Dan; Chinoy, Ira; Starkman, Dean; Sullivan, John; "Fay gives arbitration work to friends, allies: His fishing partner made more than \$125,000 for arbitrating a single Providence contract dispute," The Providence Journal, Providence, RI, Aug. 24, 1993; and Barry, Dan; Chinoy, Ira. "Chief Justice Fay awarded labor cases to top Democrats: The appointments included House leader Joseph DeAngelis, according to records obtained from the Supreme Court," The Providence Sunday Journal, Providence, RI, Sept.12, 1993). The Supreme Court chief justice at the center of the coverage resigned in the face of impeachment proceedings and criminal charges. Team coverage of the evolving court scandal during 1993 won a Pulitzer Prize for Investigative Reporting, an Investigative Reporters and Editors Medal, and first place in the enterprise category of the New England Associated Press News Executives contest.

RISDIC investigation. The Providence Journal, Providence, RI, 1991-1992. ROLE: Reporter. NOTE: In 1991 and 1992, a reporting team investigated the ill-fated Rhode Island Share and Deposit Indemnity Corporation (RISDIC), the developers who profited from inadequate safeguards at the institutions RISDIC insured, and the political figures who contributed to problems precipitating RISDIC's collapse. The newspaper's coverage by two editors and 11 reporters won the 1992 Sevellon Brown Award for public service journalism in New England. Contributions included authoring or coauthoring the following stories: "2nd warning to DiPrete failed to curb RISDIC; Normand Benoit told Governor DiPrete that the RISDIC situation was perilous, in a report 5 years ago," Feb. 10, 1991; "RISDIC became steady donor to DiPrete

campaigns," March 17, 1991; "Credit union sank \$687,500 into marshy Cranston lots," April 14, 1991; "Loans to big borrowers sealed RISDIC's fate," Oct. 6, 1991; "RISDIC's morning after; Rhode Island Central poured millions into Cranston site," Feb, 23, 1992; "The party's over... for Tom D'Andrea; The banking crisis: a big borrower," Feb. 23, 1992.

Teaching Innovations

Course or Curriculum Development

Search Mastery Project: In an ongoing pilot phase in 2020-21 and 2021-22, this project, which originated as an endeavor of the Future of Information Alliance, aims to enhance the abilities of undergraduate students at UMD to find, evaluate and use information through online search of the open web. The pilots began in 2020-21 as a collaboration between faculty in the College of Journalism, the College of Education, the College of Information Studies, the University Libraries and the Media, Self & Society program of College Park Scholars. The materials include four modules, plus pre- and post-tests, and have been used in a variety of courses either in their entirety or selectively.

JOUR200: Journalism History, Roles and Structures. This required first course for incoming freshmen in the journalism major and an elective for other UMD students is a survey of more than 325 years of American journalism history and practices. After consulting with other faculty and doing extensive research and other course preparation, I created my own complete set of lecture materials, supplemented textbook readings with primary sources, and developed in-class, hands-on modules for conducting research in historical periodical databases online. I serve as lead instructor among up to five teachers in the fall and two in the spring who have classes of up to 30 students each semester. I redesigned this course again for distance learning during the pandemic in the 2020-2021 academic year.

JOUR476: Researching Emerging Media in Journalism: Past, Present and Future. I introduced this course in Fall 2015 as a thorough revision of and replacement for JOUR479W, exploring similar themes. I redesigned the course for distance learning during the pandem in the 2020-2021 academic year.

JOUR479W: History as Context for Emerging Media in Journalism. I created this course to explore the interplay of continuity and change at the intersection of journalism, technology and culture.

JOUR774/474: Mining the National Archives. I created this course to take advantage of the proximity of the University of Maryland campus to Archives II, the major National Archives research facility located in College Park.

JOUR772/472: Computer-Assisted Reporting. I completely revised this course, starting in 2001, to emphasize the experiential-learning and critical-thinking aspects of a semester-long project to acquire databases from Maryland state and local agencies that are public record under the law but are not accessible on the Internet.
