Below are **three priority legislative bills which the BEA/MTA have endorsed**. For each statement, please indicate if you agree or disagree with the BEA's position and then elaborate briefly to clarify your position.

#### **Fair Share Amendment**

Massachusetts voters will have a once-in-a-generation opportunity in 2022 to make sure that public education gets the permanent funding it deserves. The Fair Share Amendment would change the state's Constitution to help address the chronic underfunding of our public schools, colleges and universities. The amendment would add 4 percentage points to the tax on income above \$1 million, generating up to \$2 billion annually for public education and transportation. This could lower class sizes, strength higher education programming, reduce student debt, address the impacts of systemic racism on communities of color, and restore staff to institutions that serve the common good — which have been hit hard by decades of austerity budgets. We support the passage of the Fair Share Amendment in November.

## MCAS Moratorium and Changes to High-Stakes Testing

An Act expanding opportunities to demonstrate academic achievement would eliminate the high-stakes nature of the Massachusetts Comprehensive Assessment System (MCAS) and promote alternative assessment methods. *We support bills* **S 293** and **H 612** because:

- Students will have several pathways to demonstrate that they have met the mastery standard for competency determination, including passing a standardized test.
- Providing alternative pathways for special needs students to graduate.
- Including parent, student and educator surveys in the evaluation process.
- Creating the opportunity to expand the school curriculum and focus on teaching not testing.

### **Confronting Racism & Privilege**

The union has placed a priority on confronting racism and white privilege in our schools, union, and community. Our union created Belmont Educators of Color and Allies, with a mission to Educate, Advocate, and Eliminate Racism. The group aims to educate themselves and others about the history of racism, advocate to create supportive relationships, and dismantle racism in our schools. Last year we also partnered with the BPS to establish school and district Equity Teams that meet once a month to discuss issues of equity, diversity and inclusion.

How have you supported diversity within BPS or elsewhere and how would you work to eliminate racism in our schools?

\_\_I have two sons at Belmont High School, and opened a business in Belmont (Jamaica Jeff's)

where I hired Belmont High School students to give them training, work experience,

opportunities to earn money, engage in the community, etc. I hired many students, with a focus on diversity (representing different gender, race, sexual orientation, religion, etc). These amazing kids were the servers, the actual definition of a community oriented business. I also held fund raisers and supported/sponsored various school activities, organizations and sports teams by giving monetary donations and allowing them to use the business space for their specific needs. Eliminating racism in schools should be a top priority, of course, and combining resources, education, and participation is key to achieving that goal.

## **Promoting Belmont Public Schools**

What are your specific plans for promoting public education in Belmont?

\_\_I've seen my sons thrive in Belmont public education through Wellington, Chenery, and now Belmont High School. The success of Belmont public schools should be a number 1 priority for our community. Achieving that goal means focusing resources, infrastructure, and support toward every aspect of education (teachers, administrators, facilities, activities for the kids, inclusion, mental and physical health, and opportunities for advancement, to name a few).
