Introduction





Five years ago John Lewis passed away from pancreatic cancer. He did so much to promote civil rights and justice in the USA. Here is a bit of what Heather Cox Richardson wrote today.

"Before Representative Lewis died, reporter Jonathan Capehart asked him "what he would say to people who feel as though they have already been giving it their all but nothing seems to change." Lewis answered: "You must be able and prepared to give until you cannot give any more. We must use our time and our space on this little planet that we call Earth to make a lasting contribution, to leave it a little better than we found it, and now that need is greater than ever before."
"Do not get lost in a sea of despair," Lewis tweeted almost exactly a year before his death. "Do not become bitter or hostile. Be hopeful, be optimistic. Never, ever b

afraid to make some noise and get in good trouble, necessary trouble. We will find a way to make a way out of no way."

Today, as the storm over the release of the Epstein files became a maelstrom, the American people rallied at more than 1,500 sites nationwide to protest the Trump administration in a day of action to honor Representative Lewis. Organizers of the "Good Trouble Lives On" day of action vowed to "take to the streets, courthouses, and community spaces to carry forward his fight for justice, voting rights, and dignity for all."

"My philosophy is very simple," Representative Lewis once told an audience. "When you see something that is not right, not fair, not just, say something! Do something! Get in trouble, good trouble, necessary trouble."

Some platforms are grassroots-backed and about real advocacy that actively try to pressure decision-makers, such as ACLU, Action Network, MoveOn, EarthJustice, and Common Cause campaigns.

Other platforms are about list-building; gathering supporters' contact info for campaigns, fundraising, and outreach, such as with Civic Shout, Care2, and similar sites.

Action Network is a platform: its impact depends on how groups use it.



American service members are obliged to refuse orders they believe unlawful. Articles 90 and 92 of the Uniform Code of Military Justice require service members to obey only lawful orders. To compel obedience, it must have a valid military purpose, be clear and specific, and not conflict with statutory or constitutional rights. The Manual for Courts-Martial states that an order can be presumed unlawful if it is patently illegal, such as directing unconstitutional acts against American citizens.

'The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people.- https://www.archives.gov/founding-docs/bill-of-rights-transcript

By deploying troops without state consent, the President is overriding state sovereignty, undermining federal law and defying the foundational documents of the Republic.

If a governor objects to federalization, the burden is on the President to demonstrate, legally and constitutionally, why that state's authority should be suspended over its affairs of public safety. The federal government must prove its case. Absent a collapse in law and order, the Insurrection Act cannot be used to mask political motives or suppress lawful protest.

The President's use of the military in contravention of the Tenth Amendment is a direct assault on the structural integrity of the Union, a raw power grab, leading to the slow unraveling of the Republic. If authoritarian practices are unchallenged and become normalized, autocracy will transit to fascism, unless the federal courts, and ultimately, the U.S. Supreme Court intervenes quickly. ...Let us not mistake constitutional governance for regime behavior." (Dennis Kucinich, The Kucinich Report)

Immigrant/Deportation Rights

Pursuant to Amendment XIV of the U.S. Constitution https://www.archives.gov/milestone-documents/14th-amendment, no State shall "deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws." Pursuant to Article I, Section 9, "The Privilege of the Writ of Habeas Corpus shall not be suspended, unless when in Cases of Rebellion or Invasion the public Safety may require it." https://www.archives.gov/founding-docs/constitution-transcript

Do this if ICE knocks on your door.

All individuals in the U.S. have constitutional rights. That's the law, regardless of whether or not they are being followed. To preserve your rights:

- 1. If ICE comes to your home, you do not have to open the door.
 If ICE does not produce a judicial warrant, which is a warrant signed by a judge, you definitely do not need to open the door. Ice Warrants are usually administrative warrants, which do not give them the authority to enter your home without your consent. So if ICE comes to your door, ask them to slide the warrant under the door. You need to review the warrant to make sure that it's a judicial warrant signed by a judge and not an administrative warrant signed by an ICE officer.
- 2. If you wish to speak to ICE, you still do not need to open the door. You can speak to them through the door.
- 3. If they force entry, you still do not have to answer any questions. You can invoke your right to remain silent until you speak to your attorney. You can tell them you do not wish to answer any questions without your attorney present, because you do have the right to remain silent. You do not have to show them any identity documents that would give any information about where you come from.

Regarding SNAP

Al Overview: There have been proposed and current efforts to get rid of or significantly reduce SNAP,

primarily from the Project 2025 plan and a federal government shutdown in November 2025. Proposed changes include stricter work requirements, ending categorical eligibility, and altering benefit calculations.

The November 2025 government shutdown has caused a temporary suspension or delay of benefits, but this is a result of the shutdown, not a permanent change to the program.

Proposed changes in Project 2025

- Work requirements: Increase the work requirements for able-bodied adults without dependents.

 Categorical eligibility: Eliminate "categorical eligibility," which would prevent states from expanding eligibility based on gross income and assets.
- Benefit formula: Roll back updates to the Thrifty Food Plan (TFP), which determines benefit levels.
- Overall scope: Some provisions suggest moving SNAP funding to
- the Department of Health and Human Services (HHS) to move all means-tested programs into one department.

Current impact of the November 2025 government shutdown

- Benefit suspension/delays: Due to a federal government shutdown, the <u>USDA</u> has temporarily suspended the funding and issuance of November 2025 SNAP benefits.
- Partial payments: The administration has indicated it will likely only be able to make partial payments and that it is unclear when even reduced benefits will be distributed, <u>says</u> The New York Times.
- Retroactive payments: Benefits that are missed due to the shutdown are expected to be issued retroactively once funding is restored, says a US House Representative's office.
- Continued processing: Despite the suspension of benefit payments, state agencies are still accepting and processing new applications and reported changes.

Other potential changes

- One Big Beautiful Bill Act: A Republican-backed bill enacted in 2025 includes cuts to SNAP, such as ending funding for the SNAP-ED program, changing how states are funded for administrative costs,
 - and permanently freezing the cost of the TFP, <u>reports the Center on</u> <u>Budget and Policy Priorities</u>.
- Shift in funding responsibility: This bill also shifts a portion of the financial burden of SNAP benefits onto states, which could lead to some states eventually leaving the program.

In its 2024 Donald J. Trump v. United States decision, the Supreme Court majority held that a former president has "absolute immunity from criminal prosecution for actions within his conclusive and preclusive constitutional authority," as well as "presumptive immunity from prosecution for all his official acts."

Specifically, in Trump v. United States, 603 U.S. 593 (2024), the Supreme Court held that a former president is entitled to absolute immunity from criminal prosecution for acts that fall within his "core constitutional powers." However, the Court was explicit that this immunity is not unlimited. Immunity exists to protect the presidency as an institution, not to exempt presidents from law. The president must still obey the Constitution. If the president acts outside constitutional authority, there's no immunity.

Trump is not only *not* abiding by Constitutional law, but is acting unlawfully, abusing his power to give himself the powers of a KING, and abusing his immunity. In addition to Congress pursuing impeachment, the **No Kings Act** would REVERSE the Supreme Court's immunity decision and punish Trump to the fullest extent of the LAW.

The Purpose of the No Kings Act: To affirm that the president is subject to the same laws as every other citizen — both while in and after leaving office.

The Act aims to:

Clarify that no current or former president has absolute immunity from criminal investigation or prosecution.

Reinforce that the Constitution does not shield unlawful or self-interested conduct.

Ensure Congressional oversight and judicial review could still check presidential abuses.

The Supreme Court ruling on presidential immunity said that the president has broad immunity for official acts within the scope of being the president. Disobeying the law is not a presidential act, in fact it's the opposite, as the president is sworn to uphold the law. Further, presidential immunity does not prevent Congress from pursuing impeachment for presidential misconduct.





Commentary

It is evident that Democrats fear a fascist dictatorship, void of Constitutional checks and balances, the Constitutional rule of law, civil rights protections, social and environmental justice, and true representation of We, the People.

Likewise, it is evident that Republicans fear a socialist dictatorship, void of the protection of our civil rights and freedoms and of consent-based self-governance promised in the Declaration of Independence.

 - overturn such unconscionable Supreme Court rulings as Citizens United (https://www.movetoamend.org/motion)
 - submit a Bill requiring all members of all three (3) Branches of Government and appointed Secretaries of Departments to pass an exam demonstrating that they have read and

understand the 1787 U.S. Constitution as well as the 1776 Declaration of Independence before taking their Oaths of Office!

- hold government officials accountable for not abiding by their Oath of Office!

- (3) declare the causes which impel them to the separation.

It seems that the federal government and ICE do not respect the Constitutional rule of law, - such as state sovereignty pursuant to the Tenth Amendment, as well as the right to due process pursuant to the 14th Amendment, and habeas corpus pursuant to Article I, Section 9 of the U.S. Constitution, - to which government officials, including the executive power, made an oath.
- The Trump administration pursued an unconstitutional act of war with Iran in violation of Article I of the U.S. Constitution which grants Congress exclusive authority to declare war; in violation of Congress's role in warmaking under the War Powers Resolution; in violation of international sovereignty and the principles of the UN Charter. Both U.S. law and the UN Charter permit military force only in self-defense against an *imminent* threat. The June 2025 strikes arguably failed the imminent threat test under Article 51 of the UN Charter and U.S. domestic law. Preemptive or preventive strikes—without clear evidence of an upcoming attack—are illegal.

Consider that for the past 2000 years, we were to learn the Golden Rule, "Do unto others as you would have them do unto you." We must now learn, "We ARE thy neighbor, we ARE Earth Mother, All is One".

The final statement: "There must be a return of the talking stick to the Grandmothers. We must all now revert to the universal law 101, which runs through the ancestral veins of all of (us). The warrior class of men are not equipped to make determinations right now...we are too caught up in...bad dreaming. Take the knee to (our) Grandmothers. Take the knee. We must resurrect the eternal Mother"!

This is in keeping with the role of women in the Iroquois Confederacy, which has a strong matrilineal system whereby the Iroquois women have considerable influence in governance, culture, and social structure. While men hold formal political power as sachems (chiefs), each clan has a Clan Mother, who retains the authority to nominate, hold in office, and even remove chiefs who represent their clans in the Grand Council. Chiefs are expected to act in the best interests of their people and are accountable to the Clan Mothers who select them. The Clan Mothers in the Iroquois system of governance have the power and authority to hold accountable and remove chiefs who are not fulfilling their duties effectively, by offering the chief warnings and counsel, removing his authority if necessary, and selecting a replacement. This is a crucial element of the Iroquois governance structure, ensuring accountability and prioritizing the community's well-being.
