1. Introduction
Starseed LLC ("we", "our", or "us") values your privacy and is committed to handling your personal information responsibly. 2. Information We Collect
We collect two types of data:
(A) Personally Identifiable Information (PII) – only when you voluntarily provide it, and
(B) Non-personal / Platform data – automatically accessed through Meta's platform.
A. Personally Identifiable Information (Collected Voluntarily)

We only collect PII if you directly provide it to us, for example, when contacting support. This may include:

- Your name (if included in your email)
- Your email address
- Your Meta Quest username or User ID (if you include it)
- Any information you submit via feedback or support forms

B. Data Accessed via Meta Platform (Non-PII)

To function properly, the Game accesses the following data via Meta's platform APIs (per the Meta Data Use Policy):

- Oculus ID or Platform User ID
- In-game user-generated content (e.g., avatar name)
- VR motion data and controller input (for gameplay interaction)
- Headset and device information (e.g., model, firmware version, crash logs)

Aggregated gameplay analytics (e.g., time spent, feature usage)

We may share limited data:

- With Meta (e.g., for crash diagnostics or platform-level services)
- With secure third-party providers (e.g., hosting, analytics)
- When legally required (e.g., lawful subpoenas or to ensure user safety)

All shared data is minimized, secure, and governed by confidentiality agreements where required.

5. Data Security

We implement industry-standard technical and organizational measures to protect your data. However, no system is 100% secure.

6. Data Retention and Deletion
We retain personal data only as long as necessary for the purposes outlined.
