

PocketFurry's Terms of Service

By paying you accept the terms of service

The basics:

- No personal or commercial artworks may be used, sold, "minted", etc through any crypto, NFT or Web3 services or projects.
- Artworks may not be altered to change the nature of the piece or misrepresent the kind of work I offer (example: altering SFW artwork to make them NSFW, adding hateful imagery to my artwork, etc) and signatures of full works must remain intact.
- I retain the right to refuse commissions for any reason.
- Artwork is digital only so will only be delivered this way.
- Since this is a digital artwork the customer understands that there is no need for a physical product to be delivered.
- If the customer requires a specific size this must be specified at the start of the process.
- Customers must own the characters or have permission to use them.
- Customers will receive their digital product through their preferred digital method (via: Email, Twitter, WeTransfer)
- Customer must be +18 to order a commission
- I retain the final decision on the HEX Color Code used on the digital artwork (Guidance will be followed from given references, but no nitpicking with HEX Color Code will be accepted).

Use of Personal Artwork:

- Commissions priced are for personal use only and are not to be used or altered for commercial means or to be physically mass produced.
- You are free to post your commissions publicly to your own personal galleries, social networks and collections or have the artwork appear on your own personal items. If you need artwork which you are intending to distribute in multiples or use directly or indirectly for profit, please contact me for a commercial Pricing quote.

Rights to the artwork:

- You retain all applicable rights to your IP, Characters.
- I retain all commercial rights to the works I create which includes the right to redistribute, promote and profit, as well as any rights afforded by Copyright Law.
- Should you want additional rights or licenses to the works, or wish to have your commission remain private, please contact me for a price quote.

Payment:

- Payment is done upfront being requested, these are made via PayPal.
- Prices are in USD.
- Do not send payment if it has not been requested or if commission hasn't been accepted yet.
- THERE IS NO REFUND AFTER THE SKETCH HAS BEEN APPROVED.
- Extra charge might happen if a customer requests **too** many changes (Customer will be notified when said charge will be applied).
- Payment covers the hours of work I take to finish the picture.

Workflow:

- Sketching → Line art → Coloring → Finished Illustration.
- Changes and corrections must be made before line art phase, once the Coloring process starts, changes in the illustration might be subject to extra charges.
- I will not do changes to finished work (some exceptions may apply, ask).

Deadlines:

- To have work delivered as fast as possible, the client must be in constant contact with me.
- Work must be delivered between 5 to 101 business days.

References:

- Customer must have visual references for their characters (Even if they do not have a reference sheet their character must be fully visible on the files provided)
- In case you do not own visual references, detailed text descriptions, and some visual assistance will be required.
- If the need for extra design is required such as clothing or complex props these might be subject to extra charge.

- Explicit NSFW content or extreme kinks.
- Hateful or disrespectful content.
- Religious or Political themes
- Won't copy / attempt to replicate other artist's work if requested
