Notice regarding appointment of Vice-Chancellor of the Deemed to be University

The Deccan College Post-Graduate and Research Institute is a Deemed to be University under Section 3 of the University Grants Commission Act, 1956. The Deccan College was established on 6 October 1821 and was given the status of Post-Graduate and Research Institute on 17th August 1939. It was declared as Deemed to be University in 1990 and started functioning as Deemed to be University from June 1994. The University has three academic Departments, namely, Ancient Indian History, Culture and Archaeology, Linguistics and Sanskrit and Lexicography, a well-equipped library and a large 115 acres campus. The Deemed to be University is known all over the world for its quality teaching and research in the field of Heritage Studies.

The University is going for the appointment of Vice-Chancellor, who shall be a whole-time salaried officer of the Deemed to be University. Salary and other allowances from time to time are applicable as per the rules of the State Government of Maharashtra (S-30; 144200-218200). The Chancellor of the University shall appoint Vice-Chancellor out of a panel of three names to be recommended by the Search-cum-Selection Committee, which has been constituted as per the provisions made in the rule 23.B.(3) UGC (Institutions Deemed to be Universities) Regulations, 2023. The Vice-Chancellor shall hold office for a term of five years from the date of assuming the office. The person to be appointed as Vice-Chancellor in no case shall hold the office beyond the age of 70 years (cf. UGC Institutions Deemed to be Universities Regulations, 2023). The term of the office of the Vice-Chancellor shall form part of the service period of the incumbent concerned making him/her eligible for all service related benefits.

A person of the highest level of competence, integrity, moral and institutional commitment is to be appointed as Vice-Chancellor. He/she should be a distinguished academician (preferably in the field of Ancient Indian History, Culture and Archaeology or Linguistics or Sanskrit and Lexicography) with a minimum of ten years of experience as Professor in a University system or ten years of experience in an equivalent position in reputed research and/ or academic organization.

While preparing the panel, the Search-cum-Selection Committee will give proper weightage to academic excellence, exposure to higher education system in the country and abroad and adequate experience in academic and administrative governance.

Any eminent personality in the field of education meeting the above parameters and having high academic achievements to his/her credit, clean service record and also possessing administrative ability to provide leadership to the University may forward his/her application to the

undersigned within 30 days after the publication of the advertisement. The applicant should not have reached the age of 65 years on 16th September 2024.
