(1) That **DOUG ELMSLIE between the 16th day of November in the year of 2022 and the 16th day of August in the year of 2024 at the City of Kawartha lakes in the said Region**, with the acting mayor, city councillors and senior city employees engaged in private council chambers, conduct meetings to form an intention in common to carry out an unlawful purpose and assisted each other therein and they carried out an unlawful purpose and assisted each other, each of them knew or ought to have known, that the commission of the offence would be a probable consequence of carrying out the common purpose is a party to that offence as set out in contrary to section 21 (1) and (2) of the Criminal Code of Canada. William Denby knows this to be true, due to being informed by councillor Ron Ashmore.

(2) AND FURTHER that **DOUG ELMSLIE between the 5th day of March in the year of 2024 and the 16th day of August in the year of 2024 at the City of Kawartha lakes in the said Region**, without lawful authority, with the acting mayor, city councillors and senior city employees engaged in private council chambers, conduct meetings knowing that William Denby was being harassed, caused him to fear for his safety, by repeatedly following him from place to place, and watching his dwelling house, and directing threatening conduct at him at City Hall, contrary to Section 264(1)and(2) of the Criminal Code. William Denby knows this to be true, due to being informed by councillor Ron Ashmore.

(3) AND FURTHER that **DOUG ELMSLIE between the 5th day of March in the year of 2024 and the 16th day of August in the year of 2024 at the City of Kawartha lakes in the said Region**, as a public officer, without lawful authority, with the acting mayor, city councillors and senior city employees engaged in private council chambers, committed breach of trust in connection with the duties of their office by not responding to where the hundreds of Millions of Tax Payers money have gone, contrary to Section 122 of the Criminal Code. William Denby knows this to be true, due to being informed by councillor Ron Ashmore.

(4) AND FURTHER that **DOUG ELMSLIE between the 16th day of November in the year of 2022 and the 16th day of August in the year of 2024 at the City of Kawartha lakes in the said Region**, without lawful excuse, with the acting mayor, city councillors and senior city employees engaged in private council chambers, contravened an Act of Parliament by intentionally omitted to do

something that it requires to be done contrary to Section 126(1) of the Criminal Code. William Denby knows this to be true, due to being informed by councillor Ron Ashmore.

(5) AND FURTHER that **DOUG ELMSLIE between the 16th day of November in the year of 2022 and the 16th day of August in the year of 2024 at the City of Kawartha lakes in the said Region**, with the acting mayor, city councillors and senior city employees engaged in private council chambers, intent to mislead, fabricated evidence with intent that it shall be used as evidence in a judicial proceeding, contrary to Section 137 of the Criminal Code. William Denby knows this to be true, due to being informed by councillor Ron Ashmore.

(6) AND FURTHER that **DOUG ELMSLIE between the 16th day of November in the year of 2022 and the 16th day of August in the year of 2024 at the City of Kawartha lakes in the said Region**, with the acting mayor, city councillors and senior city employees engaged in private council chambers, obstructed justice as they wilfully attempted to obstruct, pervert or defeat the course of justice who in a judicial proceeding, attempted to dissuade a person by threats, from giving evidence, contrary to Section 139(3) of the Criminal Code. William Denby knows this to be true, due to being informed by councillor Ron Ashmore.

(7) AND FURTHER that **DOUG ELMSLIE between the 16th day of November in the year of 2022 and the 16th day of August in the year of 2024 at the City of Kawartha lakes in the said Region**, with the acting mayor, city councillors and senior city employees engaged in private council chambers, are guilty of committing a common nuisance by endangering the life of William and his family and his band council members and caused physical injury to William Denby contrary to Section 180(1) of the Criminal Code. William Denby knows this to be true, due to being informed by councillor Ron Ashmore.

(8) AND FURTHER that **DOUG ELMSLIE between the 16th day of November in the year of 2022 and the 16th day of August in the year of 2024 at the City of Kawartha lakes in the said Region**, with the acting mayor, city councillors and senior city employees engaged in private council chambers, are criminally negligent by doing things and omitting things that is there duty to do, showing wanton and reckless disregard for the lives or safety of other persons, contrary to Section 219(1) of the Criminal Code. William Denby knows this to be true, due to being informed by councillor Ron Ashmore.

(9) AND FURTHER that **DOUG ELMSLIE between the 16th day of November in the year of 2022 and the 16th day of August in the year of 2024 at the City of Kawartha lakes in the said Region**, with the acting mayor, city councillors and senior city employees engaged in private council chambers, attempted to commit murder contrary to Section 239(1)(b) of the Criminal Code. William Denby knows this to be true, due to being informed by councillor Ron Ashmore.

(10) AND FURTHER that **DOUG ELMSLIE between the 5th day of March in the year of 2024 and the 16th day of August in the year of 2024 at the City of Kawartha lakes in the said Region**, being a trustee for a public purpose, converted with intent to defraud and in contravention of their trust, to a use that is not authorized by the trust, the with the acting mayor, city councillors and senior city employees engaged in private council chambers, committed Criminal breach of trust by refusing to produce documentation as to where are the hundreds of Millions of Tax Payers money have gone, contrary to Section 336 of the Criminal Code. William Denby knows this to be true, due to being informed by councillor Ron Ashmore.

(11) AND FURTHER that **DOUG ELMSLIE between the 5th day of March in the year of 2024 and the 16th day of August in the year of 2024 at the City of Kawartha lakes in the said Region**, being a trustee for a public purpose, converted with intent to defraud and in contravention of their trust, to a use that is not authorized by the trust, and along with the acting mayor, city councillors and senior city employees engaged in private council chambers, committed false pretense by falsifying environmental assessment study documentation, refusing to obtain proper archaeological studies, and illegally selling public properties which has never been documented, and never responding to William Denby's questions regarding this and questions regarding where the hundreds of Millions of Tax Payers money have gone, contrary to Section 362(1) of the Criminal Code. William Denby knows this to be true, due to being informed by councillor Ron Ashmore.

(12) AND FURTHER that **DOUG ELMSLIE between the 5th day of March in the year of 2024 and the 16th day of August in the year of 2024 at the City of Kawartha lakes in the said Region** with the acting mayor, city councillors and senior city employees engaged in private council chambers, wrongfully and without lawful authority, for the purpose of compelling William Denby and his band members to abstain from doing anything that he and they has a lawful right to do, or to do anything that he and they have a lawful right to abstain from doing, hid property owned or used by William Denby, and deprived him of the use of them, contrary to Section 423(1)d of the Criminal Code. William Denby knows this to be true, due to being informed by councillor Ron Ashmore.

(13) AND FURTHER that **DOUG ELMSLIE between the 5th day of March in the year of 2024 and the 16th day of August in the year of 2024 at the City of Kawartha lakes in the said Region**, along with the acting mayor, city councillors and senior city employees engaged in private council chambers, conspired to cause William Denby to be murdered, and they conspired to prosecute him for

fabricated offences, knowing that he did not commit those offences, and they conspired to commit indictable offences and they conspired to commit offences punishable on summary conviction, contrary to Section 465(1)(a) (b)(c) and (d) of the Criminal Code. William Denby knows this to be true, due to being informed by councillor Ron Ashmore.
