The refusal of the Personal Data Subject to provide the Operator with the following categories of data: *first name, last name, patronymic, phone number, e-mail* address leads to the impossibility of concluding and executing an agreement between the Operator and the Personal Data Subject in electronic form. In this connection, the Operator, if the Personal data Subject refuses to provide the specified categories of personal data, has the right to refuse the Personal Data Subject to conclude and execute the contract.
