Course evaluation

- The THS system, not on canvas for PhD students. This is hard for PhD courses since the number of students is low. If this gets discontinued, then the PhD students won't have a way to report. There are also inconsistent repetition of the courses.

Third cycle courses

- The professors do not get funding (even from FoFu) so they mostly have it as an add-on to the master level course. That is why there is less incentive to give these courses. The discussion will focus on if third-cycle courses can get financial incentives.
