This grouping is a change from the original report. It reflects the discussions of the Steering review on November 7, 2022.

This new Group 2b consists of 92 SPs and 3 IdPs from 14 Participants.

- To minimize service interruption, we recommend not removing these entities'
  metadata from the InCommon aggregate at this time. These organizations are
  nevertheless required to conform to SIRTFI as part of Baseline Expectations
  incorporated into terms of service, and are subject to the dispute resolution process in
  case of actual performance inconsistent with SIRTFI.
- These entities remain out of compliance with BE2 as originally formulated. InCommon will continue to reach out via alternate means to get organizations to update the SPs' metadata.
- NOTE: Any attempts to publish changes to these metadata will require acknowledgement of SIRTFI conformance, *i.e.*, the metadata in this state is "frozen" unless it is removed or the organization updates to acknowledge SIRTFI conformance.
