Topics

Officials Database Update

- New database created for tracking officials (judges, TDs, chief of comps)
- Divisions asked to review and ensure information is complete and accurate
- Database includes contact info, license levels, clinics attended
- Useful for finding officials across divisions when needed

TD Training and Updates

- International TD training offered at high-level events (e.g. World Cup in Finland)
- Multi-day program with proctors training on all aspects
- Domestic TD training calls held annually for new and returning TDs
- 100% of TD reports received this year with mostly positive feedback

Judge Recruitment and Training

- Urgent need to recruit more judges, especially at higher levels
- Proposal to formalize judge recruitment initiative:
 - Each current judge challenged to recruit one new person
 - Division directors asked to recruit one judge each
 - Track progress and identify barriers
- Judge clinics scheduled:

Lake Placid: September 26-28

o Calgary: October 17-19

o Online webinars: October 10-12

Dual Mogul Seeding Proposal

- New proposal to align U.S. events with FIS practices:
 - Seed using combination of mogul event results and ranking list
 - Addresses issues with "bracket busters" due to scheduling conflicts/injuries
- Mogul subcommittee approved; Rules & Officials to review rewritten version
- Committee to finalize wording and vote within 48 hours



Comp Guide Update

- Annual process to align U.S. rules with FIS exceptions
- Call for volunteers to help review and compare manuals
- Ensure final FIS rules are incorporated before publishing

Officials Education Initiative

- Plans to develop nationwide U.S. education program for judges and TDs
- Aim for more consistency in event formats and approaches across divisions
- Details to be worked out in coming months

New Business

Nationwide program for continuing education for officials and Judges.

Next Steps

- Thomas to send out rewritten dual mogul seeding proposal for R&O review (48-hour deadline)
- All divisions to review and update officials database
- Formalize judge recruitment initiative and track progress
- Begin development of nationwide officials education program
- Volunteers needed for annual comp guide update
