FOSTERING HOPE IN THE CHAOS OF REENTRY

New to reentry or need to know why reentry is so hard? Join Assistant Deputy Director for the Office of Reentry, Dr. Roxanne Coey, and special guests for this session that breaks

Looking for opportunities, resources and partners to support families facing reentry? In this session, Director Dent offers an update on policy changes and practices that makes it easier for parents to reconnect with their families. She provides connections for case management support and local parenting classes through local collaborative partners. Finally, Director Dent outlines opportunities for coalitions and communities to increase their ability to serve returning parents and families relationally through a greater understanding of the impact of reentry on family systems.

Pathways to Hope through the Juvenile Detention Alternatives Initiative (JDAI) 101

Did you know that a youth as young as 10 years old can be detained in an Ohio juvenile detention facility? And, that spending even one night in a secure detention facility can interrupt school, employment, family and community connections, which seriously damage a youth's prospects for future success? Recognizing these dangers, Ohio became a state-supported JDAI site in 2010. Despite popular perception, most youth detained in Ohio's detention facilities prior to Ohio's JDAI were not violent juvenile offenders. Ohio's data showed that most juvenile offenders were securely detained for technical violations and most juveniles detained were African-American males and other minority youth. Join Brittany Neal with the Department of Youth Services to learn how you can collaborate with your local justice professionals to develop just and equitable treatment of all youth.

COMMUNAL LAMENT AS A HOPEFUL PRACTICE FOR REPAIR AND HEALING.

A community cannot thrive when its members can't. At the end of the day, crime and incarceration leave pain, grief, sorrow, and suffering in their wake. If left in any of these negative affects and emotions without pathways toward healing and wholeness,

research shows that humans become unwell. Lament is to express sadness and/or regret about something. This session unpacks the importance of lament as a pathway for healing and provides perspectives and tools for creating environments where people can unload their soul-deep emotions and pick up practices that foster resilience and wholeness

OFFERING HOPE TO NEIGHBORS RETURNING WITH DISABILITIES

Medicaid statistics show that incarcerated persons have higher rates of mental illness, substance use disorder, and chronic and other physical health care needs than non-justice involved citizens. In addition, citizens with visible and invisible disabilities are twice as likely to experience violent crimes according to the US Department of Justice. Furthermore, crime victimization can result in a number of disabilities including physical damage, neurological changes, and substance abuse. Join Mallory Pitts from Opportunities for Ohioans with Disabilities (OOD) to learn about OOD's services that support justice-involved persons, including those with mental health diagnosis and substance abuse disorder in addition to other disability classifications. This session provides information and local connections vital to strengthening the reentry continuum of care. This session fills in disability service gaps encountered by coalition leaders, members, and collaborative partners and experienced by those who need extra support to successfully thrive.

A New Service Option for Record Sealing and Expungement

Opportunity Port is a record sealing and expungement application assistance program offered to all Ohio residents with criminal records in the state of Ohio. The program is free and provides limited-scope legal assistance with determining eligibility for sealing and/or expungement and completing applications for submission to Ohio courts. The only requirements to participate are that the interested applicant be a resident of the state of Ohio, have criminal records in the state of Ohio, and have a working phone number and email address, as services are delivered over the phone and electronically.
