WHIPPET PET PUPPY PURCHASE AGREEMENT

This Whippet Puppy Purchase Agreement (the "Agreement") is entered into as of _____ by
and between James and Nicole Lodi ("Breeder"), and
_____ ("Buyer") collectively referred to as the "Parties."

RECITALS

WHEREAS, Breeder has bred a litter of Whippet puppies (the "Puppies");

WHEREAS, Buyer desires to purchase one of the Whippet puppies from Breeder;

WHEREAS, Breeder wants to ensure that the puppy is going to a good home, and the new owner will take excellent care of their puppy.

NOW, THEREFORE, in consideration of the mutual promises, covenants, and agreements contained herein, the Parties agree as follows:

PUPPY. Breeder agrees to sell to Buyer a Whippet puppy:

The purchase price for the puppy is _____ (the "Purchase Price"), which is payable by Buyer to Breeder at the time of signing this Agreement.

SPAY/NEUTER. Buyer agrees to spay/neuter the puppy by the age of 24 months. Buyer shall provide Breeder with documentation from a licensed veterinarian verifying that the procedure has been completed. Buyer agrees that failure to comply with this provision will constitute a material breach of this Agreement and may result in forfeiture of the puppy, as well as any deposits paid.

SURRENDER. In the event that Buyer is no longer able to care for the puppy, Buyer agrees to surrender the puppy back to Breeder. Breeder will take the puppy back at any time, regardless of the reason. Buyer shall not transfer ownership or possession of the puppy to any third party without the prior written consent of Breeder.

CARE. Buyer agrees to take excellent care of the puppy, providing appropriate food, water, exercise, and medical care, including annual veterinary checkups, vaccinations, and preventative care.

HEALTH GUARANTEE. Breeder guarantees that the puppy is in good health and has been examined by a licensed veterinarian prior to the sale. Buyer shall have the puppy examined by a licensed veterinarian within 14 days of the date of purchase.

VACCINATIONS AND DEWORMING. The puppy has received age-appropriate vaccinations and deworming. Buyer agrees to continue the puppy's vaccination and deworming schedule as recommended by a licensed veterinarian.

TRANSFER OF OWNERSHIP. Upon receipt of the Purchase Price, Breeder shall transfer ownership of the puppy to Buyer. Buyer shall be responsible for all expenses incurred after the transfer of ownership, including but not limited to, veterinary care, food, and shelter.

DISPUTE RESOLUTION. In the event of any dispute arising under this Agreement, the Parties agree to resolve the dispute through mediation before pursuing any legal action.

GOVERNING LAW. This Agreement shall be governed by and construed in accordance with the laws of the state of Indiana, without giving effect to its conflict of laws provisions.

ENTIRE AGREEMENT. This Agreement constitutes the entire understanding and agreement of the Parties with respect to the subject matter hereof and supersedes all prior negotiations, understandings, and agreements between the Parties, whether written or oral.
