Mission Statement

Inspired Theater Company strives for excellence as we create theater for all, bringing family values, integrity, patriotism and community together while using our talents given to us by God our Creator.

Theater is a wonderful avenue for both expression and collaboration, and a successful production can only be accomplished by respecting both. Any behaviors not listed in this code of conduct that do not contribute to the spirit of respect, and community are discouraged.

This contract must be agreed upon and signed before participating in any Inspired Theater Company production. Failure to meet these expectations may result in being removed from the current production. Grace and forgiveness will be extended and participation in future productions will be encouraged.

Professionalism

Rehearsals will begin promptly at all times. In an effort to respect everyone's time, members are expected to be inside, with all materials necessary for practice, (scripts, pencil, water, shoes, costumes, props etc,) and ready to work by the posted rehearsal time.

All members must stay in the rehearsal space until excused by staff, and remain out of any other room or areas of the property without permission from staff.

Scheduling Conflicts and Refund Policy

We understand that scheduling conflicts happen. Please let staff know as soon as possible when a conflict arises. Because we work quickly to produce shows, missing even one required rehearsal can be difficult. Communication is key in the case of missed rehearsals and conflicts, please let staff know and we can try to accommodate schedules if possible. Missing multiple required rehearsals may lead to re-casting.

All tech week rehearsals are required. Missing a tech rehearsal will automatically remove you from the cast. All performances are required.

Refunds are not issued for cancellations or withdrawals after the first week of rehearsals, unless for medical reasons with a doctor's note. All withdrawals incur a \$25 administrative fee. If Inspired Theater Company cancels a production for any reason, refunds will be issued in full (does not include individual rehearsals or performances). Audition fees are non-refundable after the audition and for "no-shows." Although Inspired Theater Company cannot guarantee the number of performances, a minimum number of performances will be committed for each production. Kids production commitment: 1 show. Youth/Adult production commitment: 2 shows.

Summer programs do not offer any refunds, once registration is complete. If you are unable to attend the program, your tuition may be applied to a similar program in the same summer, providing there is room in the cast.

Ticket Refunds

Ticket refunds for any canceled performance will be issued in full. Exchanges may be issued if possible but are not guaranteed.

Staff Contact

Inspired Theater Company staff members will communicate with members, parents and students using our facebook page, email and text messages. All staff will include a parent any time they need to message or email a minor. At no time will there be private messages between staff and minors. This policy is in place to protect the integrity of all involved.

Clothing

Theater is physically active, in our mission to make theater comfortable for all and to uphold family values, all the below points must be met when dancing/moving/active etc.

- Athletic clothing should allow full range of movement without being overly revealing or suggestive.
- Shorts must be fingertip length or longer, tights are suggested under shorts for dancing purposes.
- No crop tops.
- Tank top straps must be 2 finger width, and no low cut shirts.
- Undergarments must not show, even when dancing or active.
- Proper shoes should be worn, no flip flops or bare feet unless directors give other instructions.

Language Code

As part of our mission to create theater for all, including families and small children, there is a language code all members of Inspired Theater Company must respect.

Cursing, coarse joking, harassment, or using The Lord's name in vain will not be tolerated. All members are encouraged to lift one another up, using kind and encouraging language.

Costumes, Props, etc

Respect for the items that are available for us to use, or borrow, and the spaces where we are meeting is imperative. Costumes or props provided by a member will be returned to the member after production has ended. Please fill out the form provided when bringing props, costume pieces, etc to be borrowed. Any items that do not come with the accompanied form will be considered donated to Inspired Theater Company and will be added to the prop shop to be used for future productions.

It is expected that in accordance with our strive for a professional work space and excellent theater, that members do not touch costumes or props which do not belong to them.
