Thursday, August 22, 2024 9:00 A.M.

Meeting called to order at 9:00 A.M. by President Curtis.

Opening Remarks: President Schwartzman welcomed the Association membership to the new school year. Two new athletic directors, Nate Pelletier (Windham) and Spencer Allen (Portland), were welcomed to the SMAA.

Agenda Adjustments: Guardian Cap discussion was added to football

Announcements:

Biddeford: Fall athletic participation numbers are up significantly. Seeking first team boys' soccer games.

Bonny Eagle: SMAA Cross Country Relays next Wednesday at BE. Parking at both the High School and Middle School.

Cheverus: Football numbers have increased. No JV boys' soccer.

Deering: No JV girls' soccer.

Falmouth: no announcements

Gorham: Seeking first team soccer games and volleyball games.

Kennebunk: Field hockey numbers are low, prefer playing varsity field hockey games first and junior varsity games likely to be 7 v 7.

AD Advisory Meeting: no report

Technology, Ferriera: no report.

Classification, Schwartzman: The 2025-2026 is a reclassification year. The expectation is there will be some changes. The first classification meeting will be in

September. The number of basketball classes will be a major classification committee topic. This is the second year of the cooperative team cycle.

Officials Fees, LeGage: New fees for 2024-2025 are \$95 varsity officials and 50 cents/mi for travel.

Sports Medicine, Spear: The SM Committee recommends field hockey goggles but does not require googles. Masks will be required in 2024 for corners. There was a brief discussion of soccer mouth guards and the SMC's recommendation to the Interscholastic Management Committee. The IMC will consider next week the soccer mouth guard rule.

Fall Sports

There was a discussion of the use of Hudl for all varsity level games this Fall. President Schwartzman conducted a brief Hudl utilization survey. The discussion included sharing of game films for all activities, specifically soccer and field hockey.

Motion: To share all Hudl game films for all activities within the SMAA. Marshwood/Sanford. Motion approved 16-1-0.

Cheering, Lemelin: no report

Cross Country: The 2024 SMAA relays will be at Bonny Eagle.

Field Hockey, Ashley: Sue Weatherbie (SMAA Field Hockey Assignor) shared the following items: Saturdays are good make-up days, please notify her of changes to junior varsity game conditions. There will be no travel charged for preseason games. Please regularly double check your schedules. Two game balls required. Have an established penalty table. Corner masks are mandated. Teams playing without masks will forfeit. Coaches should not call officials for rule interpretations. 3:30 P.M. games are impossible, the earliest game time would be 3:45 P.M.

Football, Stevens and Buzzell: There was a discussion of Guardian Caps. The junior varsity football schedules will likely be adjusted as the season progresses. A first team football schedule survey will be sent out by Lance Johnson. Ben Garrett, SMAA Football Assignor, request to adjust the game schedule on two dates was discussed. Two member schools (randomly selected) - Gorham and Windham, will change their Friday night football games to another date.

Golf, Spear: There was a discussion of golf coaches meeting of last night. The SMAA Qualifier will be Monday, Oct 7th. Girls Qualifier will start at noon. The MPA Championship will be Friday, October 11th. Six people may be on your qualifying team. Players should project to be capable of breaking 90-95. Championship week will require golfers to miss two school days.

Soccer, Moore: First team soccer survey coming. A report from Dennis Crowe, SMAA Soccer Assignor, was shared. There was no preseason soccer coaches meeting.

Soccer officials will no longer report yellow cards. Red Cards will be reported.
