I am demanding justice for George Floyd, a man who was killed in cold blood which, might I add, was caught on tape. There is proof that these officers murdered someone. You need to call it what it is: MURDER. Firing the officers involved is not enough. Officer Dereck Chauvin #1087 is guilty of murder, and the three other officers, are accomplices to this hate crime which took someone's LIFE. George Floyd and his family deserve true justice.
