Barn Hunt LLC Rules can be obtained online in the form of a PDF file at barnhunt.com *Dogs are required to have a Barn Hunt Registration number to show in Barn Hunt. Register your dog online at: www.barnhunt.com. Allow at least 48 hours to receive a Barn Hunt number. Handlers are responsible for entering and writing legibly the correct Barn Hunt number for their dog on entry form. An incorrect number may result in any legs earned being forfeited.

Running Order

The running order will be emailed to all exhibitors after the actual number of entries is known for each class. If you do not receive an email by Wednesday night, please contact the trial secretary. Dogs will be run in height order if at all possible. Dogs being handled by the same person will be separated into different staged groups.

Height Divisions

Small – 13” and Under - Medium – 13.1” to 18” - Large - Over 18”

Awards

Ribbons will be awarded for first through fourth place in Novice, Open, Senior, and Master classes in each height division. Ribbons will be awarded for all qualifiers in the regular classes and the Instinct Test. A High In Class Award will be offered in Novice, Open, Senior, and Master classes. Title Ribbons will be awarded to all dogs earning a new title.

Exhibitor Information:

All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. There will be a \$50.00 fee for all returned checks.

No entries will be taken over the phone or through email. Make checks payable to Flint Creek Dogs Inc. Send entries & fees to the trial secretary.

No smoking in or near the buildings. Do not throw cigarettes on the ground! The safety of the dogs is our primary concern.

By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and / or children. Any exhibitor whose dog(s) and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, may be asked to leave the trial site. In that case, no refund of any fees paid will be made.

Dog Exercise Areas: Please pick up after your dog and dispose of waste in appropriate containers outside the building. Please be considerate about picking up after your dogs and leaving the grounds as you found them. Do not allow your dogs to pee on the buildings or the house! Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement per BHA regulations.

Collars and Leashes: Electronic collars and devices are not allowed on trial grounds. Head halters are not allowed on test grounds. At no time should dogs be tied out or otherwise left attached to something other than a human. Dogs may not be brought to the line in any disallowed collar. Dogs may not be brought to the line on flexi-leads. Approved collars include flat snap or buckle collars of solid construction and leather or nylon leads. Limited slip martingale collars are allowed. Single piece slip collars/leads are allowed. Harnesses, with the exception of head-halter types, are allowed. Dogs MUST run without a collar/harness. Dogs should be brought to the ring with collars/harnesses which can be easily and quickly removed and replaced. All dogs must be on leash at all times except when in the ring.

Refunds: Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee. No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee. Exhibitors are responsible for complete, accurate and legible information on entry forms; illegible or incomplete entries cannot be entered in the trial. Entry fees may be refunded after the closing date minus \$5.00 per run. Refunds must accompany a letter/email from your veterinarian.

Bitches in Season: Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run in panties at the end of their class. After the trial closes on October 10th, 2020, entry fees will not be refunded. *If bringing a bitch in season, please inform the trial committee prior to the trial, and you must inform all exhibitors at the judge's briefing.*

Loud/Disruptive Dogs: Dogs that are loud and disruptive may be asked to locate away from the rings and/or staged away from the other dogs getting ready to compete. Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found to do so by the judge and/or trial committee. Terrier sparring is not allowed on trial grounds. Any dog that is sick, injured or lame will be excused from the trial grounds. Please do not leave barking dogs unattended in your vehicle.

Trial Grounds: Grounds consist of the entire Flint Creek Farms (minus the residential yard and home). Please do not allow dogs to run off leash on the property.

Parking: Gravel Driveway

Food: There will not be food for sale at this event. There are many fast food restaurants within 10 minutes of the site. Food will be provided for workers.
