\*Individuals who have been granted parole for more than one year (after 8/22/96) but have had this designation less than 5 years AND individuals who have been granted parole for less than one year may also be eligible for VTTC, if they are preparing to file, or have filed an application for a U/T visa, or for asylum. NOTE: Changes to [VTTC](#) took effect 6/5/24. Additionally, individuals who no longer have *active* Ukrainian Parolee status and individuals who no longer have *active* Afghan Parole status may be eligible for VTTC if they are preparing to file, or have filed an application for a U visa, T visa, or an application for asylum. \*\*Individuals who no longer have *active* Venezuelan Parole status OR who are in their five year waiting period may be eligible for VTTC *if they can show that they are preparing to file, or have filed an application for a U visa, T visa, or an application for asylum*.
