Discussion

The discussion in the research article explains the results obtained from the research. The author compiles, analyzes, evaluates, interprets, and compares the latest findings with findings from existing research (minimum five references). Avoid repeating sentences from the introduction, methods, and results. The number of discussion paragraphs should be longer than the introduction. The consistency of the article, from the title to the discussion, must be considered. Research weaknesses and suggestions for further research development are described in this section.

Conclusion

The conclusion contains the answers to the research problem formulation. Conclusions and suggestions are written separately in sub-headings. The conclusion includes answers to research questions. Written in narrative form, not in numerical/ numbering form. Suggestions are given based on the research results.

The references must use primary sources such as journals and proceedings, as much as 80% and 20% secondary reference sources (books) published in the last

10 years. References are written in APA 6th Edition format. For example, writing can be done like this (Farihah & Nurani, 2017, p. 35).
