## METHODS

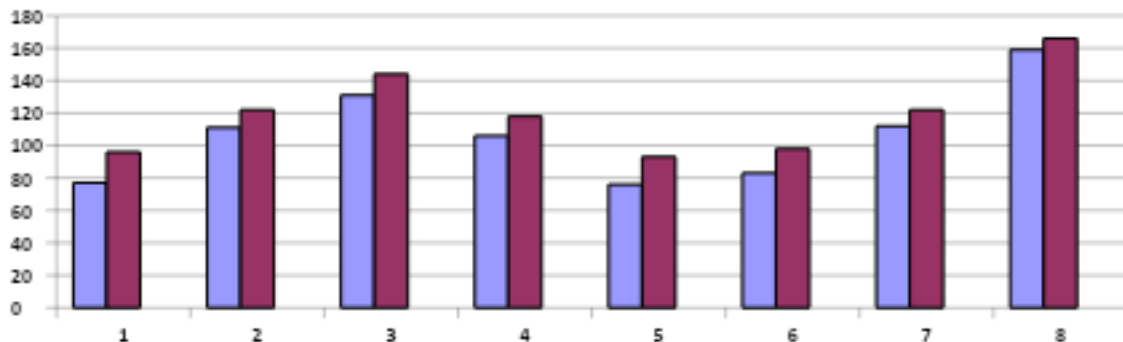
