PURPOSE OF REQUEST

The Linden Roselle Sewerage Authority is requesting proposals from qualified individuals and/or firms to provide Risk Management Consultant services of a specialized nature to the Authority as more particularly described herein. Proposals will be evaluated in accordance with the criteria set forth in the RFQ.

Respondents are expected to examine the RFQ with care and observe all its requirements. All questions about the meaning or intent of this document, all interpretations and clarifications considered necessary by the owner's representative in response to such comments and questions will be issued by Addenda posted to the website and mailed or delivered to all parties **recorded** as having received the RFQ package. Only comments and questions responded to by formal written Addenda will be binding. Oral interpretations, statements or clarifications are without legal effect.

LINDEN ROSELLE SEWERAGE AUTHORITY-DESCRIPTION

The Linden Roselle Sewerage Authority (“The Authority”) is a local public body created in 1948 by the City of Linden and Borough of Roselle under the “Sewerage Authorities Law” (N.J.S.A.40:14A-1 et seq.) It was established to contract and operate wastewater treatment and interceptor facilities to collect, treat and dispose of sewerage generated by the municipalities under a Municipal Agreement dated December 6, 1949 and as later amended.

The Authority operations are overseen by the six Members of the Board and day to day operations and administration are conducted by a staff headed by an Executive Director.

The Authority’s service area is 13 square miles and it services a residential population of 60,000. Approximately 25% of the influent sewerage flow is from industrial sources.

The Authority is governed by federal and state regulation. It operates its facilities and discharges treated wastewater to the Arthur Kill under permit No. 0024953 issued by the New Jersey Department of Environmental Protection (N.J.D.E.P). A portion of the effluent is permitted for beneficial reuse for cooling water for electric power generated at an adjacent power plant.

The Authority employs 46 people in four departments:

- Administration – Business
- Monitoring – Environmental Compliance
- Operations
- Maintenance

The Authority owns administration, monitoring/laboratory, treatment facilities and various auxiliary buildings at its primary site at 5005 South Wood Ave., Linden, NJ. It also owns a dock facility at the Arthur Kill, two pump stations, one metering chamber and pipelines outside of its treatment plant site.

The Authority’s sewerage treatment is classified as “Secondary Treatment” and is designed to treat 17 million gallons per day. It consists of Primary sedimentation, activated sludge, aeration, secondary clarifiers and ultraviolet disinfection for final effluent.

Residuals (sludge) treatment is by gravity thickening of primary sludge, gravity belt thickening (for waste activated sludge). Residuals are anaerobically digested and resulting methane gas is utilized for heat or flared (incinerated)

Residual sludge is concentrated with polymer. Final residuals are removed and disposed of off-site by a private contractor. The Authority’s 2021 operating budget is approximately \$10,000,000.

NATURE/SCOPE OF SERVICES

The Linden Roselle Sewerage Authority desires to appoint a Risk Management Consultant to assist the Authority in its membership in the New Jersey Utilities Authority Joint Insurance Fund (NJUA JIF). These services shall include but not be limited to the following:

- Assist the Authority in identifying its insurable property and casualty exposures and to recommend professional methods to reduce, assume or transfer the risk or loss.
- Assist the Authority in understanding the various coverages available from the NJUA JIF and the Municipal Excess Liability Joint Insurance Fund.
- Review with the Authority any additional coverages that the Risk Management Consultant feels should be carried but are not available from the NJUA JIF and with the approval of the Authority, place such coverage(s) outside the fund.
- Assist the Authority in the preparation of applications, statements of values, and similar documents requested by the NJUA JIF.
- Review Certificates of Insurance from contractors, vendors and professionals when requested by the Authority.
- Review construction and other contracts/specifications as requested by the Authority and comment on the insurance and hold harmless/indemnification requirements contained therein.
- Review the Authority's Assessment as prepared by the NJUA JIF and assist the Authority in the preparation of its annual insurance budget.
- Review the loss and engineering reports and generally assist the Safety Committee in its loss containment objectives. Also, attend no less than one (1) Authority Safety Committee meeting per year to promote the safety objectives of the Authority and the NJUA JIF.
- Assist when necessary, in the settlement of claims.
- Perform any other risk management related services that are required by the NJUA JIF bylaws.

SUBMISSION REQUIREMENTS OF TECHNICAL PROPOSAL

The Proposal submitted by the Respondent must meet or exceed the professional and administrative qualifications and requirements set forth in this RFQ to perform these services and shall incorporate the information requested below. In addition to the information required as described below, a Respondent may submit supplemental information that it feels may be useful in evaluating its proposal.

- A. Name of the proposer, the number of personnel in the firm, years in business, and the firm's location from which services to the Authority will be provided.
- B. Proposer must have a minimum of ten (10) years of experience in performing the services requested with a minimum of five (5) years' experience having served in that capacity for a

sewerage/municipal utility authority or similar government entities. A listing of other engagements where services of the types being proposed must be submitted. This should include other sewerage/municipal utility authorities and municipal governments. Contact information for the recipients of the similar services should be provided. The Authority may obtain references from any of the parties listed.

- C. Provide the education, qualifications, experience, credentials of the key staff who would be assigned to provide services along with their names and titles.
- D. Fee Proposal: Indicate what percent of the Authority's annual assessment as promulgated by the NJUA JIF will be taken as compensation in providing these services.
- E. A Statement that neither the firm nor any individuals assigned to this engagement are suspended, or otherwise prohibited from professional practice by any federal, state, or local agency.
- F. An EEO/Affirmative Action Statement (copy of form attached).
- G. A completed Non-Collusion Affidavit (copy of form attached).
- H. A statement that the proposer will comply with the General Terms and Conditions required by the Authority and enter into the Authority's standard Professional Services Contract.
- I. A copy of the proposer's Business Registration Certificate. (Proposer must possess and submit Certificate by contract award date. Submission with proposal is preferred).
- J. Statement of Corporate or Partnership Ownership (copy of form attached).
- K. Disclosure of Investment Activities in Iran (copy of form attached).

PROPOSAL EVALUATION

The Authority will select the most advantageous proposals based on all of the evaluation factors set forth at the end of this RFQ. The Authority will make the award that is in the best interest of the Authority.

Each proposal must satisfy the objectives and requirements detailed in this RFQ. The successful proposer shall be determined by an evaluation of the total content of the proposal submitted. The Authority reserves the right to reject any or all proposals, or to reject any proposals if the evidence submitted by, or investigation of such respondent fails to satisfy the Authority that the respondent is properly qualified to carry out the obligations of the RFQ and to complete the work contemplated therein. The Authority reserves the right to waive any minor informality in the RFQ.

The Authority shall not be obligated to explain the results of the evaluation process to any proposer.

The Authority may require proposers to demonstrate any services described in their proposal prior to award.

PROPOSAL LIMITATIONS

This RFQ is not intended to be an offer, order or contract and should not be regarded as such, nor shall any obligation or liability be imposed on the Authority by issuance of this RFQ.

USE OF INFORMATION

Any specifications, drawings, sketches, models, samples, data, computer programs, documentation, technical or business information and the like ("Information") furnished or disclosed by the Authority to the proposer in connection with this RFQ shall remain the property of the Authority. When in tangible form, all copies of such information shall be returned to the Authority upon request. Unless such information was previously known to the proposer, free of any obligation to keep it confidential, or has been or is subsequently made public by the Authority or a third party, it shall be held in confidence by the proposer, shall be used only for the purposes of this RFQ, and may not be used for other purposes except upon such terms and conditions as may be mutually agreed upon in writing.

GENERAL TERMS AND CONDITIONS

- A. In case of failure by the successful proposer, the Authority may procure the services from other sources, deduct the cost of the replacement from money due to the proposer under the contract and hold the proposer responsible for any excess cost occasioned thereby.
- B. The proposer shall maintain sufficient insurance to protect against all claims under Workmen's Compensation, General, Professional and Automobile Liability. Certificates of Insurance shall be provided when requested with the Authority named as additional insured.
- C. Each proposal must be signed by the person authorized to do so.
- D. Sealed proposals may be hand delivered or mailed consistent with the provisions of the legal notice to proposers. In the case of mailed proposals, the Authority assumes no responsibility for proposals received after the designated date and time and will return late proposals unopened. Proposals ***will not*** be accepted by facsimile or e-mail.
- E. No firm may be issued a contract unless it complies with the EEO/Affirmative Action requirements of P.L.1975 C.127 as identified in the documents attached hereto. The form shall be properly executed.
- F. By submission of the proposal, the proposer certifies that the service to be furnished will not infringe upon any valid patent, trademark or copyright and the successful proposer shall, at its expense, defend any and all actions or suits charging such infringement, and will save the Authority harmless in any case of any such infringement.
- G. No proposer shall influence, or attempt to influence, or cause to be influenced, any Authority Member or employee to use his/her official capacity in any manner which might tend to impair the objectivity or independence of judgment of said officer or employee.
- H. No proposer shall cause or influence, or attempt to cause or influence, any Authority Member or employee to use his/her official capacity to secure unwarranted privileges or advantages for the proposer or any other person.

- I. Should any difference arise between the contracting parties as to the meaning or intent of these instructions or specifications, the Authority's decision shall be final and conclusive.
- J. The Authority shall not be responsible for any expenditure of monies or other expenses incurred by the proposer in making its proposal.

During the performance of this contract, the contractor agrees as follows:

The contractor or subcontractor will send to each labor union, with which it has a collective bargaining agreement, a notice, to be provided by the agency contracting officer, advising the labor union of the contractor's commitments under this chapter and shall post copies of the notice in conspicuous places available to employees and applicants for employment.

The contractor or subcontractor, where applicable, agrees to comply with any regulations promulgated by the Treasurer pursuant to N.J.S.A. 10:5-31 et seq., as amended and supplemented from time to time and the Americans with Disabilities Act.

The contractor or subcontractor agrees to make good faith efforts to meet targeted county employment goals established in accordance with N.J.A.C. 17:275.2.

The contractor or subcontractor agrees to inform in writing its appropriate recruitment agencies including, but not limited to, employment agencies, placement bureaus, colleges, universities, and labor unions, that it does not discriminate on the basis of age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation, gender identity or expression, disability, nationality or sex, and that it will discontinue the use of any recruitment agency which engages in direct or indirect discriminatory practices.

The contractor or subcontractor agrees to revise any of its testing procedures, if necessary, to assure that all personnel testing conforms with the principles of jobrelated testing, as established by the statutes and court decisions of the State of New Jersey and as established by applicable Federal law and applicable Federal court decisions.

In conforming with the targeted employment goals, the contractor or subcontractor agrees to review all procedures relating to transfer, upgrading, downgrading and layoff to ensure that all such actions are taken without regard to age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation, gender identity or expression, disability, nationality or sex, consistent with the statutes and court decisions of the State of New Jersey, and applicable Federal law and applicable Federal court decisions.

The contractor shall submit to the public agency, after notification of award but prior to execution of a goods and services contract, one of the following three documents:

Letter of Federal Affirmative Action Plan Approval

Certificate of Employee Information Report

Employee Information Report Form AA302 (electronically provided by the Division and distributed to the public agency through the Division's website at www.state.nj.us/treasury/contract_compliance)

The contractor and its subcontractors shall furnish such reports or other documents to the Division of Public Contracts Equal Employment Opportunity Compliance as may be requested by the office from time to time in order to carry out the purposes of these regulations, and public agencies shall furnish such information as may be requested by the Division of Public Contracts Equal Employment Opportunity Compliance for conducting a compliance investigation pursuant to **Subchapter 10 of the Administrative Code at N.J.A.C. 17:27.**

The Contractor and the Owner do hereby agree that the provisions of Title 11 of the Americans With Disabilities Act of 1990 (the "Act") (42 U.S.C. §121 01 et seq.), which prohibits discrimination on the basis of disability by public entities in all services, programs, and activities provided or made available by public entities, and the rules and regulations promulgated pursuant there unto, are made a part of this contract. In providing any aid, benefit, or service on behalf of the owner pursuant to this contract, the contractor agrees that the performance shall be in strict compliance with the Act. In the event that the contractor, its agents, servants, employees, or subcontractors violate or are alleged to have violated the Act during the performance of this contract, the contractor shall defend the owner in any action or administrative proceeding commenced pursuant to this Act. The contractor shall indemnify, protect, and save harmless the owner, its agents, servants, and employees from and against any and all suits, claims, losses, demands, or damages, of whatever kind or nature arising out of or claimed to arise out of the alleged violation.
