 - **Minneapolis Redistricting Project**, Barry Clegg Chair of the Charter Commission and Redistricting Group: After each census the district boundaries for the City Council Wards and Park Districts are redetermined.  - **RCTF Update:**
 - Lolo Food: Olympic Cafe wants to close an hour later at 11:00 pm on the weeknights and 12:00 midnight on weekends. They were not able to answer questions about how many times police have been called to their business. Some residents are uncomfortable with this extension and feel there is already too much nighttime activity on that corridor.
 - MPRB Trail Connection, Andy Schilling: The trail connection between Ole Olson Park and the 26 Ave. lookout will be extended.
 - Northpoint Update, Sherrie Simpson: Northpoint is seeking a variance for its signage to raise it higher than code allows.
 - **Properties Committee:**
 - 1303 Golden Valley Road: Fence is repaired and chicken coop is complete
 - Rental Property: paid through September, no info on the water bill
 - **Blue Line Extension Committee Update:** NRRC participated in the Bus, Bike, Walk tour to see the two different paths as it relates to Broadway and Lowry. A presentation was given after the tour. The overall sentiment is that people feel like they need more information to put forth more ideas on what our community is looking for. Final deadline for engagement is coming up in December. The next Blue Line Committee meeting is Thursday October 28th.
 - **Safety Committee:** Mentors and mentees were connected for a Meet and Greet at SEIU Local 26. It was a great meeting! This is a historic program and involvement in it and excitement about it is unprecedented.
