DEPOSIT

The Seller reserves the right to void this transaction and refund the Deposit for any reason. If, through some tragic accident, the dog were to die or otherwise be seriously injured before it goes to its new home, the deposit will be returned to the Buyer OR, if the Buyer wishes, the Deposit will be applied to another dog, if one is available, or to a puppy from the next available litter.

PAYMENT METHOD
