GENERAL

- Credit me as the artist if you upload the work anywhere, tagging me directly or linking to one of my social medias is fine
- I reserve the right to decline any commission
- You cannot make drastic changes to the commission once I have started (e.g. Changing the character completely, adding extra characters, etc)

PAYMENTS

- Payments are made via Paypal using Invoices or Goods & Services
- Kofi is also accepted

REVISIONS

- Changes in pose or composition are only accepted in the sketch phase
- I will provide you with a rough layout sketch and then once approved I will provide you with a finished sketch
- Once I begin the linework I cannot make further changes unless they are colour related
- After the 3rd revision I will add additional fees for any further changes during the sketch phase
- I will provide you with the 1st flat colour pass, if your commission is shaded, for you to make any changes to the palette
- The final version of the work will be provided as a watermarked piece and once any final payments have been made you will receive a smaller watermarked version to post on your own social media and an unwatermarked version if it is for commercial branding use, profile picture, banner, etc

DEADLINES AND DELIVERY

- Turnover time depends on the commission and other factors, this is stated per type of commission on my website. I will inform you during the process if anything may cause any additional delay

- Rush fees will add an additional +50% of the base price, if you need the work earlier than my standard TAT for that type of piece please specify this when making your request
- I will provide the final files through email and email alone, this is to keep their original quality for you

USE & INTELLECTUAL PROPERTY RIGHTS

- My commissions as standard are for personal usage, if you wish to use them for commercial projects or means please discuss this with me upfront and explain fully how you intend to use the work
- Commercial Usage is priced and discussed on an individual piece by piece basis dependent on what it is for
- I have the rights to use the image for my own purposes such as in my portfolio, on my social media and to advertise my work to future clients. Private artworks can be requested but you must inform me of this upfront to make me aware
- Under no circumstances is any of my art to be used for: AI Training, NFT's, or other Crypto related activities. This includes but is not limited to: Sketches, Lineworks, Colour Passes, and Final Pieces
- As the artist, I am the copyright holder of the artwork while you as the client have the permission to use/repost the artwork with credit and claim the character as yours if it is an original character

REFUNDS

- I accept refunds anytime before I start the commission. Once I have specified work has started I cannot provide refunds unless I myself am unable to complete the commission, in which case if it is before the colour phase, you will receive 100% of the refund. If it is after the colour phase then you will receive 50% of the refund + the work I managed to create for you
- I will provide necessary refunds for work which I cannot finish due to health complications or other situations that may cause too long of a hiatus/wait for the final product for the client. I will provide any finished work to the client and work out the remainder to be refunded from there
- If the piece was completed up to an uncoloured linework stage before I needed to cancel the commission, I would provide a 50% refund if 100% was paid upfront, but no refund if only 50% was paid upfront as this would be adequate work for the half of the final price that was paid. Sketch + Linework is considered the first 50% of the work and the 2nd 50% of the work is the Colouring + Rendering + Final Touches to the piece
