- Commissions will be sent through E-mail in both .jpg/jpeg and .png file types. You, the Client, will receive both the full water-marked version, and the simple signed version.
- Upon finishing the commission an <u>invoice</u> will be sent.

By commissioning me - the Artist, you - the Client automatically agree to my Terms of Service and Rules.

If in any case you, the Client, are not comfortable or do not agree with my Terms of Service and do not want to follow my conditions, I will immediately refuse your commission request.

RULES

- **Commissions are for PERSONAL USE ONLY**. Artwork may be used for Profile Pictures/Banners. They are NOT to be used for profit. Commercial use is strictly PROHIBITED and I do NOT have any options for commercial commission.
- Reposting/Sharing the commission is fine only **WITH** crediting me.
- **I own all rights to my work**. I am allowed to post the commission (unless requested otherwise by you, the Client). I am allowed to include it in my portfolio. You may **not** claim my work as your own.
- <u>Feeding AI</u> (artificial intelligence) engines my work or using it for <u>NFT</u> purposes is **PROHIBITED**.
- It's **strictly PROHIBITED** to use my artwork for <u>reselling</u>, <u>promoting</u>, <u>advertising</u> <u>or for profits associated with block-chain related technology</u> including (but not limited to) non-fungible tokens (NFT), cryptocurrency, or future inventions in the respective field.
- I have every right to decline commissions. I have every right to refuse a commission for any reason.

- **Harassment or the attempt to bargain is not tolerated**. This includes (but is not limited to) inappropriate comments, aggressive behavior, and spam messages. These include messages on any of my social media platforms, E-mail etc. <u>I have every right to blacklist/block the harassers</u> and delete their messages.
- There are NO rush orders. I follow the line and queue as commissions are ordered.
- <u>Four [4] months is the</u> **maximum** window of time I allow myself to finish a commission. If I do **NOT** meet the deadline and overstep it I will refund 100% of the commission price.
- In case you, the Client, are <u>not replying/ghosting me</u>, the Artist, and it forces me to overstep the deadline, refunds will **NOT** be provided.
- I do NOT take text-based descriptions/ non-visual reference commissions. I need clear reference photos and a pose inspiration photo would be appreciated as well (though the pose could be provided in a descriptive format through text).
- **Do NOT provide me with pixel art** references, hence details can be lost in them.
- <u>I accept references made by the help of avatar-making websites/apps</u> (ex. Picrew, Monster Girl Maker, Doll Divine etc.), in this case, if **minor changes** for your own preferences are needed, a text-based description is acceptable.
- In the case of <u>commissioning a full-body art</u>, **provide me with full-body reference**(s) (not just half-body, or head-shots). I do **NOT** accept text-based descriptions in this case.

More than a single reference is well appreciated, the more the better, I would be thankful.

- You are **NOT allowed** to trace over my artwork, nor use it as a base.
- You are **NOT allowed** to modify, edit, change, redraw, use my work without permission.
- I can communicate and take commission in the following languages: <u>English</u>, <u>Hungarian</u>, <u>Romanian</u>.

WHAT I AM WILLING TO DRAW

I WILL DRAW

- Humans/people/original characters/fanart
- Monsters/creatures/fantasy characters

- Furry/anthropomorphic (to a certain extent, but feel free to ask)
- Mild Injury, mild gore and blood (no organs/guts/dismembering)
- Anatomical creatures (ex. Skeletons)

I WILL **NOT** DRAW

- Mecha/robots/cyborgs
- Complex armor (to a certain extent I'll happily accept it, just ask)
- Certain types of media/fanart (ask and I will let you know if it's acceptable from my point of view or not.)
- Vore/Hentai/NSFW (including fetishes even if portrayed SFW)
- Offensive/illegal media (racism, sexism, homophobia, transphobia, incest, pedophelia, xenophobia etc.)
- Vomiting, bodily fluids (exception: tears), major gore (organs, guts, dismemberment, heavy blood, gore-like portrayed broken limbs)

PAYMENT

- I only take payments through VGen. I do not accept any other way of payment (ex. any third-party apps, Paypal, NFTs etc.)
- **A minimum of 50% must be paid upfront** (<u>NON-REFUNDABLE</u>). After the sketch is done and you, the Client approve it, the remaining amount must be paid <u>fully</u>, and only after I will continue the commission.
 - <u>If you, the Client **cancel before I send the sketch**</u> I will give a partial refund (<u>I will keep 25%</u> of the full 100% of the price).
- After the sketching phase and its approval, **NO refunds** will be given from then on.
- If for any reason I cannot complete the commission due to personal situations coming up (the deadline rule is <u>not</u> applicable in this situation), I will refund back the price to a certain extent. (I will keep 25% of the full 100% of the price)
- I do NOT accept art-trading as payment for a commission.
- For any sort of **aggressive**, **rude or inappropriate behavior** I will personally cancel the commission but will keep the 50% upfront payment.
- **If payment is not made within 72 hours I will cancel** the commission and <u>no refunds</u> will be given.
- **My work will not be physically shipped** to you, the Client. It will be sent <u>digitally</u>, it is a "Digital Artwork". Afterwards, if you, the Client wish so, you can print my work for your **PERSONAL** USE.

PROCESS

- Your commission slot is only confirmed once you receive a reply/message from me.
- **I will send progress images** depending on the type of commission. The order for different types of commission:
 - 1. **Lineart**: sketch, lineart, black and white shading.
 - 2. **Colored**: sketch, line art, base colors, shading/lighting.
 - 3. <u>Colored (Gradient Map)</u>: sketch, line art, greyscale shaded base, colored grayscale (with the use of an overlay layer), Gradient Map options for the color of shadows and light.
- In case <u>I fail to message you for a longer period</u> of time, **you reserve the right to ask for updates** on your commission.
- At any step of the process (except the finished work), **three (3) changes/ revisions at maximum** at different times will be allowed in total for any of the steps listed above for the categories. After that I will refuse to change anything paying for more than three (3) revisions of these steps is <u>not</u> accepted.
- <u>Upon finishing</u> a final check will be asked of you, three (3) minor changes/ revisions at maximum are allowed. More than three (3) will cost 25% of the price for each change.
- Refunds for deadline overstepping are NOT applicable if it occurred due to too many change/revision requests.

USER AGREEMENT

By commissioning me you have read, understood and agreed to my Terms of Service.

You have agreed to the policy of not using my work for anything else but personal uses, with properly giving credit to me, the Artist.

Violators will be blacklisted and will be taken appropriate action against.
