II. Support to Construction Crew

- F. Assist with paperwork, such as updating maps, requisitioning inventory, vehicle inspection logs, etc.
- G. Interact with customers, when needed, in a professional manner
- H. Transport vehicles and equipment, adhering to all CDL requirements
- I. Assist with keeping construction sites and the yard clean and organized
- J. Perform all tasks while following all rules, processes, and procedures as outlined in the Construction Operations Manual
