INVITATION TO BID FOR PROCUREMENT OF RADIOLOGY SUPPLIES (EPA) IB No. 2023-027

1. The *Tondo Medical Center* through the *General Appropriation Act (GAA)* intends to apply the sum of **One Million One Hundred Eleven Thousand Four Hundred Ninety Pesos (Php 1,111,490.00)** being the ABC to payments under the contract for **Procurement of Various Gloves under IB No. 2023-027**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Tondo Medical Center* now invites bids for the above Procurement Project. Delivery of the Goods as specified on *Section VI*. Bidders should have completed, within *the last three (3) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary *“pass/fail”* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from the BAC Office of Tondo Medical Center and inspect the Bidding Documents at the address given below during *office hours*.
