

Privacy Policy

This Privacy Policy ("Policy") applies to MeetAmore and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include MeetAmore ("the Company"). The Company's application is a relationship and dating application. By using the Company application, you consent to the data practices described in this statement.

Collection of Personal Information

In order to provide you with products and services, the Company may collect personally identifiable information, such as:

First and last name

Email address

Location

If you purchase the Company's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction. The Company may also collect anonymous demographic information, such as:

Age

Gender

Sexual preference

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include:

Registering for an account

Entering a sweepstakes or contest sponsored by us or one of our partners

Signing up for special offers from selected third parties

Sending us an email message

Submitting your credit card or other payment information when ordering and purchasing products and services

We will use your information for communicating with you in relation to services and/or products you have requested from us. We may also gather additional personal or non-personal information in the future.

Use of Personal Information

The Company collects and uses your personal information to:

Operate and deliver the services you have requested

Provide you with information, products, or services that you request from us

Provide you with notices about your account

Carry out the Company's obligations and enforce our rights arising from any contracts entered between you and us, including for billing and collection

Notify you about changes to our MeetAmore or any products or services we offer or provide through it

Inform you of other products or services available from the Company and its affiliates

The Company may also use your personally identifiable information for other purposes with your consent.

Sharing Information with Third Parties

The Company does not sell, rent, or lease its customer lists to third parties. We may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to the Company, and they are required to maintain the confidentiality of your information.

The Company may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to:

Conform to the edicts of the law or comply with legal process served on the Company or the site

Protect and defend the rights or property of the Company

Act under exigent circumstances to protect the personal safety of users of the Company or the public

Security of Personal Information

The Company secures your personal information from unauthorized access, use, or disclosure. We strive to take appropriate security measures to protect against unauthorized access to or alteration of your personal information. However, no data transmission over the Internet or any wireless network can be guaranteed to be 100% secure. As a result, while we strive to protect your personal information, you acknowledge that there are security and privacy limitations inherent to the Internet that are beyond our control.

GDPR Compliance and Right to Deletion

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

Delete your personal information from our records

Direct any service providers to delete your personal information from their records

Please note that we may not be able to comply with requests to delete your personal information if it is necessary to:

Complete the transaction for which the personal information was collected

Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity

Debug to identify and repair errors that impair existing intended functionality

Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law
Comply with legal obligations
Children Under Eighteen

The Company does not knowingly collect personally identifiable information from children under the age of 18. If you are under the age of 18, you must ask your parent or guardian for permission to use this application.

External Data Storage Sites

We may store your data on servers provided by third-party hosting vendors with whom we have contracted.

Changes to This Statement

The Company reserves the right to change this Policy from time to time to reflect changes in our services, data protection practices, or changes in the law. When changes to this Policy are significant, we will inform you through prominent notice on our MeetAmore application and/or by updating any privacy information. Your continued use of the application and/or services available after such modifications will constitute your acknowledgment and agreement to abide by the modified Policy.
