

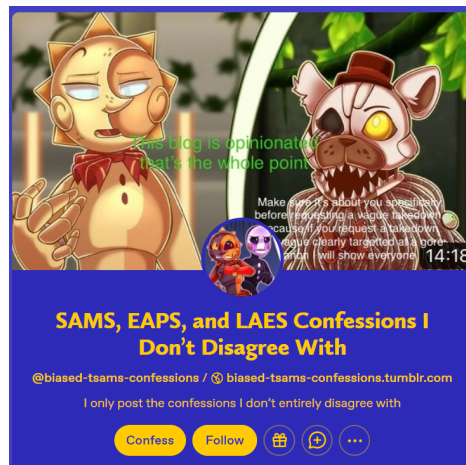
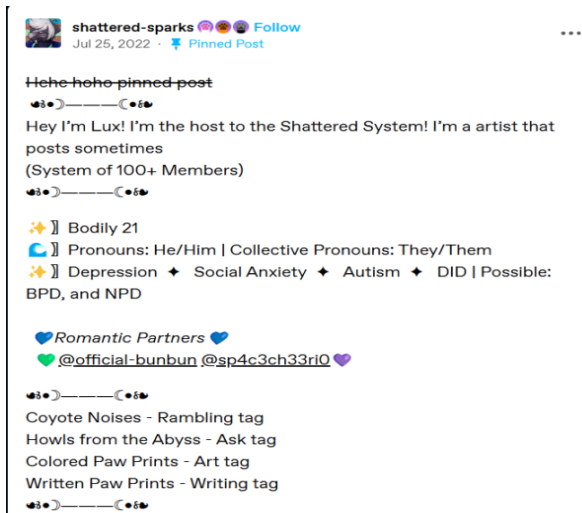
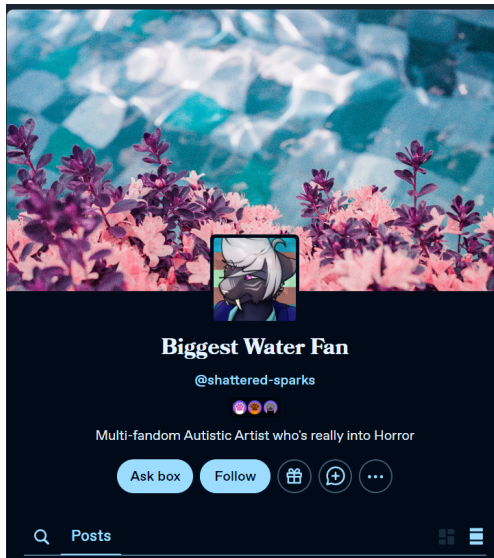
Introduction

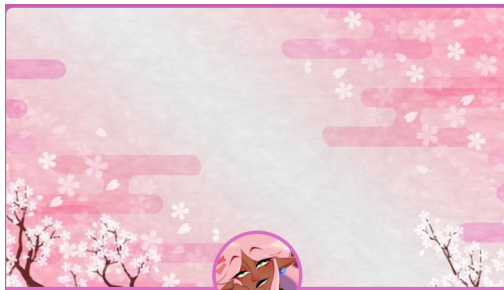

The purpose of this exposé is not to incite hostility but to provide clarity on the issues at hand. It's essential that the fandom remains a safe and respectful space for everyone, and addressing harmful behavior is a crucial part of maintaining that environment.

Background Information

Lux, known online as @Shattered-Sparks and SynthCoyote, has been a notable presence in the TSAMS (The Sun and Moon Show) fandom for their contributions as an artist. They have been closely involved in the fandom, particularly through friendships with several minors. Lux gained further recognition by assisting in the development of the TSAMS wiki under the name SynthCoyote, contributing to cataloging avatars and worlds. Their relationship with the moderator of the TSAMS-Confessions blog has added complexity to their community involvement. Despite their contributions, they have been at the center of multiple controversies, including allegations of harassment and seeking clout from their interactions with others. Notably, several individuals within the community have raised concerns about their behavior, which has led to increased scrutiny of their actions.

The primary concern in this document is Lux's longstanding pattern of behavior involving harm towards individuals significantly younger than him. This behavior has persisted over several years, impacting multiple victims.

Lux has exhibited a consistent pattern of behavior aimed at individuals younger than him. This includes emotional manipulation, coercion, and inappropriate interactions that have resulted in psychological and emotional distress for the victims.

The impact of Lux's behavior on younger community members has been significant. Victims have reported feelings of isolation, distress, and trauma as a result of their interactions with Lux. This has contributed to a toxic environment and has discouraged younger members from participating in the community.

Despite being made aware of the harm caused, Lux has failed to take responsibility or make meaningful changes to his behavior. This lack of accountability has allowed the harmful behavior to continue and has further damaged trust within the community.

Lux's continued negative behavior, coupled with a lack of consequences, has allowed him to target and attack other community members. This unchecked behavior has led to efforts to damage the reputations of those who speak out or are seen as a threat to his actions.

Lux has used his position and lack of accountability to launch attacks against other members, particularly those who have challenged or criticized him. This behavior includes spreading false accusations and engaging in character assassination.

By attacking the reputations of other members, Lux has contributed to the spread of misinformation within the community. This has resulted in false perceptions and has unfairly damaged the reputations of those affected, leading to mistrust and division.

The lack of consequences for Lux's behavior has eroded trust within the community. Members are now wary of speaking out against injustices or engaging with others due to fear of retaliation or being unjustly targeted.

The unchecked negative behavior of Lux has led to significant harm within the community. The targeting and damaging of other members' reputations, along with the spread of misinformation, have contributed to a toxic environment. This has weakened community cohesion and trust, making it harder for members to feel safe and supported.

Despite multiple attempts to address Lux's harmful behavior, he has consistently dismissed concerns and reacted with public outbursts. Efforts to discuss the issue with his associates have often been met with defensiveness, which is particularly concerning when those defending him include groups of minors.

Whenever concerns about his behavior are raised, Lux typically responds by dismissing the issues and reacting with public tantrums. This response not only fails to address the concerns but also shifts focus away from the issues at hand.

When concerns are brought up with individuals or groups connected to Lux, they often respond defensively. This defensiveness has included downplaying the issues, deflecting blame, or outright dismissing the concerns raised by others.

The most troubling aspect of the defensive reactions is when they come from groups of minors who are particularly vulnerable. These defenses often come from a lack of understanding or manipulation, exacerbating the difficulties in addressing Lux's behavior and protecting affected individuals.

The repeated attempts to address Lux's behavior have been met with dismissive and defensive reactions, including public outbursts and protective stances from his associates, particularly minors. These responses have hindered efforts to resolve the issues and have further perpetuated a harmful environment within the community.

A troubling development is Lux's practice of deleting direct messages (DMs) from his victims. This action is concerning as it prevents victims from providing proof of the harmful interactions they have experienced. By removing these messages, Lux effectively erases evidence of his misconduct, complicating efforts to hold him accountable.

The deletion of DMs not only obstructs victims' ability to present evidence but also undermines the integrity of the reporting and investigative processes. This behavior contributes to a lack of transparency and accountability, making it difficult for the community to address and resolve the issues effectively.

This behavior is concerning because it reflects a deliberate attempt to evade accountability and manipulate the perception of his actions. By deleting messages, Lux not only obstructs accountability but also exacerbates the distress and frustration of his victims, who are left without recourse to prove their experiences.

Victim Testimonies

These Testimonies are Shared in the Order that Conversation Took Place

Important Context:

- Y/N was nine when they met Lux and when the majority of the abuse occurred for them, they stayed in contact with Lux for several years, and are still in contact with some of Lux's old friends
- Jade was 14 when Lux abused them
- Phobia was 16 when Lux dated them
- 2D was 17 when he met Lux
- The term "we" will most often pertain to the writers of the document
- We discussed both Lux's past behaviors as well as recent behavior that shows he has not grown or matured as a person

Y/N described their experiences with Lux from 2016 to 2018. Initially, their interactions seemed normal, but Lux's behavior became problematic when they began "dating". Lux made inappropriate comments and suggestions that were clearly unsuitable.

As their relationship progressed, Lux's behavior worsened, including making sexual suggestions about Y/N's pet and issuing threats when Y/N did not respond to messages. Lux also accused Y/N of inappropriate behavior and used derogatory language, causing significant emotional distress.

Y/N mentioned that their early online activity was due to unrestricted access provided by their grandparents, which they now view as a concern. They recall multiple threats from Lux.

Jade shared details about Lux's behavior, confirming that Lux had sent various forms of explicit content. This included NSFW fan fiction, artwork, and an instance where Lux showed his body on camera inappropriately. These actions align with the troubling behaviors reported in other contexts.

Regarding Lux's interest in gore, Jade indicated that Lux's fascination seems to be more related to horror movies, such as those in the "Saw" series, rather than explicit gore content. However, there are concerns about recent allegations

involving Lux and minors in the fandom. Some minors have claimed they received disturbing content, which raises concerns about Lux's role in these incidents.

Jade expressed worry that Lux might be using such content to manipulate and control his friend group, particularly through guilt-tripping and emotional manipulation. This aligns with observations of Lux's manipulative behavior and reinforces concerns about his influence over vulnerable members of the community.

Jade reported that Lux's partners learned about the problematic behavior through Lux himself, who portrayed himself as a victim. The partners' reaction to Jade and 2D's relationship was notably more negative compared to their response to Lux's actions, which has raised concerns about inconsistent community reactions.

Jade confirmed they felt pressured by Lux regarding their relationship with 2D and is currently looking for evidence of this pressure. The conversation also touched on the broader community's response to relationships involving minors, indicating a perceived imbalance in how different situations are addressed.

Jade shared their experience of being pressured by Lux to pursue a romantic relationship with 2D. Lux's influence was significant, as he manipulated the situation to encourage this relationship despite Jade's personal reservations. Jade recounted that Lux's actions included coercion and pressure, which played a role in the initiation of the relationship between Jade and 2D.

Lux's involvement in pushing Jade and 2D into their relationship highlights his tendency to interfere in personal matters and manipulate situations to his advantage. Jade's testimony underscores the extent to which Lux's behavior extended beyond typical social interactions, reflecting a pattern of exerting control over others' relationships and decisions.

Jade (Jade) discussed the reactions and defenses from the fandom regarding the document about Lux. Jade expressed concern over whether the fandom's response was aggressive, acknowledging recent tensions and negativity within the community. We clarified that the backlash primarily involved defending Shattered Sparks, with critics arguing that the document was more focused on 2D rather than Lux.

The discussion also touched on accusations that the document was created to villainize individuals rather than address specific issues. Jade noted that some people in the fandom believed the document aimed to discredit certain individuals unjustly. We responded by indicating that the document's content spoke for itself, and the community's reactions often seemed to amplify misunderstandings rather than clarify the issues at hand.

We addressed the term "pedophilic" used in discussions about Lux. We expressed concern that labeling Lux as pedophilic might be misleading, emphasizing the importance of using precise terminology when discussing such sensitive issues. We requested that the term "pedophilic" be reserved for cases where there is concrete evidence of grooming minors under the age of thirteen by someone over the age of sixteen.

The discussion reveals that Lux's ex, Cami, was significantly younger than Lux. Cami was known before they reached their teenage years and was around 13 years old when the last contact occurred. It is noted that Lux used Cami's age and the dynamics of their relationship in ways that affected others. This context helps to understand Lux's behavior patterns and their impact on various individuals within their circle.

Lux used Cami as an excuse to justify their relationship with Phobia. This included using Cami as a means to rationalize or deflect attention from Lux's interactions with Phobia, highlighting Lux's patterns of manipulation.

Participants clarified that Lux had relationships with individuals younger than him, confirming a pattern of behavior where Lux was older than his partners. One point of clarification was that Lux was 20 when he was involved with 2D who was 17 at the time. Lux pressured 2D into dating Jade when 2D was 17, shortly before Jade turned 14. The relationship ended shortly after 2D turned 18.

Y/N provided insight into their experiences with Lux, which began around late 2022. Y/N initially created videos to express their frustration and document their encounters with Lux, particularly after Lux's harmful actions became apparent. These videos were a way to vent and share their experiences with a close friend, who was also a victim of Lux's manipulative behavior. This friend had been subjected to emotional distress when Lux denied their medical condition and

falsely claimed that their doctors had misled them, which could have had serious consequences for their health.

2D described how Lux used Cami, a previous partner, as a justification for their actions with Phobia. This suggests that Lux was using Cami's past relationship to manipulate the situation to their advantage, rather than addressing the issues at hand. The manipulation extended to personal relationships, where Lux's actions seemed to be driven by self-interest and a need to control the narrative around their own behavior.

The interactions between Lux and 2D began around late 2022, with significant events unfolding in early 2023. This period was marked by Lux's continued manipulative actions and efforts to influence 2D and others. Key incidents, including gaslighting and attempts to undermine the credibility of 2D and others, occurred around November 3, 2023. These interactions are indicative of a pattern of behavior where Lux's actions were designed to maintain control and manipulate those around them.

2D revealed that Lux's influence extended beyond personal relationships to impact their understanding of their own gender identity. This manipulation led to confusion and distress regarding their gender identity.

2D met Lux through Phobia around mid-2022. Their relationship began with a mix of positive and negative interactions, fluctuating between being agreeable and contentious. Lux's behavior progressively became more intrusive and manipulative. He actively encouraged sexual behavior in general, including toward 2D, creating a challenging and uncomfortable dynamic.

2D decided to end their relationship with Lux following a significant argument. This argument highlighted Lux's lack of consideration and care, particularly as Lux became involved with other partners. This incident was a catalyst for 2D to reevaluate the relationship and ultimately choose to cut ties.

In the case of Dust, 2D had been contemplating ending the relationship for several months before they actually did. The delay was largely due to fear of causing emotional harm to Dust, even though 2D recognized the need to end the relationship.

The emotional impact of Lux's actions was significant for 2D, leading to periods of severe emotional distress and exacerbating existing anger issues. Lingering effects included deep-seated trust issues, affecting 2D's ability to form and maintain healthy relationships in the future. 2D did not seek professional help during the relationship, as previous attempts at therapy had been unhelpful. However, they did pursue professional consultation after the relationship ended, indicating a recognition of the need for support and healing.

2D expressed feelings of fault regarding their involvement with Dust. They felt responsible for agreeing to the relationship despite feeling pressured. This sense of guilt persists, reflecting ongoing self-blame and the emotional burden of the experiences with both Lux and Dust. 2D feels responsible because, despite recognizing that their actions were problematic, they did not act on these realizations due to Lux's influence. They acknowledge that their judgment was affected, which hindered their ability to address the situation effectively.

2D accepts responsibility for their actions and agrees that they should be held accountable. They recognize their own mistakes but also understand that the situation was influenced by external factors beyond their control. 2D has made efforts to apologize and take responsibility for their behavior. They have expressed regret and acknowledged their mistakes, showing a commitment to making amends and improving the situation with those affected.

2D believes they were in the wrong due to acting on feelings that they now view as inappropriate. They were in a vulnerable state and saw the relationship as a way to improve their situation and support others, but recognized that their actions were not appropriate given the circumstances.

Lux often requested sexual relief from 2D during their relationship with Dust. These interactions included flirtation and, at times, engaging in phone sex. This behavior occurred both before and after 2D turned 18. 2D views Lux's behavior as emotionally and, at times, sexually grooming. They recognize that Lux's actions had an impact on them beyond just encouragement to date and be sexual with Dust.

After Lux was out of the picture, the relationships among the group members improved significantly. They focused on supporting each other through their respective healing processes. This involved listening to one another, providing

emotional support, and engaging in shared activities such as gaming. This supportive dynamic was a stark contrast to Lux's approach, which often lacked genuine empathy and led to negative outcomes in past relationships. The group's interactions reflected a healthy, supportive friendship, which was notably different from Lux's more manipulative and damaging behavior.

We highlighted various issues surrounding Lux's actions and the dynamics within fandoms. Lux has been criticized for making problematic comparisons and accusations regarding fandom content, particularly concerning fictional elements like incest. His arguments have been dismissed as lacking understanding of both the nature of fandom headcanons and the distinction between fictional content and real-life ethics.

Lux's behavior includes making exaggerated claims and targeting individuals with misleading accusations. This has led to confusion and frustration among fandom members. The community's response emphasizes a focus on maintaining respect for diverse interpretations while ensuring accurate representation and discussion of canon versus fan-created content.

Lux's recent actions have involved targeting and harassing individuals based on disagreements over fictional content and personal headcanons. After discovering that a group of fans were shipping something he didn't agree with, Lux orchestrated a social ambush, blowing the situation out of proportion and engaging in prolonged harassment.

The situation escalated to the point where VAs and their mods intervened on the group's behalf. This intervention led to significant backlash against Lux, who has continued to complain about the exposure and subsequent fallout. Screenshots and evidence of Lux's behavior have been collected to support the claims against him.

Lux's tactics have involved guilt-tripping and manipulating emotional responses, including attempts to exploit past trauma. His accusations include false claims about grooming and inappropriate behavior, which have been disproven with evidence. He has also asserted that these individuals have made false claims or engaged in harmful behavior, which has been rebutted with supporting evidence and context.

Phobia shared their experience of being under Lux's control, describing themselves as having been a "very dumb, unstable, and stupidly obedient kid." They acknowledged feeling guilty for past actions and have continued to apologize to Jade and 2D. Phobia mentioned experiencing what they believe to be dissociative identity disorder (DID) but have not been formally diagnosed. They have alters named Shadow and Bob, with Shadow being present since 5th grade and Bob joining after Phobia left their group with Jade and 2D in December 2022. Other alters from before this period have become dormant.

Phobia recounted Lux's delusional behavior, including being convinced that Lux was in a relationship with the Sun and Moon animatronics and using this to compare Phobia unfavorably. Lux's comparisons and behavior caused Phobia significant trauma, leading to a strong aversion to the Sun and Moon characters. Lux also used medical terms inappropriately to insult Phobia, including calling them "schizo" and dismissing their DID as attention-seeking. Phobia described Lux's behavior as involving witch-hunting and manipulation, including trying to force Phobia and others to roleplay as Sun and Moon without proper instructions, and then becoming angry when their expectations were not met.

We reported that Lux deleted a post that had been reviewed, which was perceived as a manipulative act. Phobia shared a similar experience, noting that after Lux attempted to reach out earlier in the year, Phobia sent a detailed message expressing their feelings. Lux responded by making a post that mocked and ridiculed Phobia, although that post has since been removed.

We raised concerns about ongoing misinformation, particularly about the identity of an "adult" partner Lux and his supporters are wrongly blaming for their issues. Phobia clarified that they did not date anyone after Lux and are still single, which aligns with Jade's confirmation that the partner in question was actually Jade and 2D, both of whom were minors during the relevant period.

There is frustration about how Lux and his supporters are either dismissing Phobia's experiences or shifting blame. We criticized the focus on Jade and 2D while ignoring Phobia's involvement and Lux's continuous posts, including recent ones featuring TSAMS art.

Phobia expressed feelings of being sidelined or erased from the narrative, suspecting that either Lux's supporters are deliberately excluding them or are

avoiding discussing them due to previous requests to keep their name out of the conversation. Jade and Phobia discussed how Lux has a history of disregarding others' feelings and making inappropriate jokes about personal issues. They also addressed Lux's manipulation, using Phobia to get over his ex and the issues arising from it.

Jade asked Phobia to contact a real-world friend of Lux's to confirm that they had repeatedly told Lux that his actions were inappropriate. The real-world friend confirmed they had informed Lux several times that his behavior was wrong, although Lux eventually claimed he had only recently realized it was an issue. We expressed skepticism about Lux's claims, believing that Lux was aware of the wrongfulness of his actions all along. Phobia and We agreed that Lux likely deceived their friend, who may have been misled due to their personal connection with Lux.

Jade inquired about the possibility of achieving justice and eliminating Lux's influence and lies. We responded, expressing commitment to the cause and outlining their current challenges, including illness and packing. Jade expressed gratitude for Our efforts.

Jade shared that Lux had previously used emotional manipulation, causing significant pain by disowning him as a "brother" during moments of anger. This was particularly hurtful due to the deep connection Jade felt with him. Jade expressed ongoing hurt from this experience.

Phobia revealed a traumatic incident from December 2022, where seeing Lux's profile pic caused a panic attack at school, leading to their decision to leave the group for the time being. They described the physical and emotional impact of that moment and the difficulty of hiding their distress in class.

We asked for updates on gathering evidence for the document. Jade confirmed that Lux's direct messages were being considered for recording to ensure comprehensive evidence. There was a concern that Lux might be planning to post something, which was confirmed when We noted that Lux had turned asks back on.

It was later revealed that Lux had deleted all messages from his side, including potentially relevant evidence. We instructed them to take screenshots of the

entire dashboard, including Lux's profile and name, to document the situation comprehensively.

(If it is any reassurance even the doc makers have said that I stopped)

So yeah, I accidently groomed a minor. I know I did, I've known for a while now. But if you're willing to hear me out I have some things to say regarding this.

I know who Y/N is. It's not hard to figure out given how the doc was written out. Y/N is 2D/Dreadmust. Jade and 2D are the ex friends that I have been vague posting about.

(Update, to respect the wishes of Y/N I want to correct that 2D isn't Y/N. But Y/N has come out to say that they no longer stand by the doc)

I know the main question is going to be why did I do the things I did. Well there's a few reasons actually.

1. I was groomed myself in the past. Sexual content normalized and that it was okay for Minors to be around and see such things.
2. Jade presented their discomfort of sexual things as a trigger, and I wanted to help them. I didn't want them to suffer with a trigger and the only way I knew how to deal with Triggers at the time was to face them head on.

This wasn't any way shape or form okay but no one was there to stop me. No one was there to tell me otherwise. So with 2D another adult in the situation enabling it as I was enabling them it was a growing problem that only recently been dealt with.

(I want it noted that I didn't know the full definition of grooming when I did and say those things in the google doc)

Reader I want to bring up something here. The whole reason why the doc was even created in the first place.

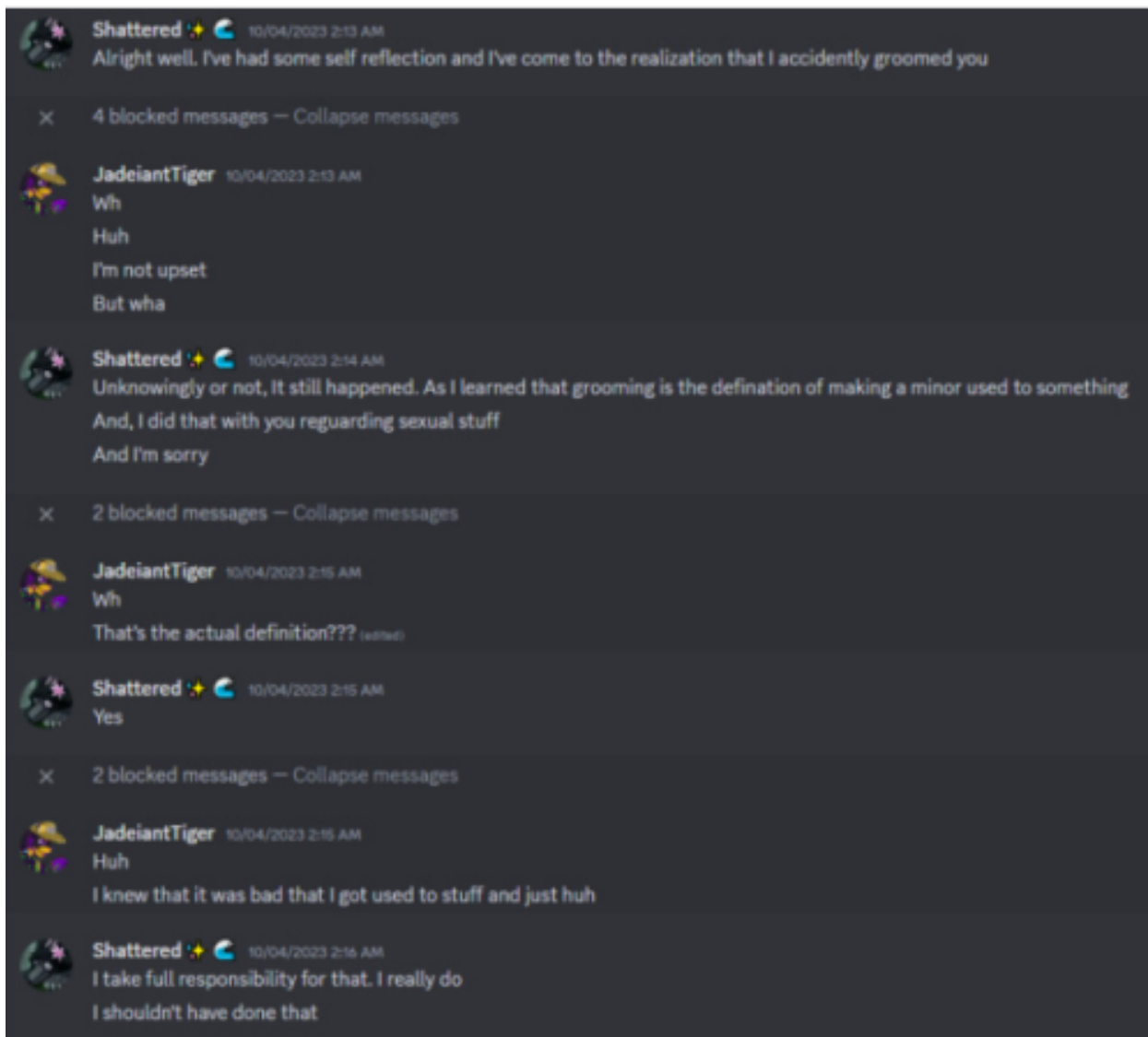
!DISCLAIMER!! This doc is created for the sole purpose of proving we are not the ones to blame, rather than the ones just trying to speak up about certain things this user has been doing.

This google doc wasn't created for the safety of others. Wasn't created to warn others of my actions, rather to try and gain a advantage over petty personal drama.

If they truly felt like I was a pedophile and a groomer they would've made the doc out of protection of others, not for the reasons they have given.

A few mislanious thoughts of mine given as I am writing this I am having a trauma response as I have a history of online harassment via making big claims like these.

1. This whole situation happened because I stopped accidentally grooming Jade. They only knew that I was because I was the one who told them.



2. The doc was created because the two couldn't handle knowing that I wasn't the one causing the several arguments that led up to us 3 no longer being friends.

3. I did everything I could do make sure Jade wasn't apart of or could see anything regarding the sexual Au

4. I'm not the only adult at fault in this situation as Jade and 2D dated for months on end. Doing sexual things together without my input. I also want it to be know that they only started dating as both had gained crushes on one another.

5. for me being so hypocritical you two sure wanted to make sure 2D being a pedophile himself wasn't made public.

My last thoughts is if anyone has any questions I'll gladly answer. But as for Jade and 2D. You don't want me to better myself. You don't want to be my friend again. You just wanted to be petty and make something personal that has already been dealt with a fixed public to try and prove a point. Fuck off.

Y/N's Response:

Basically, I was on call with Lux after the doc was released (because he went to me of all ppl for comfort bc his partners weren't online)

And he was reading the document, mind you I was trying not to Tic the entire time bc I was anxious. (For those who don't know, I have Tourettes Syndrome, Tourettes is also recognized as a neurological condition and disability involving involuntary movements and sounds known as "tics". We cannot control our tics, and suppressing them makes them worse! I'm bringing this up for future reference.)

When Lux got to my section, aka "Y/N's section", he automatically assumed I was 2D and therefore accused 2D of writing the things I wrote. I was confused, because I thought it was obvious it wasn't him who wrote it, much less go under the alias "Y/N". (But either way, it only made me tic more due to anxiety.)

However, when Lux realized it was me, he used my anxiety (and most likely my Tourettes) as "context cues".

I also want to re-mention that afterward, both Lux and "Moondrop" gaslit and yelled at me until I deleted my end of the document. Saying "I could only fix things if I deleted/took the document down". Eventually they cut me off and treated me as a villain. Which of course led to me having a mental breakdown and a trauma response. (He and "Moon" reminded me of a terrible person I knew for most of my life, so seeing them act like that genuinely set me off)

Jade's Response:

I never responded to his response then but now I'm reading it all of it is him victimizing himself

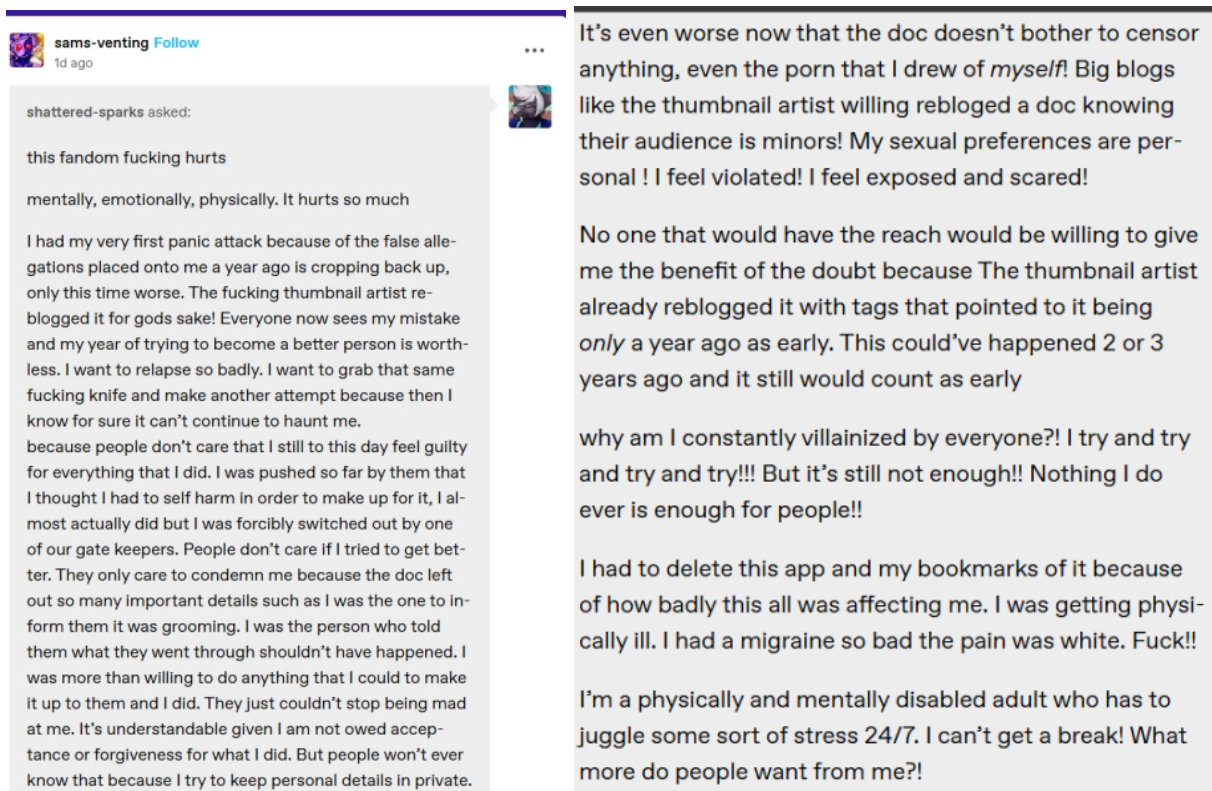

 - *Again, as explained before, I was 17 durin' that time, and mind you, after turnin' 18, I decided to break it off after a few months of thinkin'.*

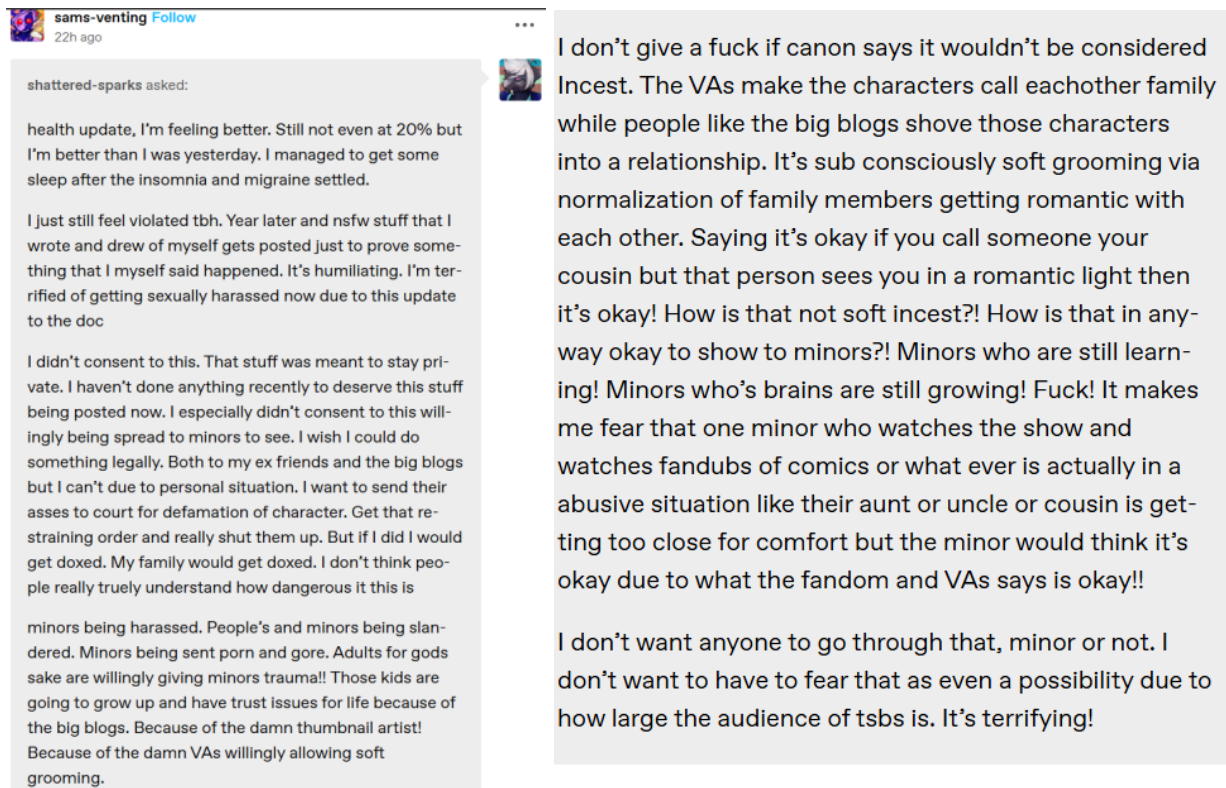
- "5. For me being so hypocritical you two sure wanted to make sure Dread being a pedophile himself wasn't made public."

After all, they literally caused two people to contemplate killing themselves and another (who is a verifiable minor) to nearly self harm. Plus, they falsely put people on their document as harassing when either they've had barely any interactions and were stating the obvious (cult anon calling out how witchy was poorly handling August 5) or just re-blogging posts from the victims to show their support.



Lux reblogged posts from minors that were defending his actions. The original poster is reportedly one of Lux's close friends, and it is public knowledge that they have group gaming sessions with Lux, Mod1Blood and other minors.

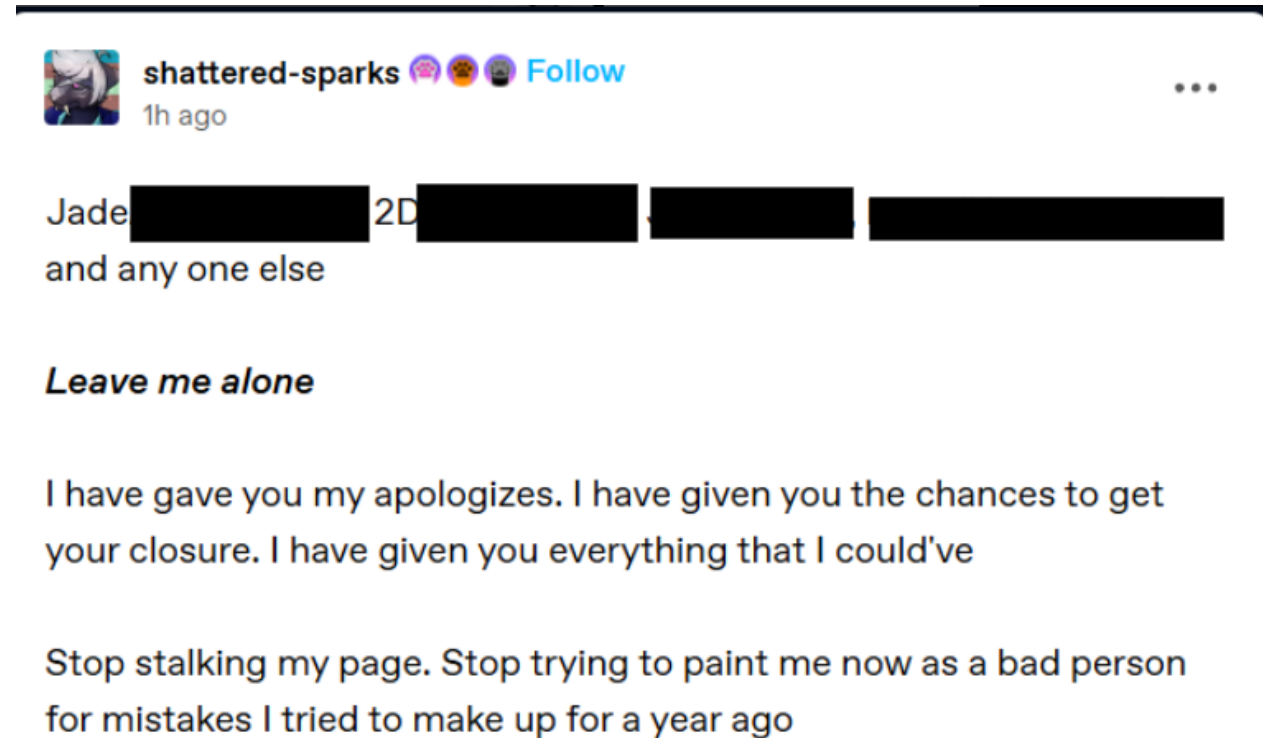

It's also been reported by the victims that he never tried to make up for what he did to them, and on the contrary, continued to hurt and manipulate them until they all left of their own free will.

Jade expressed intense anger, accusing Lux of lying, screaming at, and trying to guilt-trip them, particularly stating that Lux only became suicidal after they left. Jade is furious, stating they are "sick of his behavior". We personally just wanted to point out the irony of Lux's partner Mod1Blood posting this when Lux and his friends are defending them because Lux has made claims of being abused himself which in his words made him hurt others even after he was well into being an adult:
