## Part 1—Preliminary

#### 1 Short title

This Act may be cited as the *Northern Australia Infrastructure* Facility (Boosting Funding) Amendment Act 2021

#### 2 Commencement

(1) Each provision of this Act specified in column 1 of the table commences, or is taken to have commenced, in accordance with column 2 of the table. Any other statement in column 2 has effect according to its terms.

## 6 Amendment to Section 41

- (1) Replace the wording of Section 41 of the Principal Act to read as follows;
- (a) The Consolidated Revenue Fund is appropriated to the extent of \$10 billion for the purposes of providing financial assistance to the States and Territories and other entities for the development of Northern Australia economic infrastructure.
